Two hundred soldiers from the 17th Field Artillery Brigade based out of Fort Lewis, Washington are deployed in Washington state.

Four MAFFS C-130 Airtankers are assigned to McClellan Airfield in Sacramento, California and two MAFFS C-130 Airtankers are assigned to Channel Islands, California in support of wildland fire operations.

Five wildland fire suppression crews and one CL-415 scooper group from Ontario, Canada and one Convair 580 airtanker group from both Saskatchewan and Alberta are supporting fire suppression efforts in the Northern Rockies Area.

Area Command Team (Walker) is assigned to the Colville National Forest for large fire support.

Okanogan Complex (5 fires), Northeast Region, DNR. Transfer of command from IMT 1 (Pechota) and IMT 2 (Rabe) to IMT 1 (Minton) will occur tomorrow. Eleven miles northwest of Omak, WA. Timber. Active fire behavior with group torching and spotting. Numerous structures threatened. Evacuations, road and trail closures in effect.

North Star, Colville Agency, BIA. IMT 1 (Lewis) and IMT 2 (Nieto). Twenty-four miles east of Omak, WA. Timber and light logging slash. Extreme fire behavior with torching, flanking and backing. Numerous structures threatened. Evacuations, road and area closures in effect.

Chelan Complex (5 fires), Southeast Region, DNR. IMT 1 (Templin). IMT is also managing the Wolverine and First Creek fires. Started on BLM land one mile south of Chelan, WA. Timber, closed timber litter and short grass. Extreme fire behavior with uphill runs, crowning and torching. Numerous structures threatened. Road and area closures in effect.

Wolverine, Okanogan-Wenatchee NF. Three miles northwest of Lucerne, WA. Timber, brush and short grass. Extreme fire behavior with uphill runs, long-range spotting and group torching. Numerous structures threatened. Road, area and trail closures in effect.

First Creek, Okanogan-Wenatchee NF. Eight miles northwest of Chelan, WA. Timber and short grass. Extreme fire behavior with group torching, uphill runs and short-range spotting. Numerous structures threatened. Road closures in effect.

Kettle Complex (3 fires), Colville NF. Transfer of command from IMT 2 (Ciraulo) to IMT 1 (Schulte) will occur today. Fifteen miles northeast of Republic, WA. Timber, dormant brush and hardwood slash. Active fire behavior with group torching, spotting and creeping. Numerous structures threatened. Road, area and trail closures in effect.

Canyon Creek Complex (3 fires), Malheur NF. IMT 1 (Lund). Two miles south of John Day, OR. Timber, medium logging slash and short grass. Active fire behavior with group torching, flanking and backing. Structures threatened. Road, area and trail closures in effect.

Carpenter Road, Northeast Region, DNR. IMT 2 (Esperance). Five miles south of Fruitland, WA. Timber. Active fire behavior. Numerous structures threatened. Evacuations, road and area closures in effect.

Grizzly Bear Complex (8 fires), Umatilla NF. IMT 2 (Gales). Twenty miles southeast of Dayton, WA. Timber and short grass. Active fire behavior with uphill runs, group torching and short-range spotting. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

Kaniksu Complex (3 fires), Colville NF. IMT 2 (Tom Kurth). Ten miles northeast of Usk, WA. Timber and logging slash. Active fire behavior with uphill runs and torching. Numerous structures threatened. Road, area and trail closures in effect.

Upper Skagit Complex (4 fires), North Cascades NP. IMT 2 (Wilcox). Thirteen miles north of Marblemount, WA. Timber. Moderate fire behavior with isolated torching, flanking and backing. Numerous structures threatened. Evacuations, road and trail closures in effect.

Eagle, Wallowa-Whitman NF. IMT 2 (Greer). Twenty miles northwest of Richland, OR. Timber and medium logging slash. Active fire behavior with group torching, running and long-range spotting. Structures threatened. Evacuations, road, area and trail closures in effect.

Colville Complex (3 fires), Northeast Region, DNR. IMT 2 (Fillis). Ten miles northeast of Kettle Falls, WA. Timber and brush. Active fire behavior with isolated torching and creeping. Numerous structures threatened. Road, area and trail closures in effect.

County Line 2, Warm Springs Agency, BIA. IMT 2 (Sheldon). Six miles northwest of Warm Springs, WA. Timber. Extreme fire behavior with crowning, running and long-range spotting. Numerous structures threatened. Area and trail closures in effect.

National Creek Complex (2 fires), Rogue River-Siskiyou NF. IMT 2 (Goff). Eleven miles southwest of Diamond Lake, OR. Timber. Active fire behavior with short crown runs and group torching. Numerous structures threatened. Road, area and trail closures in effect.

Cougar Creek, Yakama Agency, BIA. IMT 2 (Leitch). Six miles northwest of Glenwood, WA. Timber, medium logging slash and tall grass. Active fire behavior with crowning, short-range spotting and flanking. Structures threatened. Road, area and trail closures in effect.

Stouts Creek, South Unit, ODF. Transfer of command from ODF IMT 1 (Cline) back to the local unit will occur today. Sixteen miles east of Canyonville, OR. Timber. No new information.

Collier Butte, Rogue River-Siskiyou NF. Transfer of command from IMT 2 (Johnson) back to the local unit will occur today. Eighteen miles east of Gold Beach, OR. Timber and brush. Moderate fire behavior with flanking, short-range spotting and backing. Structures threatened. Road, area and trail closures in effect.

Eldorado, Vale District, BLM. Transfer of command from ODF IMT 1 (Smith) back to the local unit will occur today. IMT is also managing the Cornet-Windy Ridge fire. Started on private land five miles southeast of Unity, OR. Timber, brush and tall grass. Minimal fire behavior.

Cornet-Windy Ridge, Vale District, BLM. Timber and short grass. Minimal fire behavior with smoldering.

Willamina Creek, Salem District, BLM. Started on state land ten miles north of Willamina, OR. Timber and medium logging slash. Minimal fire behavior with creeping and smoldering. Road and area closures in effect.

Alder Lake, Gifford Pinchot NF. Seven miles south of Eatonville, WA. Timber and closed timber litter. Moderate fire behavior with creeping and smoldering. Structures threatened.

Area Command Team (VanBruggen) is assigned to the Grangeville, ID area for large fire support.

Motorway Complex (16 fires), Nez Perce - Clearwater NF. IMT 2 (Staats). Ten miles east of Kooskia, ID. Timber, closed timber litter and brush. Active fire behavior with torching, backing and creeping. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

Clearwater Complex (2 fires), Nez Perce - Clearwater NF. IMT 1 (Poncin). IMT is also managing the Jay Pt fire. Started on state land one mile northwest of Kamiah, ID. Timber, hardwood slash and dormant brush. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Road, area and trail closures in effect.

Jay Pt, Nez Perce - Clearwater NF. Five miles south of Powell Junction, ID. Timber and light logging slash. Moderate fire behavior with single tree torching, backing and creeping. Structures threatened. Area closures in effect.

Clark Fork Complex (5 fires), Idaho Panhandle NF. IMT 2 (Hutton). Six miles north of Clark Fork, ID. Timber and closed timber litter. Moderate fire behavior with single tree torching and short-range spotting. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

Thompson Divide Complex (3 fires), Glacier NP. IMT 2 (Leach). Three miles southwest of Essex, MT. Timber. Moderate fire behavior with group torching. Numerous structures threatened. Evacuations, area and trail closures in effect.

Northeast Kootenai Complex (2 fires), Kootenai NF. IMT 2 (Pearson). Four miles northwest of Trego, MT. Timber. Active fire behavior with short crown runs, group torching and backing. Structures threatened. Road, area and trail closures in effect.

Marble Creek, Idaho Panhandle NF. Seven miles southeast of Avery, ID. Timber. Active fire behavior with group torching and short-range spotting. Structures threatened. Road, area and trail closures in effect.

Morrell Complex (2 fires), Lolo NF. IMT 2 (Grant). Seven miles north of Seeley Lake, MT. Timber and closed timber litter. Active fire behavior with short crown runs, group torching and spotting. Road, area and trail closures in effect.

Wash, Nez Perce - Clearwater NF. IMT 1 (Dueitt). IMT is also managing the Baldy fire and Selway Complex. Previously reported incident. Seven miles northeast of Elk City, ID. Timber, closed timber litter and brush. Extreme fire behavior with wind-driven runs, flanking and spotting. Structures threatened. Road, area and trail closures in effect.

Baldy, Nez Perce - Clearwater NF. Previously reported incident. Fourteen miles northwest of Elk City, ID. Timber and short grass. Active fire behavior with wind-driven runs and flanking. Structures threatened. Road, area and trail closures in effect.

Selway Complex (3 fires), Nez Perce - Clearwater NF. Forty-one miles west of Darby, MT. Timber, closed timber litter and brush. Active fire behavior with wind-driven runs, group torching and spotting. Structures threatened. Evacuations, road, area and trail closures in effect. Reduction in acreage due to the realignment of fires within the complex.

Grizzly Complex (4 fires), Idaho Panhandle NF. IMT 2 (Fry). Fourteen miles north of Kellogg, ID. Timber. Moderate fire behavior with uphill runs, torching and spotting. Numerous structures threatened. Road, area and trail closures in effect.

Bear Creek, Flathead NF. Previously reported incident. Twenty-six miles southeast of Bigfork, MT. Timber. Moderate fire behavior with torching, creeping and backing. Road, area and trail closures in effect. Last report unless significant activity occurs.

Last Inch, Clearwater Potlatch Timber Protective Association. IMT 2 (Schenk). Twelve miles east of Clarkia, ID. Timber. No new information.

Bear Lake, Beaverhead - Deerlodge NF. IMT 2 (Bentley). Twelve miles southeast of Wisdom, MT. Closed timber litter. Active fire behavior with group torching and long-range spotting. Structures threatened. Road, area and trail closures in effect.

Sucker Creek, Helena NF. IMT 2 (Bales). Six miles northeast of Lincoln, MT. Timber. Moderate fire behavior with isolated torching, flanking and creeping. Road closures in effect.

Municipal Complex (2 fires), Clearwater Potlatch Timber Protective Association. IMT 1 (Wilkins). One mile east of Orofino, ID. Timber and brush. Minimal fire behavior with creeping and smoldering. Numerous structures threatened.

Goat Rock Complex (5 fires), Kootenai NF. IMT 2 (Russell). Eight miles southwest of Libby, MT. Timber. Active fire behavior with group torching, short-range spotting and backing. Structures threatened. Area and trail closures in effect.

Melton 1, Flathead Agency, BIA. Eight miles north of Dixon, MT. Timber. Minimal fire behavior. Structures threatened.

Wilderness Complex (6 fires), Nez Perce - Clearwater NF. Previously reported incident. Thirty-seven miles northwest of Darby, MT. Timber and closed timber litter. Active fire behavior with wind-driven runs, group torching and spotting. Structures threatened. Trail closures in effect. Last report unless significant activity occurs.

Red River Complex (4 fires), Nez Perce - Clearwater NF. Previously reported incident. Eleven miles south of Elk City, ID. Timber. Active fire behavior with group torching, uphill runs and flanking. Structures threatened. Road, area and trail closures in effect. Last report unless significant activity occurs.

Larkin Complex (4 fires), Nez Perce - Clearwater NF. Thirty miles northeast of Pierce, ID. Closed timber litter. Moderate fire behavior. Road and trail closures in effect.

Tepee Mountain, Kootenai NF. Thirteen miles north of Troy, MT. Timber. Active fire behavior with isolated torching and spotting.

Scotchmans Gulch, Beaverhead - Deerlodge NF. Fifteen miles northwest of Philipsburg, MT. Timber. Minimal fire behavior with creeping. Trail closures in effect.

Big Lost, Ponderosa Area Office, IDL. Twenty-five miles north of Moscow, ID. Timber and heavy logging slash. No new information. Last report unless new information is received.

Nickowitz, Six Rivers NF. IMT 2 (Jay Kurth). Fifteen miles west of Somes Bar, CA. Timber, chaparral and tall grass. Moderate fire behavior with isolated torching, flanking and backing. Road, area and trail closures in effect.

Predictive Services Discussion: Hot and dry conditions will persist over much of the western United States today underneath a ridge of high pressure. Clear, but smoky skies are expected over Northern California, the Pacific Northwest and Northern Rockies. Gusty winds may pick up in the afternoon over Northern California, Southern Oregon and Northwestern Nevada. A surge of monsoonal moisture will produce scattered showers and thunderstorms across portions of Southern California, the Southwest and the Great Basin, with dry thunderstorms likely in central Nevada and central Idaho. In contrast, an upper level trough brings cooler than normal temperatures to the eastern United States with showers from the upper Mid-west through the far Northeast and in the far southeast. Heavy rainfall will also continue in the Hawaiian Islands.

Hydration

Firefighter Health & First Aid

Dehydration is the result of the body trying to regulate its temperature naturally through sweating. Maintaining body fluids is essential for sweating. You must hydrate before, during, and after work.

- Studies conducted on wildland firefighters indicate that during fire suppression activities firefighters need to drink a minimum of 1 quart of fluid each hour of work.
- Before work you should take extra fluids to prepare for the heat. Drink 1 or 2 cups of water, juice, or a sport drink before work.
- While working drink at least 1 quart of fluid per hour. Drink as much as you can during the lunch break. Water is your greatest need during work in the heat.
- Hyponatremia (abnormally low concentration of sodium in the blood) as a result of excessive water intake is a potentially life-threatening complication and can be prevented when rehydration is enhanced by fluids containing sodium and potassium, or when foods with these electrolytes are consumed along with water.
- After work it is important to continue drinking to replace fluid losses. Thirst always underestimates fluid needs, so you should drink more than you think you need.
- Unacclimatized workers lose more salt in the heat so they need to pay particular attention to salt replacement.
- Don't overdo salt intake; too much salt impairs temperature regulation. Excessive salt can cause stomach distress, fatigue, and other problems.
- You can assess your hydration by observing the volume, color, and concentration of your urine. Low volumes of dark, concentrated urine or painful urination indicate a serious need for rehydration. Other signs of dehydration include a rapid heart rate, weakness, excessive fatigue, and dizziness.
- Rapid loss of several pounds of body weight is a certain sign of dehydration. Rehydrate before returning to work; continuing to work in a dehydrated state can lead to serious consequences, including heat stroke, muscle breakdown, and kidney failure.
