**Tetlin Hills**, Tok Area Forestry, DOF. Previously reported incident. Eight miles southeast of Tok, AK. Timber. Extreme fire behavior with uphill runs, wind-driven runs and short-range spotting. Structures threatened.

**Spicer Creek**, Tanana Zone, BLM. IMT2 (Staats). IMT is also managing the Tozitna, Hay Slough, Kokrine, Bering Creek, Blind River, Moose Point and Harper Bend fires. Started on native corporation land seven miles northeast of Tanana, AK. Timber. Minimal fire behavior. Numerous structures threatened. Evacuations in effect.

**Tozitna**, Tanana Zone, BLM. Four miles northwest of Tanana, AK. Timber. Minimal fire behavior. Numerous structures threatened. Evacuations in effect.

**Hay Slough**, Tanana Zone, BLM. Fourteen miles southeast of Tanana, AK. Timber. Minimal fire behavior. Structures threatened.

**Kokrine**, Tanana Zone, BLM. Started on state land 55 miles west of Tanana, AK. Timber. Minimal fire behavior.

**Bering Creek**, Tanana Zone, BLM. Thirty-five miles west of Tanana, AK. Timber. Minimal fire behavior.

**Blind River**, Tanana Zone, BLM. Twenty miles west of Tanana, AK. Timber. Minimal fire behavior.

**Moose Point**, Tanana Zone, BLM. Started on state land 50 miles west of Tanana, AK. Timber. Minimal fire behavior.

**Harper Bend**, Tanana Zone, BLM. Twelve miles southeast of Tanana, AK. Timber. Minimal fire behavior. Structures threatened.

**Nenana Ridge**, Fairbanks Area Forestry, DOF. Twelve miles east of Four Mile Rd, AK. Light logging slash. Moderate fire behavior.

**Rex Complex (two fires)**, Fairbanks Area Forestry, DOF. IMT2 (Sheldon). Started on private land southeast of Clear, AK. Timber, tall grass and brush. Minimal fire behavior with creeping and smoldering. Structures threatened. Evacuations, road and trail closures in effect.

\* **Rock Creek**, Southwest Area Forestry, DOF. Sixty-five miles northeast of Port Alsworth, AK. Timber. Active fire behavior.

**Aggie Creek**, Fairbanks Area Forestry, DOF. IMT2 (Rosenthal). Thirty miles northwest of Fairbanks, AK. Timber. Minimal fire behavior with torching, creeping and smoldering. Structures threatened.

**Nulato**, Galena Zone, BLM. IMT2 (Hutton). IMT is also managing the Ruby Slough fire. Started on native corporation land two miles north of Nulato, AK. Timber, brush and short grass. Moderate fire behavior with torching and flanking. Numerous structures threatened.

**Ruby Slough**, Galena Zone, BLM. Five miles southwest of Ruby, AK. Timber. Minimal fire behavior.

**Healy Lake**, Delta Area Forestry, DOF. IMT2 (Bentley). IMT is also managing the Michigan Creek fire. Started on native corporation land 28 miles southeast of Delta Junction, AK. Timber. Minimal fire behavior with creeping and smoldering. Structures threatened.

**Michigan Creek**, Delta Area Forestry, DOF. Thirty-eight miles northeast of Delta Junction, AK. Timber. Minimal fire behavior. Reduction in acreage due to more accurate mapping.

**Long Lake**, Tok Area Forestry, DOF. Two miles east of Northway, AK. Timber. Moderate fire behavior with isolated torching and creeping. Structures threatened. Reduction in acreage due to more accurate mapping.

**Baker**, Tanana Zone, BLM. Five miles southwest of Eureka, AK. Closed timber litter. Minimal fire behavior with isolated torching and creeping. Structures threatened.

**Whitefish Lake 1**, Southwest Area, DOF. Previously reported incident. Started on FWS land 20 miles southwest of Kalskag, AK. Timber and short grass. Moderate fire behavior with flanking, backing and creeping. Structures threatened.

\* **Egavik**, Galena Zone, BLM. Eleven miles northeast of Unalakleet, AK. Hardwood litter. Moderate fire behavior with running.

**Sockeye**, Mat-Su Area Forestry, DOF. Started on private land six miles north of Willow, AK. Timber. Minimal fire behavior. Numerous structures threatened.

**Anaconda Creek**, Fairbanks Area Forestry, DOF. IMT2 (Allen). IMT is also managing the West Fork fire. Timber. Minimal fire behavior with creeping and smoldering. Numerous structures threatened.

**West Fork**, Fairbanks Area Forestry, DOF. Three miles east of Minto, AK. Timber. Minimal fire behavior with creeping and smoldering. Structures threatened.

**Card Street**, Kenai-Kodiak Area Forestry, DOF. IMT2 (Allbee). Started on native corporation land five miles southeast of Sterling, AK. Timber. Minimal fire behavior with creeping and smoldering. Structures threatened. Area and trail closures in effect.

**Whakatna**, Galena Zone, BLM. Started on native corporation land 12 miles northeast of Galena, AK. Hardwood Litter. Minimal fire behavior with smoldering. Reduction in acreage due to more accurate mapping.

**Nikolai Slough**, Galena Zone, BLM. Started on native corporation land seven miles northwest of Galena, AK. Timber. Moderate fire behavior with running. Structures threatened.

**Stetson Creek**, Chugach NF. IMT2 (Goff). IMT is also managing the Juneau Lake fire. Timber. Minimal fire behavior with smoldering and creeping. Area and trail closures in effect.

**Juneau Lake**, Chugach NF. Five miles north of Cooper Landing, AK. Timber and brush. Minimal fire behavior with smoldering. Evacuations and trail closures in effect.

**Tanana Slough**, Tok Area Forestry, DOF. Started on native corporation land four miles north of Dot Lake, AK. Timber. Significant precipitation over occurred over the fire area. Minimal fire behavior.

**Iditarod River**, Southwest Area Forestry, DOF. Three miles north of Iditarod, AK. Previously reported incident. Timber. Moderate fire behavior with creeping and torching. Structures threatened.

**North Aniak**, Southwest Area Forestry, DOF. Two miles north of Aniak, AK. Timber. Moderate fire behavior with torching and creeping. Structures threatened.

**Village Creek**, Southwest Area Forestry, DOF. Previously reported incident. Six miles west of Crooked Creek, AK. Timber. Moderate fire behavior with creeping. Last report unless significant activity occurs.

\* **Fog River**, Southwest Area Forestry, DOF. Started on FWS land seven miles north of Red Devil, AK. Short grass. Active fire behavior. Last report unless significant activity occurs.

\* **Munsatli**, Tanana Zone, BLM. One hundred seventeen miles southeast of Ruby, AK. Closed timber litter. Active fire behavior with torching and creeping.

\* **Anakshek Pass**, Southwest Area Forestry, DOF. Started on FWS land 12 miles southeast of Nunam Iqua, AK. Short grass. Active fire behavior. Last report unless significant activity occurs.

\* **Gechiak Lake**, Southwest Area Forestry, DOF. Thirteen miles northwest of Twin Hills, AK. Short grass. Active fire behavior. Last report unless significant activity occurs.

\* **Carlson Lake**, Tanana Zone, BLM. Five miles southeast of Lake Minchumina, AK. Closed timber litter. Active fire behavior with crowning and running. Structures threatened. Last report unless significant activity occurs.

\* **Izavlknek River**, Southwest Area Forestry, DOF. Started on FWS land 53 miles northeast of Newtok, AK. Short grass. Active fire behavior. Last report unless significant activity occurs.

\* **Hamlin Creek**, Upper Yukon Zone, BLM. Two miles northeast of Fort Hamlin, AK. Timber and closed timber litter. Active fire behavior with torching and creeping. Last report unless significant activity occurs.

\* **Coffee Creek**, Southwest Area Forestry, DOF. Sixteen miles north of King Salmon, AK. Short grass. Active fire behavior. Last report unless significant activity occurs.

- \* **Gentian**, Tanana Zone, BLM. Started on state land three miles southwest of Poorman, AK. Timber. Active fire behavior. Last report unless significant activity occurs.

**Predictive Services Discussion** A ridge of high pressure over the western U.S. will continue to strengthen its grip. On the western periphery, a series of weak disturbances will move northward through California, Oregon and Washington to provide showers and thunderstorms, with isolated storms over the remainder of the west. Record breaking temperatures will continue over the Great Basin and Pacific Northwest, with very low humidity. Scattered showers and thunderstorms will also continue to move around the east side of the ridge through the Rocky Mountain region and southwest U.S. A pair of upper level troughs in the Great Lakes and northeast U.S. will kick off showers and thunderstorms from the upper Mid-West to New England. Moderating conditions are anticipated for Alaska today, with less lightning coverage, but locally breezy winds in the southern Interior.

## POWERLINE SAFETY

*Miscellaneous Fireline Hazards 1545*

Operating near or under power lines poses unique hazards, and the following precautions should be followed to reduce potential equipment damage or injury:

- If possible, the power company should deactivate lines in the fire area.
- Don't operate heavy equipment under power lines.
- Keep all aviation activity away from power lines. Inform air attack and/or other aviation resources of the location of the power lines.
- Don't drive with long antennas under power lines.
- Don't stand near power lines during retardant drops.
- Don't park under power lines. The magnetic field around energized power lines can induce an electrical charge in ungrounded vehicles or equipment. This charge can shock anyone who touches the vehicle.
- Don't apply straight stream to power lines.
- All personnel should be cautioned that smoke may become charged and conduct the electrical current. Deactivated transmission and distribution lines may continue to pose a hazard due to induction.
- If power lines fall on your vehicle, DON'T leave the vehicle until the power company arrives. If the vehicle is on fire or fire is near, jump clear, don't hang on, keep feet together, and bunny hop away.
