Two hundred soldiers from the 17<sup>th</sup> Field Artillery Brigade based out of Fort Lewis, Washington are deployed in Washington state.

Two MAFFS C-130 Airtankers are assigned to Channel Islands, California in support of wildland fire operations.

Sixty-eight fireline management personnel from Australia and New Zealand are assigned to support large fires in the Northwest Area.

**Okanogan Complex (2 fires)**, Northeast Region, DNR. IMT 2 (Lietch). Eleven miles northwest of Omak, WA. Timber and brush. Minimal fire behavior with backing, creeping and smoldering. Road, area and trail closures in effect.

**North Star**, Colville Agency, BIA. Transfer of command from IMT 1 (Minton) to IMT 1 (McGowen) will occur today. IMT is also managing the Tunk Block fire. Twenty-four miles east of Omak, WA. Timber and closed timber litter. Moderate fire behavior with flanking, backing and creeping. Numerous structures threatened. Road and area closures in effect.

**Tunk Block**, Northeast Region, DNR. Ten miles northeast of Omak, WA. Timber and brush. Moderate fire behavior with flanking, backing and creeping. Numerous structures threatened. Road and area closures in effect.

**Canyon Creek Complex**, Malheur NF. IMT 2 (Goff). Two miles south of John Day, OR. Timber and short grass. Moderate fire behavior with isolated torching, backing and creeping. Structures threatened. Road, area and trail closures in effect.

**Chelan Complex (3 fires)**, Southeast Region, DNR. IMT 2 (Allbee). Started on BLM land one mile south of Chelan, WA. Timber. Active fire behavior with torching, backing and creeping. Road and trail closures in effect.

**Kettle Complex (3 fires)**, Colville NF. IMT 2 (Ciraulo). Fifteen miles northeast of Republic, WA. Timber and light logging slash. Minimal fire behavior with torching, backing and creeping. Numerous structures threatened. Road, area and trail closures in effect.

**Kaniksu Complex (3 fires)**, Colville NF. IMT 2 (Tom Kurth). Ten miles northeast of Usk, WA. Timber. Minimal fire behavior with smoldering. Road, area and trail closures in effect.

**Carpenter Rd**, Spokane Agency, BIA. IMT 2 (Johnson). Five miles south of Fruitland, WA. Timber and short grass. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Road closures in effect. Reduction in acreage due to more accurate mapping.

**Wolverine**, Okanogan-Wenatchee NF. IMT 2 (Rabe). IMT is also managing the First Creek fire. Three miles northwest of Lucerne, WA. Timber. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Road, area and trail closures in effect.

**First Creek**, Okanogan-Wenatchee NF. Eight miles northwest of Chelan, WA. Timber and short grass. Minimal fire behavior with smoldering.

**Cougar Creek**, Yakama Agency, BIA. Six miles northwest of Glenwood, WA. Timber. Minimal fire behavior with isolated torching, creeping and smoldering. Structures threatened. Road, area and trail closures in effect.

**National Creek Complex**, Rogue River-Siskiyou NF. Eleven miles southwest of Diamond Lake, OR. Timber. Moderate fire behavior with group torching. Road, area and trail closures in effect.

**Oven**, Prineville District, BLM. Three miles east of Maupin, OR. Brush and short grass. Minimal fire behavior with creeping and smoldering.

**Alder Lake**, Gifford Pinchot NF. Seven miles south of Eatonville, WA. Closed timber litter. No new information. Last report unless significant activity occurs.

**Predictive Services Discussion:** Another day of warm, dry and unstable conditions can be expected across portions of the western U.S. as a thermal trough of low pressure at the surface moves east of the Cascade Mountains in the Pacific Northwest. This will be in response to an upper level ridge of high pressure flattening out with the approach of several storm systems in the Pacific. Ahead of this, expect temperatures to continue above normal across the northern Rockies and Plains region with locally breezy conditions. Isolated showers and thunderstorms will develop over the higher terrain of California and the Great Basin as subtropical moisture streams northward. Cooler weather will persist over the eastern U.S. today with showers and thunderstorms focused along a cold front extending from New England through the Appalachian Mountains and along the Gulf Coast.

## MY SAFETY

Leadership Category

An important aspect of safety is individual responsibility for one's own health & safety. Even with the best supervision, each individual firefighter will occasionally be required to make personal decisions concerning their safety. It is important that individual responsibility be taught as the basis for a viable safety program. Some of those individual responsibilities are:

- Fitness for duty. Begin each work shift both mentally and physically prepared for the rigors of wildland firefighting. Getting adequate sleep, maintaining a healthy diet, and proactively participating in physical training are the foundation of "My Safety".
- Utilization of personal protective equipment. Wear your PPE without being told. Each individual is responsible for performing their own risk assessments. If a hazard is identified that can be mitigated by wearing a particular PPE component it should be utilized. Fireline supervisors have more important duties to focus on other than performing glove patrol.
- Following safe work practices. Using a spotter when backing up vehicles is the prudent and professional course of action. If you are unsure of how to perform a job task safely, ask your supervisor or experienced coworker.
- Using the correct reference materials is an important aspect of safety. You should have a working knowledge of the Red Book, IRPG, and your local operating guidelines.
- Ensure instructions are clearly understood. Communication is a basic responsibility for all fire personnel. Ask appropriate questions to clarify uncertain issues. Speak up when you observe hazards that may place yourself or others at risk.
- Maintain situational awareness at all times. Awareness is a vital component of "My Safety". Pay attention to what is happening around your area of operations. Always display an awareness of what is happening around you by asking questions or making comments.

**Summary: Do not expect someone else to be responsible for your safety. Take it upon yourself to make "My Safety" your number one priority.**

**Discussions points:**

1. *Talk about ways you can improve on your safety.*
2. *Have your supervisor talk about their expectations for individual safety.*
