Rock Mountain, Chattahoochee-Oconee NF. IMT 1 (Livingston) Includes previously reported Flat Branch fire. Two miles south of Tate City, GA. Hardwood litter and timber. Extreme fire behavior with running and backing. Structures threatened. Road closures in effect.

Party Rock, North Carolina Forest Service. IMT 2 (Brandon). One mile north of Lake Lure, NC. Hardwood litter. Active fire behavior with uphill runs, running, and backing. Numerous structures threatened. Road, area and trail closures in effect.

Boteler, National Forests in North Carolina. IMT 1 (Dueitt). IMT is also managing the Tellico, Ferebee Memorial, Dick's Creek, Knob, Cliffside and Muskrat fires. Nine miles east of Hayesville, NC. Timber and brush. Active fire behavior with uphill runs, backing and flanking. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Tellico, National Forests in North Carolina. Includes previously reported Ferebee Memorial fire. Three miles south of Almond, NC. Hardwood litter, timber and short grass. Active fire behavior with backing and flanking. Numerous structures threatened. Road and trail closures in effect.

Dick's Creek, National Forests in North Carolina. Two miles northwest of Sylva, NC. Hardwood litter, short grass and timber. Moderate fire behavior with backing, creeping and smoldering. Structures threatened.

Knob, National Forests in North Carolina. Ten miles southwest of Franklin, NC. Closed timber litter and hardwood litter. Minimal fire behavior with creeping and smoldering. Area and trail closures in effect.

Cliffside, National Forests in North Carolina. Three miles northwest of Highlands, NC. Hardwood litter, timber and short grass. Minimal fire behavior with smoldering.

* **Muskrat**, North Carolina Forest Service. Eight miles southwest of Franklin, NC. Hardwood litter and timber. Active fire behavior with flanking and backing. Structures threatened.

Chestnut Knob, North Carolina Forest Service. IMT 2 (Kern). Three miles south of Enola, NC. Hardwood litter. Moderate fire behavior with uphill runs, flanking and backing. Structures threatened. Area and trail closures in effect.

Maple Springs, National Forests in North Carolina. IMT 2 (Esperance). IMT is also managing the Old Roughy fire. Three miles northwest of Santeetlah Lake, NC. Hardwood litter, timber and brush. Active fire behavior with uphill runs and short-range spotting. Structures threatened. Evacuations, road, area and trail closures in effect.

Old Roughy, National Forests in North Carolina. Five miles north of Pelham, TN. Hardwood litter, timber and brush. Active fire behavior with uphill runs and short-range spotting. Structures threatened. Evacuations and road closures in effect.

Pinnacle Mountain, South Carolina Forestry Commission. Three miles southeast of Rocky Bottom, SC. Hardwood Litter and Timber. Active fire behavior. Numerous structures threatened. Evacuations, area and trail closures in effect.

Rough Ridge, Chattahoochee-Oconee NF. IMT 2 (Bentley). Thirteen miles northwest of Blue Ridge, GA. Hardwood litter, timber and brush. Moderate fire behavior with wind driven runs, backing and flanking. Structures threatened. Area and trail closures in effect.

* **Neddy Mountain Road**, Tennessee DOF. Three miles northeast of Del Rio, TN. Hardwood litter. Active fire behavior with uphill runs. Numerous structures threatened. Evacuations in effect.

Eastern Cherokee Complex, Eastern Cherokee Agency (2 fires). IMT 1 (Wilkins). Four miles east of Cherokee, NC. Hardwood litter. No new information

Cloverlick, Kentucky DOF. Previously reported incident. Two miles south of Lynch, KY. Hardwood Litter. Active fire behavior.

Raven Rock, George Washington & Jefferson NF. Started on private land one mile east of Jenkins, KY. Hardwood litter and timber. Minimal fire behavior with smoldering and creeping. Numerous structures threatened. Trail closures in effect.

Gatliff, Kentucky DOF. Five miles south of Gatliff, KY. Hardwood litter and timber. Active fire behavior.

Abner Br, Kentucky DOF. Previously reported incident. Two miles southwest of Big Laurel, KY. Timber and Hardwood Litter. Active fire behavior.

Kentucky Ridge, Kentucky DOF. One mile northwest of Chenoa, KY. Hardwood litter and timber. Active fire behavior.

* **Fairview**, Virginia DOF. Five miles southwest of Duffield, VA. Hardwood litter and closed timber litter. Active fire behavior with uphill runs. Structures threatened.

* **White Oak Circle**, Tennessee DOF. Started on private land four miles east of Sunbright, TN. Hardwood litter. Active fire behavior with uphill runs.

Treat Mountain, Georgia Forestry Commission. Twenty miles southwest of Cedartown, GA. Timber. Moderate fire behavior with flanking and backing. Structures threatened.

Lookout Mountain, Georgia Forestry Commission. Fifteen miles southwest of Trenton, GA. Hardwood litter and timber. Moderate fire behavior with flanking and backing. Structures threatened. Road closures in effect.

* **Mowbray**, Tennessee DOF. Started on private land three miles northwest of Soddy Daisy, TN. Dormant brush, hardwood slash and timber. Active fire behavior with running, flanking and backing. Structures threatened. Evacuations in effect.

* **Timber Ridge**, Chattahoochee-Oconee NF. Three miles southeast of Tiger, GA. Hardwood litter and timber. Extreme fire behavior with running, backing and short-range spotting. Structures threatened.

Mountain Creek, Ozark & St. Francis NF. Seventeen miles north of Ozark, AR. Timber. Minimal fire behavior with smoldering. Trail closures in effect.

Ellen Lane, Kentucky DOF. Two miles south of Gray, KY. Hardwood litter and timber. Active fire behavior.

* **Buckhorn Rd**, Kentucky DOF. One mile southwest of Beaver, KY. Hardwood litter and timber. Active fire behavior.

Bear Crossing, Virginia DOF. One mile west of Stacy, VA. Hardwood litter. No new information.

* **Bull Creek**, Kentucky DOF. Three miles west of Woolum, KY. Hardwood litter and timber. Active fire behavior.

Laurel Run Park Road, Tennessee DOF. Started on private land three miles southeast of Church Hill, TN. Timber. No new information.

Tatum Gulf, Georgia Forestry Commission. Eleven miles west of LaFayette, GA. Hardwood litter. Active fire behavior with flanking, backing and isolated torching. Numerous structures threatened. Road and area closures in effect.

* **Horsepen Road**, Virginia DOF. Three miles west of Stacy, VA. Hardwood litter. Moderate fire behavior. Structures threatened.

* **West Chapparral**, George Washington & Jefferson NF. Three miles southwest of Tacoma, VA. Hardwood litter and brush. Moderate fire behavior with flanking, backing and smoldering. Structures threatened.

* **White Mtn**, Kentucky DOF. Five miles north of Ajay, KY. Hardwood litter and timber. Active fire behavior.

Buckeye Mountain, Virginia DOF. One mile south of Eggleston, VA. Hardwood Litter. Minimal fire behavior. Structures threatened.

* **Clear Creek Road**, Tennessee DOF. Started on private land seven miles west of Sharpes Chapel, TN. Hardwood litter. Active fire behavior.

* **Creek Road**, Georgia Forestry Commission. Five miles northeast of Trenton, GA. Hardwood litter. Active fire behavior with flanking, backing and isolated torching. Structures threatened.

Predictive Services Discussion: High pressure will remain over the East and the South. A trough over the central states will keep windy conditions in place across the Plains. High pressure will build over the West. Except for a few scattered showers over the Rockies and rain moving into the Northwest late, the nation will be mostly dry. Temperatures will remain cool over the Midwest and Northeast and turning cooler across the Northwest, Northern Rockies and the northern Great Basin. The South and Southwest will remain very warm while warm conditions spread into the central Plains.

Parking Safely on Slopes

Vehicles/Roads Category

In 2005, three fireline fatalities related to improper parking on slopes occurred. One involved a water tender, another a fire engine and the third was a command vehicle. In wildland fire operations, we frequently exit vehicles quickly, but it is imperative that anytime a vehicle is left unattended, time is taken to assure it is parked safely and will not present a hazard to ourselves or others. Standard operating procedures for parking vehicles safely on slopes are:

- Turn the front wheels uphill or into the inside/embankment.
- Firmly set the emergency brake.
- Put the vehicle in park (if automatic transmission) or in forward gear (if manual transmission); do not leave it in neutral.
- Turn off the engine.
- Chock the wheels. When utilizing chocks, make sure they are on the correct side in reference to the slope. Assure the chocks are approved to hold the weight of the vehicle and will grip on the road surface.
- Be especially aware of safe parking on slopes on incidents when moving a vehicle frequently, as in using engines in pumping operations along a roadway -- it is very easy to get complacent with procedures or not even realize that you are on a slightly different slope which would require placing chocks differently. It is the driver's responsibility to assure not only that the vehicle is operated safely, but is positioned and parked safely.
