Party Rock, North Carolina Forest Service. IMT 2 (Brandon). One mile north of Lake Lure, NC. Hardwood litter. Active fire behavior with uphill runs. Numerous structures threatened. Road, area and trail closures in effect.

Tellico, National Forests in North Carolina. IMT 1 (Dueitt). IMT is also managing the Boteler, Dick's Creek, Knob, and Muskrat fires. Three miles south of Almond, NC. Hardwood litter, timber and short grass. Moderate fire behavior with flanking and backing. Numerous structures threatened. Evacuations, road and trail closures in effect.

Boteler, National Forests in North Carolina.. Nine miles east of Hayesville, NC. Timber and brush. Active fire behavior with uphill runs, backing and flanking. Numerous structures threatened. Area, road and trail closures in effect.

Dick's Creek, National Forests in North Carolina. Two miles northwest of Sylva, NC. Hardwood litter, short grass and timber. Minimal fire behavior with smoldering and creeping. Structures threatened.

Knob, National Forests in North Carolina. Ten miles southwest of Franklin, NC. Closed timber litter and hardwood litter. Minimal fire behavior with smoldering. Area and trail closures in effect. Last report unless significant activity occurs.

Muskrat, North Carolina Forest Service. Eight miles southwest of Franklin, NC. Hardwood litter and timber. Moderate fire behavior with backing, creeping and smoldering. Structures threatened.

Rock Mountain, Chattahoochee-Oconee NF. IMT 1 (Livingston). Two miles south of Tate City, GA. Hardwood litter and timber. Active fire behavior with flanking, running and backing. Structures threatened. Evacuations, road and trail closures in effect.

Maple Springs, National Forests in North Carolina. IMT 2 (Esperance). IMT is also managing the Old Roughy fire. Three miles northwest of Santeetlah Lake, NC. Hardwood litter, timber and brush. Active fire behavior with uphill runs, short-range spotting and smoldering. Structures threatened. Road, area and trail closures in effect.

Old Roughy, National Forests in North Carolina. Five miles north of Pelham, TN. Hardwood litter, timber and brush. Moderate fire behavior with creeping and smoldering. Structures threatened. Road closures in effect.

Tatum Gulf, Georgia Forestry Commission. Eleven miles west of LaFayette, GA. Includes previously reported Lookout Mountain fire. Hardwood litter. Extreme fire behavior with uphill runs, spotting and torching. Numerous structures threatened. Evacuations, road and area closures in effect.

Chestnut Knob, North Carolina Forest Service. IMT 2 (Kern). Three miles south of Enola, NC. Hardwood litter. Moderate fire behavior with backing, flanking and creeping. Structures threatened. Area and trail closures in effect.

Pinnacle Mountain, South Carolina Forestry Commission. Three miles southeast of Rocky Bottom, SC. Hardwood Litter and Timber. Active fire behavior. Numerous structures threatened. Area and trail closures in effect.

Eastern Cherokee Complex, Eastern Cherokee Agency (2 fires). Transfer of command from IMT 1 (Wilkins) back to the local unit will occur today. Four miles east of Cherokee, NC. Hardwood litter. Minimal fire behavior with creeping and smoldering. Structures threatened. Road and area closures in effect.

Rough Ridge, Chattahoochee-Oconee NF. IMT 2 (Bentley). Thirteen miles northwest of Blue Ridge, GA. Hardwood litter, timber and brush. Moderate fire behavior with wind uphill runs, backing and flanking. Structures threatened. Area and trail closures in effect.

Neddy Mountain Road, Tennessee DOF. Three miles northeast of Del Rio, TN. Hardwood litter. No new information.

Raven Rock, George Washington & Jefferson NF. Started on private land one mile east of Jenkins, KY. Hardwood litter and timber. Minimal fire behavior with smoldering and creeping. Numerous structures threatened. Trail closures in effect.

Cloverlick, Kentucky DOF. Two miles south of Lynch, KY. Hardwood Litter. Active fire behavior.

Abner Br, Kentucky DOF. Two miles southwest of Big Laurel, KY. Timber and Hardwood Litter. Active fire behavior.

Timber Ridge, Chattahoochee-Oconee NF. Three miles southeast of Tiger, GA. Hardwood litter and timber. Active fire behavior with running and backing. Numerous structures threatened.

Fairview, Virginia DOF. Five miles southwest of Duffield, VA. Hardwood litter and closed timber litter. Moderate fire behavior. Structures threatened.

White Oak Circle, Tennessee DOF. Started on private land four miles east of Sunbright, TN. Hardwood litter. No new information.

* **Bull Creek 2**, Kentucky DOF. Three miles west of Woolum, KY. Hardwood litter and timber. Active fire behavior.

Treat Mountain, Georgia Forestry Commission. Twenty miles southwest of Cedartown, GA. Timber. Minimal fire behavior with creeping. Structures threatened. Last report unless significant activity occurs.

Mowbray, Tennessee DOF. Started on private land three miles northwest of Soddy Daisy, TN. Dormant brush, hardwood slash and timber. No new information.

Buckhorn Rd, Kentucky DOF. One mile southwest of Beaver, KY. Hardwood litter and timber. Active fire behavior.

Bull Creek, Kentucky DOF. Three miles west of Woolum, KY. Hardwood litter and timber. Active fire behavior. No new information.

Laurel Run Park Road, Tennessee DOF. Started on private land three miles southeast of Church Hill, TN. Timber. No new information. Last report unless new information is received.

* **Pigeonroost**, Kentucky DOF. Ten miles east of Manchester, KY. Hardwood litter and timber. Active fire behavior.

West Chapparal, George Washington & Jefferson NF. Three miles southwest of Tacoma, VA. Hardwood litter and brush. Minimal fire behavior with smoldering and creeping. Structures threatened.

White Mtn, Kentucky DOF. Five miles north of Ajay, KY. Hardwood litter and timber. Active fire behavior.

Buckeye Mountain, Virginia DOF. One mile south of Eggleston, VA. Hardwood Litter. No new information.

Clear Creek Road, Tennessee DOF. Started on private land seven miles west of Sharpes Chapel, TN. Hardwood litter. No new information.

Creek Road, Georgia Forestry Commission. Five miles northeast of Trenton, GA. Hardwood litter. Minimal fire behavior with backing and creeping. Structures threatened. Last report unless significant activity occurs.

MEDICAL INCIDENT REPORT

Fire Communication Category

The new Medical Incident Report (MIR) form can be found at all of the following: pages 108-09 of the IRPG, Medical Plan ICS-206 WF form and in many Incident Action Plans (IAPs). The MIR evolved from, and has replaced, the "9 Line Form" and "Pink Sticker."

The MIR is not always tasked to the EMT or Paramedic in "Patient Care". The intent of the form is to:

- 1) establish control of the incident whether routine or life-threatening by initiating a new Incident Command System,
- 2) have a systematic standard process for reporting medical incidents/injuries, similar to a fire size-up form for initial attack, and
- 3) have any firefighter be able to fill it out and transmit with prior training and direction.

- Treat it like any incident. If the incident is overwhelming, ask for a more qualified IC to assume command and expand/contract the organization's size depending on the needs of the incident.
- Fill this form out completely prior to transmitting the report to dispatch/communications. If there is a life threat, do not let documentation delay patient care.
- When transmitting the report, state the number and title of each section and say "break" and pause between the sections (e.g., *"Dispatch, TFLD Jones, Stand by for Priority Medical Incident Report. All other radio traffic please hold BREAK (pause/wait for response.)* **2. Incident Status:** *Nature of Illness is chest pain. Incident Name is Tank Medical. IC will be TFLD Jones. Patient Care will be Paramedic Smith. BREAK. 3. Initial Patient Assessment is..."*).
- When using the MIR during a Multi-Casualty Incident (MCI) state the number injured and their severity (Section 3), (e.g., **3. Initial Patient Assessment, I have 5 patients. 3 Reds, 1 Yellow and 1 Green. Mechanism of Injury is..."**).
- Use the terms Paramedic or EMT with the provider's last name in "Patient Care." Do not use EMT to describe a Paramedic or the ambiguous term, "Medic." All those roles need to be clearly identified to understand the level of care and treatment the patient(s) will receive.
- Enact more than one transport plan and clear more than one frequency if needed for Sections 5 and 6.
- Always be ready for the first plan to fail and be flexible enough to move into an alternate plan. Use the acronym PACE (Primary, Alternate, Contingency, and Emergency) for planning purposes.

Action Items:

- Consider developing medical emergency tabletop scenarios as part of morning briefings or field scenarios on project work to be become familiar with the process. The more comfortable with the MIR you are, the more it will be second nature under stress.
- Ensure dispatchers and radio operators are aware of their roles and responsibilities pertaining to the Medical Incident Report.
- Review your local units' Emergency Plans.
