**Long Valley**, Northern California District, BLM. IMT 2 (Fogle). Fifty miles north of Reno, NV. Brush and short grass. Extreme fire behavior with uphill runs, wind driven runs and flanking. Numerous residences threatened. Evacuations, area and trail closures in effect. Energy infrastructure threatened. Sage-grouse habitat threatened.

**MM155**, Winnemucca District, BLM. Twenty-one miles southwest of Winnemucca, NV. Brush and short grass. Active fire behavior with running. Numerous structures threatened. Evacuations in effect. Sage-grouse habitat threatened.

**Snowstorm**, Elko District, BLM. IMT 2 (Goff). IMT is also managing the Cornucopia and Roosters Comb fires. Fifty miles north of Battle Mountain, NV. Tall grass and brush. Extreme fire behavior with running, torching and wind driven runs. Sage-grouse habitat threatened

**Cornucopia**, Northern Region, Nevada DOF. Started on BLM land 32 miles southwest of Owyhee, NV. Brush and tall grass. Minimal fire behavior. Residences threatened. Sage-grouse habitat threatened. Reduction in acreage due to more accurate mapping.

**Roosters Comb**, Northern Region, Nevada DOF. Twenty-five miles north of Battle Mountain, NV. Brush and tall grass. Minimal fire behavior. Sage-grouse habitat threatened.

**Bravo17**, Fallon Naval Air Station, DOD. IMT 2 (Rohrer). Started on BLM land 25 miles east of Fallon, NV. Closed timber litter, brush and short grass. Active fire behavior with running and flanking.

**Brianhead**, Southwest Area, Utah DOF. Transfer of command from IMT 2 (DeMasters) back to the local unit will occur tomorrow. One mile north of Brian Head, UT. Timber and hardwood litter. Minimal fire behavior. Road, area and trail closures in effect.

\* **Juni**, Boise District, BLM. Fifteen miles southwest of Riddle, ID. Brush and short grass. Minimal fire behavior. Sage-grouse habitat threatened.

**Summer**, Northern Region, Nevada DOF. Ten miles north of Wells, NV. Brush and tall grass. Minimal fire behavior with creeping. Sage-grouse habitat threatened.

\* **Eastline**, Sawtooth NF. Thirteen miles south of Rock Creek, ID. Hardwood litter, brush and short grass. Active fire behavior with group torching and running. Evacuations and road closures in effect.

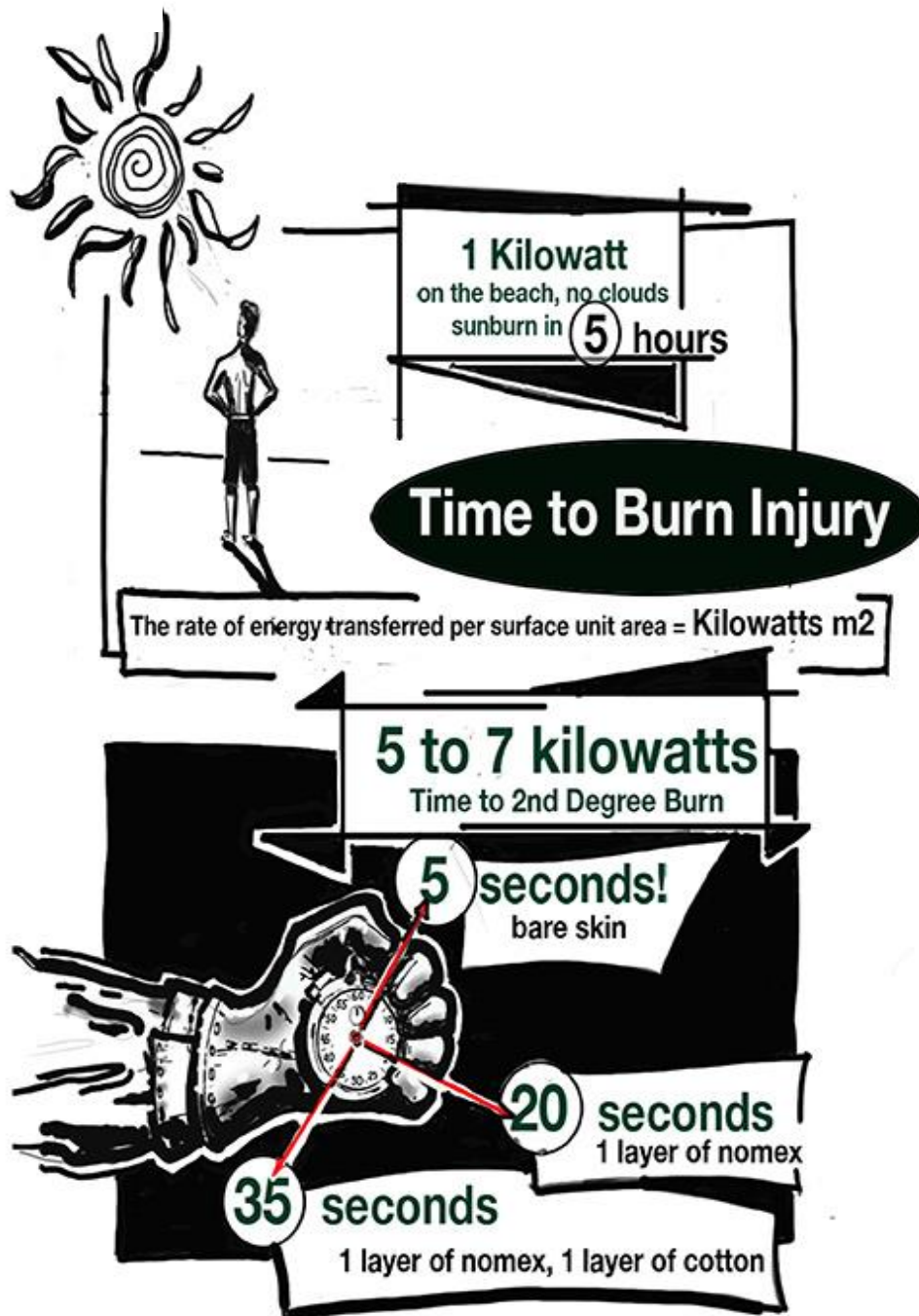
**Predictive Services Discussion:** The strong, hot ridge of high pressure will continue to allow for monsoonal moisture to filter northward across the West. Scattered showers and wet storms are expected across the Southwest while a mix of scattered wet and dry storms are expected across the Great Basin and Northern Rockies. The Mid-Atlantic States and the New England will remain mostly warm and dry while the Southeast remains mostly wet beneath a stalled front. In Alaska, scattered showers and storms are possible along the Arctic Coast and across the interior. Other locations should be warm and dry.
