Area Command Team (Sexton) is managing large fires on the Lolo National Forest and Flathead Reservation.

**Rice Ridge**, Lolo NF. IMT 2 (Thompson). Six miles north of Seeley Lake, MT. Timber. Active fire behavior with uphill runs, group torching and long-range spotting. Structures threatened. Evacuations, road, trail and area closures in effect.

**Caribou**, Kootenai NF. IMT 2 (Pearson). IMT is also managing the Gibraltar Ridge fire. Twenty-one miles northwest of Eureka, MT. Timber. Extreme fire behavior with wind-driven runs and long-range spotting. Residences threatened. Evacuations, road, trail and area closures in effect.

**Gibraltar Ridge**, Kootenai NF. Seven miles east of Eureka, MT. Timber and grass. Moderate fire behavior with torching and backing. Residences threatened. Road, trail and area closures in effect. Reduction in acreage due to more accurate mapping.

**Highway 200 Complex**, (4 fires), Lolo NF. IMT 2 (Connell). IMT is also managing the Sunrise and Moose Peak fires. Nine miles northwest of Plains, MT. Timber. Active fire behavior with torching, uphill runs and flanking. Structures threatened. Evacuations, road and area closures in effect.

**Sunrise**, Lolo NF. Eleven miles east of Superior, MT. Timber and brush. Active fire behavior with short crown runs, group torching and short-range spotting. Trail and area closures in effect.

\* **Moose Peak**, Kootenai NF. Thirteen miles east of Trout Creek, MT. Timber. Active fire behavior with torching, spotting and flanking. Road closures in effect.

**Sprague**, Glacier National Park. IMT 2 (Hutton). Nine miles northeast of West Glacier, MT. Timber. Active fire behavior with group torching, short crown runs and spotting. Structures threatened. Evacuations, trail and area closures in effect.

**East Fork**, Rocky Boy's Agency, BIA. IMT 1 (Martin). Ten miles east of Box Elder, MT. Timber and tall grass. Moderate fire behavior with torching. Structures threatened. Evacuations, road and area closures in effect.

**Meyers**, Beaverhead - Deerlodge NF. IMT 2 (Leach). Twenty-five miles southwest of Philipsburg, MT. Timber. Extreme fire behavior with crowning, torching and long-range spotting. Structures threatened. Evacuations, road and area closures in effect.

**Lolo Peak**, Lolo NF. IMT 1 (Turman). Ten miles southwest of Lolo, MT. Timber. Active fire behavior with group torching, short-range spotting and flanking. Structures threatened. Road, trail and area closures in effect.

**Alice Creek**, Helena – Lewis and Clark NF. IMT 2 (Bird). Fifteen miles northeast of Lincoln, MT. Timber and short grass. Active fire behavior with torching, wind-driven runs and short-range spotting. Residences threatened. Evacuations, road, trail and area closures in effect.

**Liberty**, Flathead Agency, BIA. IMT 2 (Rohrer). Seventeen miles southeast of Arlee, MT. Timber. Moderate fire behavior with flanking, backing and uphill runs. Trail and area closures in effect.

**Sapphire Complex**, (3 fires), Lolo NF. IMT 2 (Almas). Fifteen miles southeast of Clinton, MT. Timber. Active fire behavior with torching and spotting. Structures threatened. Evacuations, road, trail and area closures in effect.

**Sartin Draw**, Miles City Field Office, BLM. Started on Forest Service land 35 miles northwest of Broadus, MT. Timber, brush and short grass. Moderate fire behavior with creeping and smoldering. Structures and sage-grouse habitat threatened.

**Brush Flat**, Miles City Field Office, BLM. Started on private land 14 miles south of Birney, MT. Timber, brush and short grass. Extreme fire behavior with wind-driven runs, isolated torching and smoldering. Structures and sage-grouse habitat threatened. Reduction in acreage due to more accurate mapping.

**Tidwell**, Miles City Field Office, BLM. Started on private land 27 miles east of Decker, MT. Timber, brush and short grass. Active fire behavior with isolated torching, creeping and smoldering. Sage-grouse habitat threatened.

**Conrow**, Beaverhead - Deerlodge NF. Started on county land seven miles northeast of Whitehall, MT. Timber, brush and tall grass. Minimal fire behavior with smoldering, backing and creeping.

\* **West Fork**, Kootenai NF. IMT 2 (Esperance). Seven miles northwest of Libby, MT. Timber. Moderate fire behavior with group torching, uphill runs and spotting. Road, trail and area closures in effect.

**Wolverine**, Blackfeet Agency, BIA. Ten miles northeast of St. Mary, MT. Timber, brush and short grass. Minimal fire behavior with smoldering. Structures threatened.

**Ditch Creek**, Helena – Lewis and Clark NF. Twenty-seven miles northwest of White Sulphur Springs, MT. Timber. Minimal fire behavior.

**Blue Bay**, Flathead Agency, BIA. Ten miles northeast of Polson, MT. Timber. Minimal fire behavior with single-tree torching, creeping and smoldering. Road, trail and area closures in effect.

**Nelson Creek**, Bitterroot NF. Sixteen miles southwest of Conner, MT. Timber. Moderate fire behavior with single-tree torching, short-range spotting and backing. Road and trail closures in effect.

**Upper Midway**, Flathead Agency, BIA. Three miles southwest of St. Ignatius, MT. Timber and grass. Minimal fire behavior with smoldering.

**Cold Smoke**, Charles M. Russell National Wildlife Refuge. Thirty-five miles south of Glasgow, MT. Timber and short grass. Moderate fire behavior with isolated torching and short crown runs.

**McCully**, Northwestern Land Office, Montana DNR. Seventeen miles northeast of Thompson Falls, MT. Timber. Extreme fire behavior with running, torching and spotting. Road closures in effect.

\* **Hawk Ridge**, Northern Cheyenne Agency, BIA. Sixteen miles west of Lame Deer, MT. Timber and short grass. Extreme fire behavior with wind-driven runs, isolated torching and spotting.

\* **Black**, Flathead Agency, BIA. Thirteen miles northwest of Seeley Lake, MT. Timber, brush and short grass. Minimal fire behavior with isolated torching, creeping and smoldering. Last report unless significant activity occurs.

**Painted Hill**, Northern Cheyenne Agency, BIA. Eight miles west of Lame Deer, MT. Timber and short grass. Minimal fire behavior.

**Jolly Mountain, Okanogan - Wenatchee NF. IMT 2 (Roide).** Thirteen miles northwest of Cle Elum, WA. Timber. Extreme fire behavior with crowning and backing. Structures threatened. Evacuations, road, trail and area closures in effect.

**Chetco Bar**, Rogue River - Siskiyou NF. Area Command Team (Muir), IMT 1 (Livingston) and IMT 2 (Sheldon). Sixteen miles west of Selma, OR. Timber and brush. Extreme fire behavior with group torching, short crown runs and spotting. Structures threatened. Evacuations, road, trail and area closures in effect.

**Horse Prairie**, Central Unit, Oregon Department of Forestry. ODF IMT 1 (Smith). Fifteen miles northwest of Canyonville, OR. Timber. Active fire behavior with uphill runs and backing. Residences threatened. Evacuations, road and area closures in effect.

**Umpqua North Complex**, (8 fires), Umpqua NF. IMT 1 (J. Kurth). Fifty miles east of Roseburg, OR. Timber, brush and grass. Active fire behavior with uphill runs, single-tree torching and backing. Structures threatened. Evacuations, road, trail and area closures in effect.

**Miller Complex**, (3 fires), Rogue River - Siskiyou NF. IMT 1 (Pechota). Seventeen miles east of Cave Junction, OR. Timber. Active fire behavior with short crown runs, torching and short-range spotting. Structures threatened. Evacuations, road, trail and area closures in effect.

**Jones**, Willamette NF. IMT 2 (Harrod). Ten miles northeast of Lowell, OR. Timber and grass. Moderate fire behavior with uphill runs, single-tree torching and backing. Structures threatened. Road, trail and area closures in effect.

**Norse Peak**, Okanogan - Wenatchee NF. Florida IMT 2 (Dolan). IMT is also managing the American fire. Eleven miles west of Cliffdell, WA. Timber. Active fire behavior with flanking and backing. Residences threatened. Road, trail and area closures in effect.

**American**, Okanogan - Wenatchee NF. Eleven miles west of Cliffdell, WA. Timber. Moderate fire behavior with flanking and backing. Residences threatened. Road, trail and area closures in effect.

**Milli**, Deschutes NF. IMT 2 (Johnson). IMT is also managing the Nash fire. Nine miles west of Sisters, OR. Timber. Active fire behavior with running, flanking and backing. Residences threatened. Road, trail and area closures in effect. Reduction in acreage due to more accurate mapping.

**Nash**, Willamette NF. Previously reported incident. Six miles north of Elk Lake, OR. Timber. Active fire behavior with wind-driven runs, torching and spotting. Structures threatened. Road and trail closures in effect.

**Whitewater**, Willamette NF. IMT 1 (Day). IMT is also managing the Rebel fire and Horse Creek Complex. Ten miles east of Idanha, OR. Timber and brush. Active fire behavior with isolated torching, flanking and backing. Structures threatened. Road, trail and area closures in effect.

**Rebel**, Willamette NF. Twenty-two miles north of Oakridge, OR. Timber. Active fire behavior with torching, flanking and backing. Road, trail and area closures in effect.

**Horse Creek Complex**, (4 fires), Willamette NF. Seven miles south of Belknap Springs, OR. Timber. Active fire behavior with group torching, flanking and crowning. Structures threatened. Evacuations, road, trail and area closures in effect.

**High Cascades Complex**, (6 fires), Rogue River - Siskiyou NF. IMT 2 (Knerr). Nine miles northeast of Prospect, OR. Timber. Active fire behavior with short crown runs, short-range spotting and group torching. Structures threatened. Road, trail and area closures in effect.

**Uno**, Okanogan-Wenatchee NF. IMT 2 (Ciraulo). Sixteen miles northwest of Manson, WA. Timber. Active fire behavior with running and spotting. Residences threatened. Road, trail and area closures in effect.

**Bridge Creek**, Colville Agency, BIA. IMT 2 (Rabe). Eleven miles northeast of Keller, WA. Timber and tall grass. Active fire behavior with backing, flanking and torching. Road, trail and area closures in effect.

**Staley**, Willamette NF. IMT 2 (Goff). Twenty-three miles south of Oakridge, OR. Timber and brush. Moderate fire behavior with backing and flanking. Road, trail and area closures in effect.

**North Pelican**, Fremont – Winema NF. Twenty-five miles northwest of Klamath Falls, OR. Timber and brush. Moderate fire behavior with backing, short-range spotting and group torching. Residences threatened. Road, trail and area closures in effect.

**McKay**, Deschutes NF. Five miles northeast of La Pine, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Road, trail and area closures in effect.

**Falcon Complex**, (2 fires), Umpqua NF. Twenty-five miles east of Tiller, OR. Timber, brush and grass. No fire behavior received. Structures threatened. Road closures in effect.

**Jade Creek**, Lake Unit, Oregon Department of Forestry. IMT 2 (Sinclair). Sixteen miles east of Bly, OR. Timber. Moderate fire behavior with torching. Structures threatened. Road, trail and area closures in effect.

**Naylox**, Klamath Unit, Oregon Department of Forestry. Ten miles north of Klamath Falls, OR. Timber and brush. No new information.

**Predictive Services Discussion:** The high pressure ridge will become centered over the Four Corners, keeping the West hot and dry until afternoon convection begins. Low afternoon humidities will allow for the developing scattered storms to begin as mostly dry before moistening up in the late afternoon. The focus of the convection will be over Oregon, California and the Great Basin. A cold front will begin dropping south into the northern Great Plains from central Canada, bringing breezy winds and cooler temperatures to North Dakota and eastern Montana late in the day. Breezy northwesterly winds will extend east to the mid-Atlantic states by afternoon, as temperatures remain just below normal.

## AVIATION MISHAP RESPONSE

*Aviation Category*

Having a written mishap response action posted and accessible to all employees is an important first step. Having a list of actions to follow will ensure that nothing is missed in a stressful, time-critical period. Response plans have to be briefed to all on the crew.

- Immediate, positive action is necessary. Any delay may affect someone's chances of survival.
- Conduct rescue operations keeping the following priorities in mind:
  - Preserve life. Rescuers first!!!
  - Do whatever is necessary to extricate injured occupants and to extinguish fires, keeping in mind the necessity of protecting and preserving evidence.
  - Document and/or photograph the location of any debris that must be disturbed in order to carry out rescues and/or fire suppression activities.
  - Secure the area. Treat the crash site as a crime scene. Arrange for security at the accident scene if necessary. Determine if hazardous materials were on the aircraft. Deny access except to credentialed officials and escorted media.
- Be aware that crash sites can be dangerous due to hazardous cargo, flammable and toxic fluids, sharp objects, disease, adverse terrain, hot/cold weather conditions, and fire.
- Exercise good judgment, utilize available protective devices and clothing, and use extreme caution when working near the wreckage site.
- Do not exceed your physical limitations.
- **Activity:** *Review your unit's mishap response plan with the crew. Consider practicing with a crash rescue drill or scenario.*
