Area Command Team (Muir) is managing the Chetco Bar fire, Miller Complex and High Cascades Complex.

Eagle Creek, Columbia River Gorge National Scenic Area. IMT 1 (Pierson) and IMT 2 (Sheldon). One mile south of Cascade Locks, OR. Timber. Extreme fire behavior with crowning, wind-driven runs and long-range spotting. Structures threatened. Evacuations, road, trail and area closures in effect.

Indian Creek, Mt. Hood NF. Six miles south of Cascade Locks, OR. Timber. Active fire behavior.

Chetco Bar, Rogue River - Siskiyou NF. IMT 1 (Livingston) and IMT 2 (Gales). Sixteen miles west of Selma, OR. Timber and brush. Active fire behavior with torching, spotting and flanking. Structures threatened. Evacuations, road, trail and area closures in effect.

Jolly Mountain, Okanogan - Wenatchee NF. IMT 1 (Schulte). Thirteen miles northwest of Cle Elum, WA. Timber. Active fire behavior with uphill runs, torching and spotting. Structures threatened. Road, trail and area closures in effect.

Norse Peak, Okanogan - Wenatchee NF. Florida IMT 2 (Dolan) and IMT 2 (Arroyo). IMT is also managing the American fire. Eleven miles west of Cliffdell, WA. Timber. Active fire behavior with torching and running. Residences threatened. Road, trail and area closures in effect.

American, Okanogan - Wenatchee NF. Eleven miles west of Cliffdell, WA. Timber. Active fire behavior with single-tree torching and flanking. Residences threatened. Road, trail and area closures in effect.

Horse Creek Complex, (4 fires), Willamette NF. IMT 1 (Day). IMT is also managing the Whitewater, Rebel and Potato Hill fires. Seven miles south of Belknap Springs, OR. Timber. Extreme fire behavior with crowning, group torching and long-range spotting. Structures threatened. Evacuations, road, trail and area closures in effect.

Whitewater, Willamette NF. Ten miles east of Idanha, OR. Timber and brush. Moderate fire behavior with flanking, backing and torching. Structures threatened. Road, trail and area closures in effect.

Rebel, Willamette NF. Twenty-two miles north of Oakridge, OR. Timber. Moderate fire behavior with backing, flanking and torching. Road, trail and area closures in effect.

Potato Hill, Willamette NF. Twenty miles northwest of Sisters, OR. Timber. Minimal fire behavior. Structures threatened. Road and area closures in effect.

Umpqua North Complex, (8 fires), Umpqua NF. IMT 1 (J. Kurth). Fifty miles east of Roseburg, OR. Timber, brush and grass. Active fire behavior with uphill runs, group torching and backing. Structures threatened. Evacuations, road, trail and area closures in effect.

Horse Prairie, Central Unit, Oregon Department of Forestry. ODF IMT 1 (Smith). Fifteen miles northwest of Canyonville, OR. Timber. Active fire behavior with single-tree torching and spotting. Residences threatened. Evacuations, road and area closures in effect.

Miller Complex, (3 fires), Rogue River - Siskiyou NF. IMT 1 (Pechota). Seventeen miles east of Cave Junction, OR. Timber. Active fire behavior with group torching, crowning and spotting. Structures threatened. Evacuations, road, trail and area closures in effect.

High Cascades Complex, (4 fires), Rogue River - Siskiyou NF. IMT 2 (Knerr). Nine miles northeast of Prospect, OR. Timber. Extreme fire behavior with crowning and short-range spotting. Structures threatened. Road, trail and area closures in effect.

Nash, Willamette NF. Six miles north of Elk Lake, OR. IMT 2 (Johnson). IMT is also managing the Milli fire. Timber. Extreme fire behavior with running and spotting. Structures threatened. Trail closures in effect.

Milli, Deschutes NF. Nine miles west of Sisters, OR. Timber. Active fire behavior with flanking, backing and short-range spotting. Residences threatened. Road, trail and area closures in effect.

Uno Peak, Okanogan-Wenatchee NF. IMT 2 (Ciraulo). Sixteen miles northwest of Manson, WA. Timber. Active fire behavior with torching, flanking and backing. Structures threatened. Road, trail and area closures in effect.

Jones, Willamette NF. IMT 2 (Harrod). IMT is also managing the Staley fire. Ten miles northeast of Lowell, OR. Timber and grass. Active fire behavior with uphill runs, group torching and spotting. Structures threatened. Road, trail and area closures in effect.

Staley, Willamette NF. Twenty-three miles south of Oakridge, OR. Timber and brush. Minimal fire behavior. Road, trail and area closures in effect.

Jade Creek, Lake Unit, Oregon Department of Forestry. IMT 2 (Sinclair). Sixteen miles east of Bly, OR. Timber. Minimal fire behavior. Road closures in effect.

Bridge Creek, Colville Agency, BIA. IMT 2 (Rabe). Eleven miles northeast of Keller, WA. Timber and tall grass. Moderate fire behavior with smoldering, creeping and isolated torching. Road, trail and area closures in effect.

North Pelican, Fremont – Winema NF. Twenty-five miles northwest of Klamath Falls, OR. Timber and brush. Moderate fire behavior with backing, flanking and single-tree torching. Residences threatened. Road, trail and area closures in effect.

McKay, Deschutes NF. Five miles northeast of La Pine, OR. Timber and brush. Minimal fire behavior.

Falcon Complex, (2 fires), Umpqua NF. Twenty-five miles east of Tiller, OR. Timber, brush and grass. Minimal fire behavior. Structures threatened. Road closures in effect.

East Crater, Gifford Pinchot NF. Ten miles northwest of Trout Lake, WA. Timber and grass. No new information.

Diamond Creek, Okanogan - Wenatchee NF. Previously reported incident. Twenty-seven miles north of Winthrop, WA. Timber. Extreme fire behavior with short crown runs, group torching and spotting. Structures threatened. Road, trail and area closures in effect. Last report unless significant activity occurs.

Area Command Team (Stutler) is managing large fires on the Lolo National Forest and Flathead Reservation.

Caribou, Kootenai NF. IMT 2 (Pearson). IMT is also managing the Gibraltar Ridge fire. Twenty-one miles northwest of Eureka, MT. Timber. Active fire behavior with group torching and backing. Structures threatened. Road, trail and area closures in effect.

Gibraltar Ridge, Kootenai NF. Seven miles east of Eureka, MT. Timber and grass. Moderate fire behavior. Residences threatened. Road, trail and area closures in effect.

Rice Ridge, Lolo NF. IMT 1 (Poncin). IMT is also managing the Liberty fire. Six miles north of Seeley Lake, MT. Timber. Active fire behavior with flanking, running and spotting. Structures threatened. Evacuations, road, trail and area closures in effect.

Liberty, Flathead Agency, BIA. Seventeen miles southeast of Arlee, MT. Timber. Active fire behavior with short-range spotting, backing and group torching. Road, trail and area closures in effect.

Highway 200 Complex, (5 fires), Lolo NF. IMT 2 (Connell). IMT is also managing the Sunrise fire. Nine miles northwest of Plains, MT. Timber. Moderate fire behavior with torching and spotting. Residences threatened. Road and area closures in effect.

Sunrise, Lolo NF. Eleven miles east of Superior, MT. Timber and brush. Active fire behavior with creeping, backing and single-tree torching. Residences threatened. Trail and area closures in effect.

West Fork, Kootenai NF. IMT 2 (Esperance). IMT is also managing the Moose Peak fire. Seven miles northwest of Libby, MT. Timber. Active fire behavior with running, crowning and long-range spotting. Structures threatened. Evacuations, road, trail and area closures in effect.

Moose Peak, Kootenai NF. Thirteen miles east of Trout Creek, MT. Timber. Active fire behavior with uphill runs, group torching and long-range spotting. Structures threatened. Evacuations and road closures in effect.

Sprague, Glacier National Park. IMT 2 (Hutton). IMT is also managing the Adair Peak fire. Nine miles northeast of West Glacier, MT. Timber. Active fire behavior with flanking, crowning and spotting. Structures threatened. Road, trail and area closures in effect.

Adair Peak, Glacier National Park. Eighteen miles north of West Glacier, MT. Timber. Moderate fire behavior with torching and creeping. Structures threatened. Road, trail and area closures in effect.

Lolo Peak, Lolo NF. IMT 1 (Turman). Ten miles southwest of Lolo, MT. Timber. Active fire behavior with group torching, spotting and backing. Structures threatened. Road, trail and area closures in effect.

Meyers, Beaverhead - Deerlodge NF. Transfer of command from IMT 2 (Leach) to IMT 1 (Dueitt) will occur tomorrow. Twenty-five miles southwest of Philipsburg, MT. Timber. Active fire behavior with flanking, backing and isolated torching. Structures threatened. Road and area closures in effect.

Alice Creek, Helena – Lewis and Clark NF. IMT 2 (Bird). Fifteen miles northeast of Lincoln, MT. Timber and short grass. Active fire behavior with torching and short-range spotting. Residences threatened. Evacuations, road, trail and area closures in effect.

Sapphire Complex, (3 fires), Lolo NF. IMT 2 (Almas). Fifteen miles southeast of Clinton, MT. Timber. Active fire behavior with creeping, flanking and backing. Structures threatened. Evacuations, road, trail and area closures in effect.

Strychnine, Ponderosa Area Office, IDL. Five miles northeast of Harvard, ID. Timber. Active fire behavior with single-tree torching, flanking and wind-driven runs. Structures threatened. Road, trail and area closures in effect. Reduction in acreage due to more accurate mapping.

Hanover, Nez Perce - Clearwater NF. Four miles northeast of Florence, ID. Timber, brush and grass. Moderate fire behavior with torching, creeping and backing. Structures threatened. Road, trail and area closures in effect. Last report unless significant activity occurs.

McCully, Northwestern Land Office, Montana DNR. Seventeen miles northeast of Thompson Falls, MT. Timber. Active fire behavior with creeping and smoldering. Road closures in effect.

East Fork, Rocky Boy's Agency, BIA. IMT 1 (Martin). Ten miles east of Box Elder, MT. Timber and tall grass. Minimal fire behavior. Residences threatened. Evacuations, road and area closures in effect.

Conrow, Beaverhead - Deerlodge NF. Started on county land seven miles northeast of Whitehall, MT. Timber, brush and tall grass. Minimal fire behavior.

Wolverine, Blackfeet Agency, BIA. Ten miles northeast of St. Mary, MT. Timber, brush and short grass. Minimal fire behavior. Structures threatened.

Blue Bay, Flathead Agency, BIA. Ten miles northeast of Polson, MT. Timber. Minimal fire behavior. Road, trail and area closures in effect.

Nelson Creek, Bitterroot NF. Sixteen miles southwest of Conner, MT. Timber. Moderate fire behavior with single-tree torching and backing. Road and trail closures in effect.

Painted Hill, Northern Cheyenne Agency, BIA. Eight miles west of Lame Deer, MT. Timber and short grass. Minimal fire behavior.

Crucifixion Creek, Helena – Lewis and Clark NF. Previously reported incident. Twenty-five miles west of Dupuyer, MT. Timber and short grass. Active fire behavior with short crown runs, torching and flanking. Structures threatened. Area closures in effect. Last report unless significant activity occurs.

Hidden, Nez Perce – Clearwater NF. Previously reported incident. Fourteen miles west of Pinesdale, MT. Timber and brush. Moderate fire behavior with backing, smoldering and creeping. Structures threatened. Trail closures in effect. Last report unless significant activity occurs.

Moose Creek 1, Nez Perce - Clearwater NF. Previously reported incident. Fifty miles east of Kooskia, ID. Timber and tall grass. Moderate fire behavior with flanking, creeping and backing. Residences threatened. Trail closures in effect. Last report unless significant activity occurs.

* **Red Butte**, Miles City Field Office, BLM. Started on private land 30 miles south of Miles City, MT. Timber, brush and short grass. Extreme fire behavior with running and short-range spotting. Structures and sage-grouse habitat threatened.

* **Andy's Hump**, Nez Perce - Clearwater NF. Twenty-four miles east of Kooskia, ID. Timber and short grass. Moderate fire behavior with torching. Structures threatened. Road, trail and area closures in effect. Last report unless significant activity occurs.

Predictive Services Discussion: Scattered wet storms will redevelop over the higher terrain across California, western Nevada and western Oregon as the remnants of Tropical Storm Lidia continues to move north just off shore, parallel to the Pacific Coast. While new initial attack is possible, higher humidities and patchy moisture might produce a net benefit to the pre-existing conditions. Temperatures further east across the inland West will remain well above normal as the upper level ridge and thermal trough remain firmly in place from Washington southeast to New Mexico. In the East, cooler than average conditions are expected as a large, elongated upper level trough lingers over the eastern half of the country.

MY SAFETY

Leadership Category

An important aspect of safety is individual responsibility for one's own health & safety. Even with the best supervision, each individual firefighter will occasionally be required to make personal decisions concerning their safety. It is important that individual responsibility be taught as the basis for a viable safety program. Some of those individual responsibilities are:

- Fitness for duty. Begin each work shift both mentally and physically prepared for the rigors of wildland firefighting. Getting adequate sleep, maintaining a healthy diet, and proactively participating in physical training are the foundation of "My Safety".
- Utilization of personal protective equipment. Wear your PPE without being told. Each individual is responsible for performing their own risk assessments. If a hazard is identified that can be mitigated by wearing a particular PPE component it should be utilized. Fireline supervisors have more important duties to focus on other than performing glove patrol.
- Following safe work practices. Using a spotter when backing up vehicles is the prudent and professional course of action. If you are unsure of how to perform a job task safely, ask your supervisor or experienced coworker.
- Using the correct reference materials is an important aspect of safety. You should have a working knowledge of the Red Book, IRPG, and your local operating guidelines.
- Ensure instructions are clearly understood. Communication is a basic responsibility for all fire personnel. Ask appropriate questions to clarify uncertain issues. Speak up when you observe hazards that may place yourself or others at risk.
- Maintain situational awareness at all times. Awareness is a vital component of "My Safety". Pay attention to what is happening around your area of operations. Always display an awareness of what is happening around you by asking questions or making comments.

Summary: Do not expect someone else to be responsible for your safety. Take it upon yourself to make "My Safety" your number one priority.
