Two hundred thirty-three soldiers from the 14<sup>th</sup> Brigade Engineer Battalion based out of Joint Base Lewis-McChord, Washington are deployed in support of the Mendocino Complex.

One hundred thirty-eight fireline management personnel from Australia and New Zealand are assigned to support large fires in the California and Northwest Areas.

Two MAFFS C-130 airtankers and support personnel from the 152nd Airlift Wing (Nevada Air National Guard), one from the 146th Airlift Wing (California Air National Guard) and one from the 302nd Airlift Wing (Colorado Springs, Air Force Reserve) have been deployed to McClellan Airfield, CA in support of wildland fire operations.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Spokane, WA in support of wildland fire operations in the West.

**Boysds**, Northeast Region, Washington DNR. IMT 2 (Rabe). Three miles west of Kettle Falls, WA. Timber and brush. Active fire behavior with backing, torching and spotting. Numerous structures, energy and communications infrastructure threatened. Evacuations in effect.

**Taylor Creek**, Medford District, BLM. IMT 1 (T. Kurth). IMT also managing the Klondike incident. Ten miles west of Grants Pass, OR. Timber and brush. Moderate fire behavior. Numerous structures and communication infrastructure threatened. Road, area and trail closures in effect.

**Klondike**, Rogue River-Siskiyou NF. IMT 1 (J. Kurth) mobilizing. Nine miles northwest of Selma, OR. Timber and chaparral. Active fire behavior with uphill runs, torching and spotting. Numerous residences threatened. Evacuations, road, area and trail closures in effect.

**Cougar Creek**, Okanogan/Wenatchee NF. IMT 1 (Livingston). IMT is also managing the Bannock Lakes incident. Twelve miles northwest of Ardenvoir, WA. Timber, medium logging slash and closed timber litter. Active fire behavior with uphill runs, flanking and backing. Numerous structures and energy infrastructure threatened. Road, area and trail closures in effect. Evacuations have been lifted.

**Bannock Lakes**, Okanogan/Wenatchee NF. Fourteen miles southwest of Stehekin, WA. Timber and brush. Minimal fire behavior. Trail closures in effect.

**Natchez**, Rogue River-Siskiyou NF. IMT 1 (Goicoechea). Fifteen miles southeast of Cave Junction, OR. Timber and chaparral. Active fire behavior with backing, torching and short-range spotting. Structures threatened. Evacuations, road, area and trail closures in effect.

**McLeod**, Okanogan/Wenatchee NF. IMT 1 (Dueitt). IMT 1 (Wilkins) mobilizing. IMT is also managing the Crescent Mountain incident. Eight miles north of Mazama, WA. Timber. Active fire behavior with flanking, spotting and running. Numerous residences and communication infrastructure threatened.

**Crescent Mountain**, Okanogan/Wenatchee NF. Eighteen miles west of Winthrop, WA. Timber. Moderate fire behavior with torching, flanking, and short crown runs. Numerous residences threatened. Road, area and trail closures in effect.

**Horns Mountain**, Colville NF. IMT 2 (Goff). Nineteen miles north of Evans, WA. Timber and heavy logging slash. Moderate fire behavior with flanking, single tree torching and short-range spotting.

**Miles**, Umpqua NF. IMT 1 (Turman). IMT 1 (Schulte) on order. Unified Command between IMT 1 (Turman) and ODF IMT 1 (Smith). IMT is also managing the Columbus incident. Five miles northeast of Trail, OR. Timber. Active fire behavior with isolated torching, backing, and short-range spotting. Numerous structures, energy and communication infrastructure threatened. Evacuations, road, area and trail closures in effect.

**Columbus**, Umpqua NF. Fifteen miles east of Tiller, OR. Timber. Active fire behavior with isolated torching, short-range spotting and backing. Road and trail closures in effect.

**Miriam**, Okanogan/Wenatchee NF. IMT 2 (Johnson). Fifteen miles east of Packwood, WA. Timber and brush. Active fire behavior with uphill runs, regular torching and flanking. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

**Maple**, Olympic NF. IMT 2 (Lawson). Ten miles north of Hoodspport, WA. Timber. Moderate fire behavior with creeping, flanking and backing. Structures and communication infrastructure threatened. Road, area and trail closures in effect.

**Porcupine 2 0927 RN**, Prineville District, BLM. Started on private land nine miles east of Clarno, OR. Timber brush and grass. Minimal fire behavior.

**Hendrix**, Rogue River-Siskiyou NF. Nine miles southwest of Ashland, OR. Timber and medium logging slash. Minimal fire behavior. Road, area and trail closures in effect.

\* **Watson Creek**, Fremont-Winema NF. IMT 2 (Sheldon) mobilizing. Thirteen miles west of Paisley, OR. Timber and brush. Active fire behavior with short crown runs, group torching and long-range spotting. Structures threatened. Evacuations, road, area and trail closures in effect.

\* **Coyote Creek**, Vale District, BLM. Fifteen miles south of Jordan Valley, OR. Brush and grass. Active fire behavior with running. Sage-grouse habitat threatened.

**Howe Ridge**, Glacier National Park, NPS. IMT 1 (Pierson). IMT is also managing the Paola Ridge and Coal Ridge incidents. Ten miles north of West Glacier, MT. Timber. Active fire behavior with single tree torching, backing and spotting. Residences threatened. Evacuations, road, area and trail closures in effect.

**Paola Ridge**, Flathead NF. Three miles northwest of Essex, MT. Timber and brush. Moderate fire behavior with group torching, uphill runs and flanking. Numerous structures threatened. Road, area and trail closures in effect.

**Coal Ridge**, Flathead NF. Twenty-eight miles north of Kalispell, MT. Timber and brush. Moderate fire behavior with single tree torching, flanking and backing. Structures threatened. Road, area and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Wigwam**, Beaverhead/Deerlodge NF. IMT 2 (Wakoski). IMT is also managing the Monument incident. Fifteen miles southwest of Ennis, MT. Timber. Extreme fire behavior with wind-driven runs, group torching and spotting. Numerous residences and sage-grouse habitat threatened. Evacuations in effect.

**Monument**, Beaverhead/Deerlodge NF. Forty-two miles southwest of Ennis, MT. Timber. Active fire behavior with wind-driven runs, group torching and spotting. Structures threatened. Road, area and trail closures in effect.

**Rattlesnake Creek**, Nez Perce-Clearwater NF. IMT 2 (Sinclair). IMT 1 (Day) mobilizing. Five miles southwest of Riggins, ID. Timber and short grass. Active fire behavior with uphill runs, group torching and short-range spotting. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

**Goldstone**, Beaverhead/Deerlodge NF. IMT 2 (Millert). Twelve miles south of Jackson, MT. Timber. Active fire behavior with torching and spotting. Structures threatened. Road, area and trail closures in effect.

**Beaver Creek**, Beaverhead/Deerlodge NF. Previously reported incident. Eighteen miles north west of Wisdom, MT. Timber. Active fire behavior with backing, spotting and short crown runs. Structures threatened. Road, area and trail closures in effect. Last narrative report unless significant activity occurs.

**Sterling Complex**, (2 fires). Kootenai NF. Transfer of command from IMT 2 (Connell) to IMT 2 (Bird) will occur today. IMT is also managing the Tenmile incident. Eighteen miles south of Eureka, MT. Timber and brush. Moderate fire behavior with backing, torching and short-range spotting. Numerous structures and communication infrastructure threatened. Road, area and trail closures in effect.

**Tenmile**, Kootenai NF. Nineteen miles south of Eureka, MT. Timber. Minimal fire behavior. Road, area and trail closures in effect.

**Shellrock**, Central Land Office, Montana DNRC. Twenty-five miles north of Helena, MT. Timber and grass. Active fire behavior with group torching and spotting. Structures and energy infrastructure threatened. Area closures in effect.

**Surprise Creek**, Idaho Panhandle NF. IMT 2 (Sampson). IMT is also managing the Cougar incident. Eighteen miles east of Athol, ID. Timber. Moderate fire behavior with torching and short-range spotting. Road, area and trail closures in effect.

**Cougar**, Idaho Panhandle NF. Five miles east of East Hope, ID. Timber and brush. Active fire behavior with uphill runs, torching and flanking. Structures and communication infrastructure threatened. Road, area and trail closures in effect.

**Davis**, Kootenai NF. IMT 2 (Almas). Ten miles northwest of Yaak, MT. Timber. Moderate fire behavior with short-range spotting, creeping and isolated torching. Structures threatened. Road, area and trail closures in effect.

**Rampike**, Idaho Panhandle NF. Previously reported incident. Twenty-eight miles north of Wallace, ID. Timber and brush. Moderate fire behavior with uphill runs, flanking and backing. Road, area and trail closures in effect. Last narrative report unless significant activity occurs.

**Gold Hill**, Kootenai NF. Thirteen miles north of Libby, MT. Timber. Moderate fire behavior with creeping and backing.

**Garden Creek**, Flathead Agency, BIA. Two miles north of Ronan, MT. Timber and tall grass. Minimal fire behavior.

**Copper Mountain**, Idaho Panhandle NF. Four miles east of Eastport, ID. Timber. Minimal fire behavior.

**Predictive Services Discussion:** A strong disturbance will move on shore and into the Pacific Northwest by afternoon. The advancing system will pull monsoonal moisture north across the Great Basin through Idaho and Montana and into south central Canada. Storms will be scattered in coverage and should be generally wet. Breezy winds will be possible along the southern edge of the system across northwestern Nevada and northeastern California. To the south, expect scattered wet storms to redevelop over the Four Corners region. Temperatures across the West will be above average except across Washington where they will be near-average. Texas will remain hot and dry...though the panhandle could see scattered wet convection during the afternoon hours. Another system moving east across the Great Lakes region and the Mississippi River Valley will bring showers and storms to the East Coast.

## Nomex®

*Firefighter Health & First Aid*

Nomexfi is the brand name for a **heat and flame-resistant** textile made by the DuPont chemical company and first marketed in 1967. Today, more than three million firefighters and aviation personnel around the world are protected by structure fire turnout gear, wildland fire PPE, and flight suits and jackets made of Nomexfi .

Nomexfi IS NOT flame-proof. It burns when you hold a flame to it, but stops burning once the heat source is removed. The thick woven structure of synthetic fibers is a very poor conductor of heat. When exposed to heat, the fibers expand closing the spaces between them insulating the wearer. But to work correctly, Nomexfi needs care.

### Dirty Nomex®

- Wash Nomexfi like normal laundry, but always include a rinse cycle that adequately removes soaps and detergents.
- Nomexfi garments should never be subjected to strong oxidizing agents such as peroxides or bleaches. These harm the physical strength of the fabric.
- Tumble-dry and remove while slightly damp. Over-drying damages the fabric.

**Poison Oak/Ivy/Sumac on Nomex®** - MTDC researched the laundering of Nomex® firefighting clothing that has been contaminated with urushiol oil (what causes the rash) from poison oak/ivy/sumac exposure.

- MTDC recommends that fire clothing contaminated with urushiol oil be cleaned following normal Nomexfi laundering procedures, with a degreaser such as a detergent or laundry soap, and as soon as possible.
- Extra care should be exercised when handling the contaminated clothing and should be kept separate from unaffected clothing and equipment.
- Put the affected clothing in a marked bag if you are giving it to someone else to wash. Before handling the affected clothing, apply a skin-barrier product such as Ivy Block or Technufi .

**Fuel Soaked Nomex®** - Flammable contaminants will reduce the thermal performance of any flame-resistant garment including Nomex®.

- Proper and periodic cleaning is essential to maintain thermal protective performance.

**Action Item – Nomexfi is not effective if it is excessively dirty, fuel-soaked, or has holes. Does your Nomexfi need to be washed, repaired or replaced?**
