**Crescent Mountain**, Okanogan-Wenatchee NF. IMT 1 (Turman). IMT is also managing the McLeod and Holman incidents. Eighteen miles west of Winthrop, WA. Timber. Active fire behavior with backing, creeping and flanking. Numerous residences threatened. Evacuations, road, area and trail closures in effect.

**McLeod**, Okanogan-Wenatchee NF. Eight miles north of Mazama, WA. Timber. Moderate fire behavior with isolated torching, backing and flanking. Road, area and trail closures in effect.

**Holman**, Okanogan-Wenatchee NF. Nineteen miles northwest of Mazama, WA. Timber. Minimal fire behavior. Structures and communication infrastructure threatened. Road, area and trail closures in effect.

**Klondike**, Rogue River-Siskiyou NF. IMT 1 (Dueitt). Nine miles northwest of Selma, OR. Timber and brush. Moderate fire behavior with backing and torching. Residences threatened. Road, area and trail closures in effect.

**Terwilliger**, Willamette NF. IMT 2 (Connell). Five miles southeast of Blue River, OR. Timber. Active fire behavior with backing, torching and short-range spotting. Numerous structures threatened. Road, area and trail closures in effect.

**Natchez**, Rogue River-Siskiyou NF. IMT 2 (Knerr). Fifteen miles southeast of Cave Junction, OR. Timber and chaparral. Active fire behavior with uphill runs, spotting and backing. Numerous structures threatened. Road, area and trail closures in effect.

**Cougar Creek**, Okanogan-Wenatchee NF. IMT 2 (Lawson). IMT is also managing the Bannock Lakes incident. Twelve miles northwest of Ardenvoir, WA. Timber, medium logging slash and closed timber litter. Active fire behavior with torching, short crown runs and flanking. Road, area and trail closures in effect.

**Bannock Lakes**, Okanogan-Wenatchee NF. Fourteen miles southwest of Stehekin, WA. Timber and brush. Minimal fire behavior. Trail closures in effect.

**Miles**, Umpqua NF. Five miles northeast of Trail, OR. Timber. Active fire behavior with group torching, creeping and spotting. Road, area and trail closures in effect.

**Watson Creek**, Fremont-Winema NF. Thirteen miles west of Paisley, OR. Timber and brush. Minimal fire behavior. Numerous structures threatened. Road, area and trail closures in effect. Evacuations have been lifted.

**Taylor Creek**, Medford District, BLM. Ten miles west of Grants Pass, OR. Timber and brush. Minimal fire behavior. Numerous structures threatened. Road, area and trail closures in effect.

**Hendrix**, Rogue River-Siskiyou NF. Previously reported incident. Nine miles southwest of Ashland, OR. Timber and medium logging slash. Minimal fire behavior. Road, area and trail closures in effect.

**Delta**, Shasta-Trinity NF. IMT 1 (Young). IMT is also managing the Hirz incident. Two miles north of Lakehead, CA. Timber and brush. Extreme fire behavior with running and long-range spotting. Numerous structures and energy, communication and railroad infrastructure threatened. Evacuations, road and area closures in effect.

**Hirz**, Shasta-Trinity NF. Eleven miles east of Lakehead, CA. Timber and chaparral. Moderate fire behavior with creeping, backing and smoldering. Structures and energy and communication infrastructure threatened. Evacuations, road, area and trail closures in effect.

**Kerlin**, Shasta-Trinity NF. IMT 2 (Dalrymple). Eleven miles north of Mad River, CA. Timber. Active fire behavior with short crown runs, spotting and backing. Numerous residences threatened. Evacuations and road closures in effect. Reduction in acreage due to more accurate mapping.

**North**, Tahoe NF. IMT 2 (Coots). Nine miles northeast of Alta, CA. Timber, brush and medium logging slash. Moderate fire behavior with flanking, single tree torching and short-range spotting. Structures threatened. Road and trail closures in effect.

**Mendocino Complex**, Mendocino Unit, Cal Fire. IMT 2 (Wakoski). Five miles south of Potter Valley, CA. Brush, hardwood slash and tall grass. Moderate fire behavior with backing, flanking and isolated torching. Road, area and trail closures in effect.

**Boot**, Humboldt-Toiyabe NF. IMT 2 (Bird). Nine miles southwest of Walker, CA. Timber and brush. Extreme fire behavior with crowning, long-range spotting and uphill runs. Numerous structures and communication and energy infrastructure threatened. Evacuations, road, area and trail closures in effect.

**Stewart Creek**, Sawtooth NF. IMT 2 (Goldman). Eighteen miles northwest of Fairfield, ID. Timber. Active fire behavior with uphill runs, torching and backing. Structures, communication infrastructure and sage-grouse habitat threatened. Road, area and trail closures in effect.

**Rabbit Foot**, Salmon-Challis NF. IMT 2 (Roide). Fourteen miles southwest of Salmon, ID. Timber. Moderate fire behavior with flanking, backing and single tree torching. Road, area and trail closures in effect.

**Goshute Cave**, Ely District Office, BLM. IMT 2 (Fry). Fifty-five miles north of Ely, NV. Timber, hardwood slash and dormant brush. Moderate fire behavior with single tree torching, creeping and short-range spotting. Structures and sage-grouse habitat threatened.

**Bender Mountain**, Vernal Field Office, BLM. Seventeen miles northwest of Dutch John, UT. Timber, brush and short grass. Minimal fire behavior. Structures, energy infrastructure and sage-grouse habitat threatened.

**Gance**, Humboldt-Toiyabe NF. Fifty miles north of Elko, NV. Brush and short grass. Minimal fire behavior.

**Tervels**, Northeast Area, Utah DOF. Two miles north of Echo, UT. Brush and short grass. Minimal fire behavior.

**Coal Hollow**, Manti-Lasal NF. Fifteen miles southeast of Spanish Fork, UT. Timber and brush. Minimal fire behavior. Energy and railroad infrastructure threatened. Road, area and trail closures in effect.

**South Sugarloaf**, Elko County Fire Protection District. Twenty miles southwest of Owyhee, NV. Brush and grass. No new information.

**Howe Ridge**, Glacier National Park, NPS. IMT 1 (Goicoechea). IMT is also managing the Whale Butte, Boundary, Paola Ridge and Coal Ridge incidents. Ten miles north of West Glacier, MT. Timber. Moderate fire behavior with backing, flanking and creeping. Structures threatened. Evacuations, road, area and trail closures in effect.

**Whale Butte**, Flathead NF. Forty-five miles north of Kalispell, MT. Timber. Minimal fire behavior. Numerous structures threatened. Area closures in effect.

**Boundary**, Glacier National Park, NPS. Forty-two miles northeast of Whitefish, MT. Timber. Moderate fire behavior with flanking, backing and isolated torching. Structures threatened. Trail and area closures in effect.

**Predictive Services Discussion:** The upper level trough will move into the Pacific Northwest as a surface cold front moves east across Montana and Idaho. This will lead to scattered showers and storms across both the Pacific Northwest and possibly into the Northern Rockies. Breezy southwesterly winds may be a concern across Northern California and the Great Basin. Hot conditions are expected across Southern California as high pressure off shore begins to move east toward the coast. To the south, the monsoonal flow over New Mexico and Colorado will begin to show signs of weakening as less convection develops. The very hot and humid ridge of high pressure over the East will remain in place over the Ohio River Valley.

## Ash Pit Hazards

*Miscellaneous Fireline Hazards*

Ash pits are an inherent and hidden risk to wildland firefighters that can cause severe burns and injuries. Ash pits are created when a ground fire consumes underground fuels creating an empty space that is imperceptible from the surface.

- Environmental factors that increase the risk of ash pit formation after a wildfire:
  - Extensive root systems of trees and shrubs.
  - Deep duff or peat, the organic layer covering mineral soil.
  - Landscapes that have once been cultivated or manipulated by heavy equipment, old dozer piles, sawmills, timber sale yards or decking areas.
  - Small rodent holes that have become filled with decadent combustible debris, beaver holes near dams and stream beds, badger and coyote dens.
  - White ash is sometimes an indicator of ash pits as are swarms of hovering insects.
  - With the sun behind the suspected ash pit, look for small nearly translucent smokes that dissipate quickly above the ground.
  - Ash pits often give off the smell of incomplete combustion or of creosote burning.
- Mitigation measures to consider:
  - Identification of high risk landscape.
  - Identify and flag all hazardous discovered ash pits.
