**Delta**, Shasta-Trinity NF. Transfer of command from IMT 1 (Young) to IMT 1 (J. Kurth) will occur today. IMT is also managing the Hirz incident. Two miles north of Lakehead, CA. Timber and brush. Active fire behavior with running, backing and spotting. Numerous structures and energy, communication and railroad infrastructure threatened. Evacuations, road, area and trail closures in effect.

**Hirz**, Shasta-Trinity NF. Eleven miles east of Lakehead, CA. Timber, chaparral and tall grass. Minimal fire behavior. Road, area and trail closures in effect.

**Kerlin**, Shasta-Trinity NF. IMT 2 (Dalrymple). Eleven miles north of Mad River, CA. Timber. Minimal fire behavior. Numerous residences threatened. Road closures in effect. Evacuations have been lifted.

**North**, Tahoe NF. IMT 2 (Coots). Nine miles northeast of Alta, CA. Timber and brush. Minimal fire behavior. Structures threatened. Road closures in effect. Reduction in acreage due to more accurate mapping.

**Mendocino Complex**, Mendocino Unit, Cal Fire. IMT 2 (Wakoski). Five miles south of Potter Valley, CA. Timber, chaparral and tall grass. Minimal fire behavior. Road, area and trail closures in effect.

**Snell**, Sonoma-Lake Napa Unit, Cal Fire. Twelve miles east of Middletown, CA. Brush and tall grass. Active fire behavior with uphill runs, single tree torching and flanking. Numerous residences threatened. Evacuations in effect.

**Crescent Mountain**, Okanogan-Wenatchee NF. Transfer of command from IMT 1 (Turman) to IMT 1 (Schulte) will occur on 9/12. IMT is also managing the McLeod and Holman incidents. Eighteen miles west of Winthrop, WA. Timber. Moderate fire behavior with backing, creeping and flanking. Road, area and trail closures in effect. Evacuations have been lifted

**McLeod**, Okanogan-Wenatchee NF. Six miles north of Mazama, WA. Timber. Moderate fire behavior with isolated torching, backing and creeping. Road, area and trail closures in effect.

**Holman**, Okanogan-Wenatchee NF. Nineteen miles northwest of Mazama, WA. Timber. Minimal fire behavior. Structures and communication infrastructure threatened. Road, area and trail closures in effect.

**Klondike**, Rogue River-Siskiyou NF. IMT 1 (Dueitt). Nine miles northwest of Selma, OR. Timber and brush. Moderate fire behavior with backing, isolated torching and uphill runs. Residences threatened. Road, area and trail closures in effect.

**Terwilliger**, Willamette NF. Transfer of command from IMT 2 (Connell) to IMT 2 (Johnson) will occur on 9/12. Five miles southeast of Blue River, OR. Timber, hardwood litter and closed timber litter. Moderate fire behavior with flanking, backing and creeping. Numerous structures threatened. Road, area and trail closures in effect.

**Natchez**, Rogue River-Siskiyou NF. IMT 2 (Knerr). Fifteen miles southeast of Cave Junction, OR. Timber, brush and hardwood litter. Active fire behavior with uphill runs, spotting and backing. Numerous structures threatened. Road, area and trail closures in effect.

**Cougar Creek**, Okanogan-Wenatchee NF. Transfer of command from IMT 2 (Lawson) back to the local unit will occur tomorrow. IMT is also managing the Bannock Lakes incident. Twelve miles northwest of Ardenvoir, WA. Timber, brush and short grass. Active fire behavior with torching, short crown runs and flanking. Road, area and trail closures in effect.

**Bannock Lakes**, Okanogan-Wenatchee NF. Fourteen miles southwest of Stehekin, WA. Timber and brush. Minimal fire behavior. Trail closures in effect.

**Wahlake Slope**, Mid-Columbia Wildlife Refuge, FWS. Fifteen miles southwest of Othello, WA. Brush and short grass. Minimal fire behavior. Railroad infrastructure threatened.

**Tepee 1144 NE**, Deschutes NF. Fifteen miles southeast of Bend, OR. Timber, brush and short grass. Moderate fire behavior with creeping and smoldering. Structures threatened. Road, area and trail closures in effect.

**Willow 1145 RN**, Prineville District, BLM. Three miles east of Madras, OR. Chaparral, brush, and tall grass. Moderate fire behavior with isolated torching, backing and creeping. Structures threatened. Road and area closures in effect.

**Glade Creek**, Washington State. Seven miles southeast of Mabton, WA. Brush and tall grass. Active fire behavior with running and spotting. Residences threatened.

**Miles**, Umpqua NF. Five miles northeast of Trail, OR. Timber. Active fire behavior with group torching, creeping and spotting. Structures threatened. Road, area and trail closures in effect.

**Boot**, Humboldt-Toiyabe NF. IMT 2 (Bird). Nine miles southwest of Walker, CA. Timber and brush. Active fire behavior with running and short-range spotting. Structures and communication and energy infrastructure threatened. Road, area and trail closures in effect.

**Stewart Creek**, Sawtooth NF. IMT 2 (Goldman). Eighteen miles northwest of Fairfield, ID. Timber and brush. Moderate fire behavior with wind-driven runs, torching and spotting. Structures, communication infrastructure and sage-grouse habitat threatened. Road, area and trail closures in effect.

**Rabbit Foot**, Salmon-Challis NF. IMT 2 (Roide). Fourteen miles southwest of Salmon, ID. Timber and short grass. Moderate fire behavior with group torching, short-range spotting and backing. Road, area and trail closures in effect.

**Arc**, Storey County Fire Department. Seventeen miles east of Reno, NV. Brush and tall grass. Minimal fire behavior. Energy infrastructure threatened.

**Goshute Cave**, Ely District Office, BLM. Fifty-five miles north of Ely, NV. Timber, brush and short grass. Moderate fire behavior with single tree torching, creeping and short-range spotting. Sage-grouse habitat threatened. Last narrative report unless significant activity occurs.

**Bender Mountain**, Vernal Field Office, BLM. Seventeen miles northwest of Dutch John, UT. Timber. Active fire behavior with group torching, smoldering and creeping. Structures, energy infrastructure and sage-grouse habitat threatened.

**Coal Hollow**, Manti-Lasal NF. Fifteen miles southeast of Spanish Fork, UT. Timber. Minimal fire behavior. Energy and railroad infrastructure threatened. Road, area and trail closures in effect. Last report unless significant activity occurs.

Moderate fire behavior with backing, flanking and single tree torching. Structures threatened. Evacuations, road, area and trail closures in effect.

**Whale Butte**, Flathead NF. Forty-five miles north of Kalispell, MT. Timber and brush. Minimal fire behavior. Numerous structures threatened. Area closures in effect.

**Predictive Services Discussion:** The very flat ridge of high pressure will move east toward the Great Plains, taking residual monsoonal moisture with it to create isolated storms in the afternoon with the daytime heating. Meanwhile to the west, a cooling trend will develop, as a strong but weakening low pressure area drops south from the Gulf of Alaska. Breezy winds will be a concern across Oregon, northern California, and Idaho as the system approaches. However, lower afternoon temperatures should translate to overall higher humidity in the afternoon. Scattered showers will be possible in the Washington Cascades and the Okanogan. A passing Alberta Clipper will bring showers to the western portion of the Great Lakes Region, while a slow-moving cold front will produce rain along the Atlantic and Gulf Coasts.

# Firefighter Mental Illness/Suicide

Firefighter Health & First Aid Category

Mental health is an often neglected part of firefighter safety, even as the number of reported firefighter deaths by suicide has been on the rise. Suicidal thoughts and other symptoms of depression, post-traumatic stress, and other mood disorders are not signs of weakness; rather, they are indicators of a medical condition that requires attention and treatment. Awareness, knowledge, and action can mitigate emotional suffering and reduce the risk of suicide among firefighters. One life lost is too many.

### Risk Factors

- Sleep deprivation
- Heavy alcohol or drug use
- Witnessing traumatic event(s)
- Major physical illness or injury
- Loss of a close relationship
- Isolation or lack of social support (e.g. off-season, retirement)
- Knowing others who have died by suicide



### Warning Signs

- Sudden withdrawal from social contact
- Persistent feeling of hopelessness
- Increasingly reckless behavior
- Mood swings/Change in behavior
- Having a suicide plan (time, place, method)

### What You Can Do

- **TAKE CARE OF YOURSELF AND OTHERS.** Monitor and manage mental health, just as you would physical health. Do not be afraid to ask for help and seek medical treatment. Thoughts of suicide can occur in anyone, it is not their fault but rather a need to treat a mental health issue.
- **TALK OPENLY AND ACTIVELY LISTEN.** Peer support goes a long way to protecting mental health. *Open communication is especially important for the survivors after a firefighter suicide occurs.* Listen actively, let someone who is seeking your help talk at their own pace and ask them open-ended questions.
- **SHOW COMPASSION:** Psychological risk is an undeniable part of the job. Be patient and supportive; do not judge or stigmatize firefighters experiencing a mental health challenge.
- **BE DIRECT.** If someone seems at risk or shows warning signs, ask "Are you thinking of suicide?" and "Do you have a plan?" Recognizing a potential suicide is critical to preventing it.
- **BE PROACTIVE:** If someone you know has a suicide plan, do not leave them alone. Remove any firearms or implements that could cause harm. Call 9-1-1 immediately.
