**Swan Lake**, Kenai Kodiak Area, Alaska DOF. IMT 1 (GB Team 1). IMT is also managing the Caribou Lake incident. Started on FWS land five miles northeast of Sterling, AK. Timber, brush and short grass. Active fire behavior with short crown runs, group torching and flanking. The communities of Sterling and Cooper Landing and numerous structures threatened. Area, road and trail closures in effect.

**Caribou Lake**, Kenai-Kodiak Area, Alaska DOF. Seven miles northwest of Fox River, AK. Heavy logging slash, timber and tall grass. Moderate fire behavior with spotting, backing and torching. Structures threatened.

**McKinley**, Mat-Su Area, Alaska DOF. IMT 2 (AK Green Team). Started on private land 18 miles north of Willow, AK. Timber and brush. Active fire behavior with backing, creeping and single tree torching. Numerous residences threatened. Area, road and trail closures in effect.

**Predictive Services Discussion:** An Alberta Clipper will drop southeast from southwestern Canada across Montana, bringing scattered showers and cooler temperatures to the Pacific Northwest and the Northern Rockies. High pressure over southwestern Oregon, California and Arizona will strengthen. Expect an upward trend in temperatures. Pressure gradients across northern California will line up to be north-to-south oriented; expect north winds to develop which will lead to lower humidities and poor overnight recoveries. Stormy conditions are expected across the nation's mid-section, as the Alberta Clipper draws moisture north from the Gulf of Mexico.

## What the SAFECOM system IS

The Aviation Safety CommuniquØ(SAFECOM) **AMD-34/FS-5700-14** should be used to report any condition, observation, act, maintenance problem, or circumstance with personnel or the aircraft that has the potential to cause an aviation-related mishap. SAFECOMS are a tool used to identify, document, track, and correct safety related issues.

## What the SAFECOM system IS NOT

- NOT intended for initiating punitive actions,
- NOT to be used as a complaint system or for personal attacks,
- NOT used by contracting officers for contract evaluations/award purposes,
- NOT a substitute for "on-the-spot" corrections to a safety concern, and
- does NOT replace the requirement for initiating an accident or incident report.

SAFECOMs provide the necessary feedback for development of the following communication tools:

- Accident Prevention Bulletins.
- Lessons Learned.
- Safety Alerts.
- Technical Bulletins.
- Airwards
- Information Sharing Memos.
- Maintenance Deficiencies (ADs, SBs, etc).
- Safety Trends.
- Training Needs.
