**Shovel Creek**, Fairbanks Area, Alaska DOF. IMT 1 (PNW Team 2). Twenty miles northwest of Fairbanks, AK. Timber and brush. Moderate fire behavior with backing, creeping and isolated torching. Numerous residences and communication infrastructure threatened. Evacuations, road and trail closures in effect.

**Swan Lake**, Kenai-Kodiak Area, Alaska DOF. IMT 2 (NW Team 13). Started on FWS land six miles northeast of Sterling, AK. Timber and short grass. Active fire behavior with spotting and group torching. Numerous residences and structures threatened. Area, road and trail closures in effect.

\* **Montana Creek**, Mat-Su Area, Alaska DOF. Started on private land 13 miles south of Talkeetna, AK. Timber. Minimal fire behavior with creeping, smoldering and torching. Residences threatened.

**Boundary River**, Tok Area, Alaska DOF. NIMO on order. Started on Native corporation land 37 miles southeast of Tok, AK. Timber and short grass. Extreme fire behavior with short-range spotting, group torching and backing. Residences threatened.

**Hess Creek**, Upper Yukon Zone, BLM. Started on state land 29 miles northeast of Steven s Village, AK. Timber and tall grass. Active fire behavior with single tree torching, wind-driven runs and backing. Residences and structures threatened. Last narrative report unless significant activity occurs.

**Caribou Creek**, Fairbanks Area, Alaska DOF. Twenty miles northeast of North Pole, AK. Timber and tall grass. Minimal fire behavior with smoldering. Residences threatened.

**Predictive Services Discussion:** The upper level low pressure area over the Pacific Northwest will continue to produce showers and wet storms across the Northern Rockies. On shore flow will keep humidities at noncritical levels along the West Coast. Isolated storms developing in the afternoon could spark an increase in initial attach across southeastern Oregon and northeastern California. Monsoonal flow over the Southwest will reach west from New Mexico into Arizona. Scattered storms are expected on the Mogollon Rim. High pressure over south central Alaska will remain very strong as it reaches northwest well into Siberia. Most of the state will continue to see very warm temperatures and low humidities, especially the western Interior. While convective activity is not expected to be a problem, the heat and dryness will be the challenge of the day.

## South Canyon 25 Years Ago Today

This Week of Remembrance is dedicated to all those who have fallen in the line of duty and is intended to serve as an opportunity to renew our commitment to the health, wellness, and safety of wildland firefighters.

On July 2, 1994, seven miles west of Glenwood Springs, Colorado, lightning ignited a Bureau of Land Management fire in piñon-pine and juniper on a ridge at the base of Storm King Mountain. The fire, paralleled by two deep canyons, was initially believed to have little chance to spread. The past two days, lightning had started 40 new fires on this BLM District. The entire general area, in a one-year drought, was experiencing low humidity and record-high temperatures. Over the next two days, the South Canyon Fire increased in size. Visible from Interstate 70 and nearby residential areas, the public becomes concerned. Some initial attack resources are assigned.

Four days later, on July 6, a dry cold front moved into the fire area. As winds and fire activity increased, the fire made several rapid runs within the existing burn in dense, highly flammable Gambel oak. 35 firefighters survived either by escaping down a deep drainage or by seeking a safety area and deploying their fire shelters. Fourteen firefighters perished as they tried to outrun the flames. They were just out doing normal work.

Today we mark the anniversary of this tragedy and honor through learning. Anniversaries of such events provide an opportunity for all of us to reflect on our mission and seek improvement.

The purpose of this week has been to honor all fallen firefighters by **making a commitment** that we will learn the lessons from those that walked the fireline before us, many of those lessons being learned the hard way and by those making the ultimate sacrifice.

**Action:** We encourage all fireline personnel, incident management, fire support staff, and program management to take a moment of remembrance, when/if appropriate, to reflect on, and discuss lessons we learned from this Week of Remembrance, and how we will apply those lessons.

Remembering those that lost their lives on Storm King Mountain 25 years ago today.
