NIMO (Houseman) has been assigned to COVID-19 support at Forest Service headquarters in Washington, D.C.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

One MAFFS C-130 airtanker and support personnel each from the 153rd Airlift Wing (Wyoming Air National Guard) and the 152<sup>nd</sup> Airlift Wing (Nevada Air National Guard), and two MAFFS C-130 airtankers and support personnel from the 146th Airlift Wing (California Air National Guard) have been deployed to support wildland fire operations in California.

**\* SCU Lightning Complex** (4 fires), Santa Clara Unit, Cal Fire. IMT 1 (Cal Fire Team 6). Five miles southwest of Brentwood, CA. Includes previously reported Deer, Arroyo, Canyon and 4-1 Marsh fires. Tall grass and chapparal. Extreme fire behavior with uphill runs and group torching. Numerous residences and energy infrastructure threatened. Area, road and trail closures in effect.

**\* Jones**, Nevada-Yuba-Placer Unit, Cal Fire. Three miles southeast of Birchville, CA. Timber, dormant brush and hardwood slash. Active fire behavior with uphill runs and spotting. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

**LNU Lightning Complex** (7 fires), Sonoma-Lake Napa Unit, Cal Fire. IMT 1 (Cal Fire Team 2) mobilizing. Two miles north of Barro, CA. Chapparal, tall grass and timber. Extreme fire behavior with long-range spotting, short-range spotting and single tree torching. Numerous structures, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Loyalton**, Tahoe NF, USFS. IMT 2 (CA Team 10). Four miles northeast of Loyalton, CA. Timber and tall grass. Extreme fire behavior with wind-driven runs, backing and isolated torching. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

**CZU Aug Lightning** (4 fires), San Mateo-Santa Cruz Unit, Cal Fire. Eight miles east of Pescadero, CA. Timber, brush, and closed timber litter. Active fire behavior with uphill runs, torching and long-range spotting. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

**\* BTU Light Complex 2020**, Butte Unit, Cal Fire. IMT 1 (Cal Fire Team 4) mobilizing. One mile northwest of Oroville, CA. Timber and heavy slash. Active fire behavior with wind-driven runs, uphill runs and backing. Numerous residences threatened.

**Red Salmon Complex** (2 fires), Six Rivers NF, USFS. IMT 1 (CA Team 4). Fourteen miles northeast of Willow Creek, CA. Timber, chaparral and short grass. Active fire behavior with uphill runs, flanking and torching. Area, road and trail closures in effect.

**August Complex** (3 fires), Mendocino NF, USFS. Fourteen miles northwest of Elk Creek, CA. IMT 2 (CA Team 15) mobilizing. Timber, brush and medium slash. Extreme fire behavior with torching, spotting and crowning.

\* **North Complex** (2 fires), Plumas NF, USFS. IMT 1 (CA Team 1) mobilizing. One mile southwest of Crescent Mills, CA. Timber, short grass and brush. Extreme fire behavior with crowning, uphill runs and torching. Numerous structures threatened. Evacuations, area and road closures in effect.

\* **W-5**, Northern California District, BLM. Eleven miles east of Madeline, CA. Brush, light slash and timber. Extreme fire behavior with wind-driven runs and short-range spotting. Structures and sage-grouse habitat threatened. Road closures in effect.

**5-4 Potters**, Butte Unit, Cal Fire. Five miles northeast of Oroville, CA. Brush and grass. Active fire behavior with wind-driven runs and running. Numerous structures and energy infrastructure threatened. Evacuations, area, road, and trail closures in effect.

\* **Woodward**, Point Reyes National Seashore, NPS. Three miles southwest of Olema, CA. Timber, brush and chaparral. Active fire behavior with uphill runs and wind-driven runs. Communication infrastructure threatened. Evacuations in effect.

\* **R-5**, Northern California District, BLM. Seventeen miles northeast of Susanville, CA. Brush and short grass. Minimal fire behavior with creeping. Sage-grouse habitat threatened.

**July Complex**, Modoc NF, USFS. Thirty-six miles northwest of Canby, CA. Timber, brush and tall grass. Minimal fire behavior with smoldering. Area and road closures in effect.

**Grizzly Creek**, Garfield County. IMT 1 (GB Team 1). One mile east of Glenwood Springs, CO. Timber and brush. Extreme fire behavior with crowning, running and long-range spotting. Energy and transportation infrastructure and numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Williams Fork**, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. IMT 1 (GB Team 2). Fifteen miles southwest of Fraser, CO. Timber. Active fire behavior with short crown runs and running. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Pine Gulch**, Grand Junction Field Office, BLM. IMT 1 (RM Team 1). Eighteen miles north of Grand Junction, CO. Timber and brush. Active fire behavior with crowning, group torching and spotting. Structures, energy infrastructure and sage-grouse habitat threatened. Evacuations and road closures in effect.

**Cameron Peak**, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. IMT 2 (RM Blue Team). Fifteen miles southwest of Redfeather Lakes, CO. Timber and closed timber litter. Extreme fire behavior with short crown runs and long-range spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

**Waddle Creek**, Sheridan County. Twenty-five miles east of Sheridan, WY. Short grass and brush. Active fire behavior with running, spotting and backing. Structures and energy infrastructure threatened. Evacuations in effect.

**High Bull**, Pine Ridge Agency, BIA. Seven miles northeast of Pine Ridge, SD. Grass and timber. Minimal fire behavior.

**Lake**, Angeles NF, USFS. IMT 1 (CA Team 5). Seventeen miles west of Lancaster, CA. Timber, brush and chaparral. Extreme fire behavior with short crown runs, spotting and running. Numerous structures, multiple communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**River**, San Benito-Monterey Unit, Cal Fire. IMT 1 (Cal Fire Team 1). Five miles southeast of Salinas, CA. Brush, chaparral and short grass. Moderate fire behavior with uphill runs, flanking and single tree torching. Numerous residences and communication infrastructure threatened. Evacuations, area, road, and trail closures in effect.

**Ranch2**, Angeles NF, USFS. IMT 2 (CA Team 11). Two miles north of Azusa, CA. Brush and tall grass. Active fire behavior with running, uphill runs and spotting. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

**Dome**, Mojave National Preserve, NPS. IMT 2 (CA Team 12). Seven miles northwest of Cima, CA. Brush and tall grass. Active fire behavior with isolated torching and wind-driven runs. Structures, energy and railroad infrastructure threatened. Evacuations, area, road and trail closures in effect.

\* **Carmel**, San Benito-Monterey Unit, Cal Fire. Three miles southeast of Carmel Valley, CA. Brush, tall grass and chaparral. Extreme fire behavior with uphill runs. Residences threatened. Evacuations and road closures in effect.

**Beach**, Inyo NF, USFS. Three miles northwest of Mono Mills, CA. Chaparral, brush, and timber. Moderate fire behavior with creeping. Structures and sage-grouse habitat threatened. Area and road closures in effect.

**Chief Timothy**, Washington State. Started on private land six miles west of Clarkston, WA. Brush and short grass. Minimal fire behavior with smoldering and backing.

**Wildcat**, Burns District, BLM. Twenty-five miles west of Rome, OR. Brush and short grass. No new information.

**Trout Creek**, Burns District, BLM. Twenty-two miles southeast of Fields, OR. Brush and grass. No new information.

**Predictive Services Discussion:** The Four Corners High will continue to slightly weaken as it begins to drift south. Scattered afternoon storms will remain possible along its northern edge over eastern Oregon, Idaho, Montana, and Wyoming where winds will be breezy during the afternoon period. Scattered storms will also be possible along the Rocky Mountain Front in Colorado and New Mexico while isolated storms will be possible further west across Arizona and Southern California. Below average temperatures will continue across the East as a weakening trough of low pressure remains anchored over the Mississippi River Valley. Scattered storms will remain possible across the Southeast along a weakening stationary front situated over Florida.

## Serious Injury Procedures

*Firefighter Health & First Aid*

Dealing with serious injuries on the fireline can add even more stress to our hectic work environment. In the event a fireline accident occurs, adherence to the following principles is important to insure an adequate and appropriate response is made.

- Before entering the scene, determine whether it is safe to approach. Look for hazards as well as what may have happened. It may be necessary to move the patient or to make the area safe before doing an assessment.
- Provide first aid and assess the extent of the injuries.
- Make contact with your supervisor. Depending on the complexity of the fire, that could be your crew boss, the Division Supervisor, the Incident Commander, or even dispatch. If your fire has a medical plan, follow the plan.
- Provide them with accurate, concise information on the following
  - Number of people injured
  - Type of injuries
  - Severity of injuries (light, moderate, severe, life threatening)
  - Mechanism of injury
  - Vital signs (pulse, respiration, level of consciousness, etc)
- Determine the best method of evacuation. Depending on the severity of injury or availability of resources, this decision may already be made for you.
- Keep the radio frequency clear of non-emergency traffic, provide updates of the patient's condition and await instructions.
- If evacuation is by helicopter, it may be necessary to construct a helispot. Document treatment provided in case it is necessary to send the information along with the patient in the aircraft.
- If the patient needs to be carried to a road, insure enough people are available to work in relays.
- Once the patient is clear, take a moment to write down witness statements, clean up notes and timelines, and document any other pertinent information.
