One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

Two MAFFS C-130 airtanker and support personnel each from the 153rd Airlift Wing (Wyoming Air National Guard) and the 146th Airlift Wing (California Air National Guard) have been deployed to support wildland fire operations in California.

**LNU Lightning Complex** (3 fires), Sonoma-Lake Napa Unit, Cal Fire. IMT 1 (Cal Fire Team 2). Two miles north of Barro, CA. Chaparral, tall grass and timber. Extreme fire behavior with long-range spotting, short-range spotting and wind-driven runs. Numerous structures, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**CZU Aug Lightning Complex** (4 fires), San Mateo-Santa Cruz Unit, Cal Fire. IMT 1 (Cal Fire Team 3). Eight miles east of Pescadero, CA. Timber, brush and closed timber litter. Active fire behavior with backing, flanking and group torching. Numerous residences, several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**SCU Lightning Complex** (2 fires), Santa Clara Unit, Cal Fire. IMT 1 (Cal Fire Team 6). Five miles southwest of Brentwood, CA. Tall grass and chaparral. Active fire behavior with long-range spotting, wind-driven runs and isolated torching. Numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**August Complex** (5 fires), Mendocino NF, USFS. Fourteen miles northwest of Elk Creek, CA. IMT 2 (CA Team 15). Timber, brush and medium slash. Extreme fire behavior with short crown runs, group torching and short-range spotting. Numerous residences, communication and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**North Complex** (2 fires), Plumas NF, USFS. IMT 1 (CA Team 1). IMT is also managing the Sheep fire. One mile southwest of Crescent Mills, CA. Timber, short grass and brush. Active fire behavior with torching and spotting. Structures threatened. Evacuations, road and trail closures in effect. Reduction in acreage due to separating Sheep fire.

\* **Sheep**, Plumas NF, USFS. Previously reported as part of the North Complex. Thirteen miles east of Westwood, CA. Timber, short grass and chaparral. Active fire behavior with torching and spotting. Numerous structures threatened. Road and trail closures in effect.

**BTU/TGU Lightning Complex** (9 fires), Butte Unit, Cal Fire. IMT 1 (Cal Fire Team 4). Two miles northwest of Oroville, CA. Timber, brush and tall grass. Active fire behavior with single tree torching and uphill runs. Numerous residences and energy infrastructure threatened. Evacuations, road and trail closures in effect.

**Woodward**, Point Reyes National Seashore, NPS. IMT 1 (NR Team 2). Three miles southwest of Olema, CA. Timber, brush and chaparral. Active fire behavior with wind-driven runs, group torching and short-range spotting. Numerous structures and transportation infrastructure threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**W-5 Cold Springs**, Northern California District, BLM. IMT 2 (CA Team 13). Eleven miles east of Madeline, CA. Brush, light slash and timber. Extreme fire behavior with uphill runs, long-range spotting and running. Structures and sage-grouse habitat threatened. Area and road closures in effect.

**Red Salmon Complex** (2 fires), Six Rivers NF, USFS. IMT 1 (CA Team 4). Fourteen miles northeast of Willow Creek, CA. Timber, chaparral and short grass. Active fire behavior with uphill runs, flanking and torching. Area, road and trail closures in effect.

**Loyalton**, Tahoe NF, USFS. Transfer of command from IMT 2 (CA Team 10) back to the local unit will occur on 8/24. Four miles northeast of Loyalton, CA. Timber and tall grass. Minimal fire behavior with creeping, single tree torching and smoldering. Area, road and trail closures in effect.

**Jones**, Nevada-Yuba-Placer Unit, Cal Fire. Three miles southeast of Birchville, CA. Timber, dormant brush and hardwood slash. Minimal fire behavior with smoldering. Area closures in effect.

**Hull**, Mendocino NF, USFS. Five miles north of Lake Pillsbury, CA. Timber, brush and chaparral. Active fire behavior with spotting, torching and flanking. Numerous residences and energy infrastructure threatened.

\* **Spring**, Shasta-Trinity NF. Eight miles north of Platina, CA. Timber and medium timber slash. Active fire behavior with crowning, uphill runs and spotting. Structures threatened. Evacuations, area and road closures in effect.

**Lake**, Angeles NF, USFS. IMT 1 (CA Team 5). Seventeen miles west of Lancaster, CA. Timber, brush and chaparral. Moderate fire behavior with flanking, backing and isolated torching. Numerous structures, multiple communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**River**, San Benito-Monterey Unit, Cal Fire. IMT 1 (Cal Fire Team 1). IMT is also managing the Carmel incident. Five miles southeast of Salinas, CA. Brush, chapparral and short grass. Active fire behavior with uphill runs, single tree torching and short-range spotting. Numerous residences and communication infrastructure threatened. Evacuations, area, road, and trail closures in effect.

**Carmel**, San Benito-Monterey Unit, Cal Fire. Three miles southeast of Carmel Valley, CA. Brush, tall grass and chapparral. Moderate fire behavior with backing and single tree torching. Numerous residences and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Moc**, Tuolumne-Calaveras Unit, Cal Fire. Started on county land two miles southwest of Big Oak Flat, CA. Chaparral and grass. Active fire behavior with backing, creeping and isolated torching. Multiple communities, numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Dolan**, Los Padres NF, USFS. IMT 1 (CA Team 2). Ten miles south of Big Sur, CA. Timber, brush and chaparral. Active fire behavior with flanking, short crown runs and backing. Numerous residences and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Ranch 2**, Angeles NF, USFS. IMT 2 (CA Team 11). Two miles north of Azusa, CA. Brush and tall grass. Minimal fire behavior with creeping and smoldering. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

**Hills**, Fresno-Kings Unit, Cal Fire. Nine miles south of Coalinga, CA. Chaparral and tall grass. Minimal fire behavior.

**Dome**, Mojave National Preserve, NPS. Transfer of command from IMT 2 (CA Team 12) back to the local unit will occur today. Seven miles northwest of Cima, CA. Brush and tall grass. Minimal fire behavior with smoldering. Structures threatened.

\* **Castle**, Sequoia NF, USFS. Six miles northeast of Ponderosa, CA. Timber, brush and short grass. Extreme fire behavior with wind-driven runs, flanking and spotting. Residences threatened. Road closures in effect.

\* **Shotgun**, Sequoia NF, USFS. Twenty-one miles northwest of Three Rivers, CA. Timber and chaparral. Active fire behavior with wind-driven runs and flanking. Trail closures in effect.

**Apple**, Riverside Unit, Cal Fire. One mile northeast of Cherry Valley, CA. Timber, chaparral and tall grass. Minimal fire behavior with smoldering.

**Salt**, Tuolumne-Calaveras Unit, Cal Fire. Two miles west of Felix, CA. Brush and grass. Minimal fire behavior with creeping and smoldering.

**Trimmer**, Sierra NF, USFS. Ten miles northeast of Piedra, CA. Timber and brush. Minimal fire behavior.

**Beach**, Inyo NF, USFS. Three miles northwest of Mono Mills, CA. Chaparral, brush, and timber. No new information. Last report unless new information is received.

**Grizzly Creek**, White River NF, USFS. IMT 1 (GB Team 1). IMT 1 (AK Team 1) mobilizing. Started on county land one mile east of Glenwood Springs, CO. Timber and brush. Active fire behavior with group torching, single tree torching and creeping. Energy and transportation infrastructure and numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Williams Fork**, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. IMT 1 (GB Team 2). Fifteen miles southwest of Fraser, CO. Timber. Active fire behavior with uphill runs, group torching and spotting. Numerous structures threatened. Area, road and trail closures in effect.

**Pine Gulch**, Grand Junction Field Office, BLM. IMT 1 (RM Team 1). Eighteen miles north of Grand Junction, CO. Timber and brush. Moderate fire behavior with crowning, group torching and spotting. Structures and sage-grouse habitat threatened. Evacuations, area and road closures in effect.

**Cameron Peak**, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. IMT 2 (RM Blue Team). NIMO (Portland) and IMT 2 (RM Black Team) mobilizing. Fifteen miles southwest of Redfeather Lakes, CO. Timber and closed timber litter. Active fire behavior with short crown runs and long-range spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

**High Bull**, Pine Ridge Agency, BIA. Seven miles northeast of Pine Ridge, SD. Grass and timber. Minimal fire behavior.

**P515**, Warm Springs Agency, BIA. IMT 2 (NW Team 7). IMT is also managing the Lionshead fire. Seventeen miles west of Warm Springs, OR. Timber. Active fire behavior with flanking, backing and torching. Residences threatened. Area, road and trail closures in effect.

**Lionshead**, Warm Springs Agency, BIA. Twenty miles west of Warm Springs, OR. Timber and brush. Active fire behavior with flanking, backing and torching. Area, road and trail closures in effect.

**Palmer**, Spokane District, BLM. IMT 2 (NW Team 6). Nine miles southwest of Oroville, WA. Timber. Moderate fire behavior with flanking, backing and torching. Numerous residences threatened. Area closures in effect.

**Green Ridge**, Deschutes NF, USFS. Transfer of command from IMT 2 (NW Team 10) to IMT 1 (ODF Team 3) will occur today. Twelve miles northwest of Sisters, OR. Timber and brush. Active fire behavior with isolated torching, flanking and short-range spotting. Community of Camp Sherman and numerous residences threatened. Area, road, and trail closures in effect.

**Indian Creek**, Vale District, BLM. IMT 2 (NW Team 13). Nine miles east of Juntura, OR. Brush and short grass. Moderate fire behavior with backing, isolated torching and short-range spotting. Numerous structures and sage-grouse habitat threatened.

**Crane**, Fremont-Winema NF, USFS. IMT 2 (NW Team 12). Ten miles southeast of Lakeview, OR. Timber and brush. Moderate fire behavior with torching, creeping and flanking. Structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Frog**, Ochoco NF, USFS. IMT 2 (NW Team 8). Eight miles south of Post, OR. Timber and brush. Moderate fire behavior with creeping, single tree torching and short-range spotting. Structures threatened. Area and road closures in effect.

**White River**, Mt. Hood NF, USFS. IMT2 (NW Team 9). Timber and closed timber litter. Twenty miles west of Wamic, OR. Active fire behavior with short-range spotting, group torching and single tree torching. Area, road and trail closures in effect.

**Meacham Complex**, Umatilla NF, USFS. IMT 2 (NR Team 3). Eight miles northeast of Meacham, OR. Timber. Moderate fire behavior with flanking, backing and isolated torching. Numerous structures and transportation infrastructure threatened. Road closures in effect.

**Steet Mountain**, John Day Unit, Oregon DOF. IMT 1 (ODF Team 2). IMT is also managing the Laurel fire. Six miles northeast of Monument, OR. Timber. Minimal fire behavior with creeping and smoldering. Reduction in acreage due to more accurate mapping.

**Laurel**, Prineville District, BLM. Five miles south of Spray, OR. Timber, brush and short grass. Minimal fire behavior with creeping and smoldering.

**Beachie Creek**, Willamette NF, USFS. NIMO (Atlanta) mobilizing. Six miles northeast of Detroit, OR. Timber. No new information.

**Putnam Springs**, Umatilla NF, USFS. Forty-five miles south of Heppner, OR. Timber. Moderate fire behavior with isolated torching, creeping and smoldering. Structures threatened.

**Little Mud Creek**, Burns District, BLM. Six miles west of Frenchglen, OR. Brush and short grass. Minimal fire behavior. Sage-grouse habitat threatened. Reduction in acreage due to more accurate mapping. Last report unless significant activity occurs.

**Baldy**, Vale District, BLM. Six miles north of Ironside, OR. Brush and grass. Minimal fire behavior with smoldering. Sage-grouse habitat threatened. Reduction in acreage due to more accurate mapping.

**Jungle Creek**, Okanogan-Wenatchee NF, USFS. Fourteen miles southwest of Cle Elum, WA. Timber. Moderate fire behavior.

**Wildcat**, Burns District, BLM. Twenty-five miles west of Rome, OR. Brush and short grass. Minimal fire behavior.

**Salt**, Tonto NF, USFS. IMT 2 (SW Team 5). IMT is also managing the Griffin fire. Twelve miles northwest of Globe, AZ. Tall grass and brush. Active fire behavior with uphill runs, flanking and group torching. Numerous structures and energy infrastructure threatened. Evacuations, area and road closures in effect. Reduction in acreage due to more accurate mapping.

**Griffin**, Tonto NF, USFS. Includes previously reported Gin fire. Sixteen miles northeast of Globe, AZ. Short grass and brush. Active fire behavior with wind-driven runs, running and flanking. Structures threatened. Area and road closures in effect.

**Predictive Services Discussion:** A Four Corners High will remain entrenched with an upper-level trough approaching the Pacific Northwest and a remnant upper low from Hurricane Genevieve off the southern California coast. Widely scattered monsoonal thunderstorms are expected across the higher terrain of the Great Basin and Southwest. Storms are likely to extend northward out of southern California into the Sierra and possibly over portions of the central California coast. A weak cold front will push into portions of the northern Great Basin and central Montana. Thunderstorms are likely from the Louisiana Gulf Coast eastward across Florida and northward into the Southeast and Mid-Atlantic as moisture wraps around the Bermuda High out of the Gulf of Mexico.

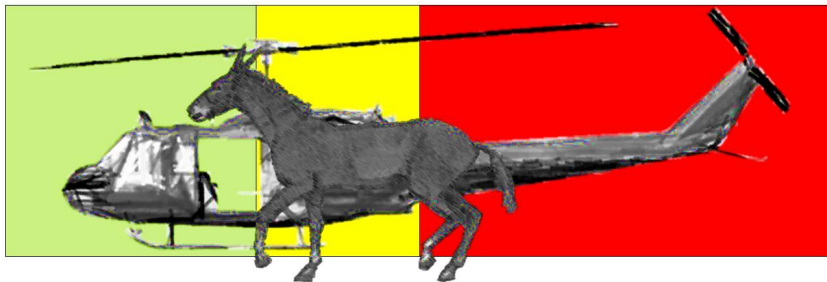
## Working Around Pack Stock

*Miscellaneous Fireline Hazards*

Fire crews often receive supplies that are transported by pack stock (horses and mules). While these animals provide fire crews a valuable service, they can cause injury to themselves and personnel, and severely damage food, gear, and fire equipment if not handled properly.

Much like adding aviation resources to a fire incident, having pack stock around is adding an additional hazard to the fire environment which increases the difficulty in maintaining situational awareness. Fire personnel must be aware that human activity, aircraft, wildlife, and weather conditions can and will affect the behavior of the pack animals, often unpredictably.

- Avoid making any sudden or abrupt moves or making any loud or unusual noises around the stock. Be calm, relaxed, steady, and smooth around the animals at all times.
- When passing pack stock on the trail, know your escape routes at all times. Move off the trail before the stock passes. Calmly move to the **same** side, preferably the downhill side, with all of your gear. Be far enough off the trail that no one could get kicked, but close enough for the stock to see everyone. Talk to the packer and the stock as they approach and pass...this helps the stock know that you and your crew are not something to be afraid of.
- Packers, like all fire personnel, must maintain communications at all times. Ensure that the communication plan is known to everyone. Individual forest and park units will have the specific safety-related guidelines identified for Packers in regards to required fire training, personal protective equipment, communications, etc.
- **Work around pack stock in the same manner you would work around many types of helicopters:**
  - ✓ Stay outside of the safety circle unless invited or escorted in.
  - ✓ Only approach from the front.
  - ✓ Never approach from the tail or walk around the tail.
  - ✓ Don't run, wave arms, throw tarps, or anything else.
  - ✓ Put your gear where directed and in an orderly manner.
  - ✓ Weigh everything. Weight and balance are important on mules and helicopters!
