NIMO (Houseman) has been assigned to COVID-19 support at Forest Service headquarters in Washington, D.C.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

Two MAFFS C-130 airtanker and support personnel each from the 153rd Airlift Wing (Wyoming Air National Guard) and the 146th Airlift Wing (California Air National Guard) have been deployed to support wildland fire operations in California.

LNU Lightning Complex (3 fires), Sonoma-Lake Napa Unit, Cal Fire. IMT 1 (Cal Fire Team 2). Two miles north of Barro, CA. Chapparal, tall grass and timber. Extreme fire behavior with long-range spotting, short-range spotting and wind-driven runs. Numerous structures, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

SCU Lightning Complex (2 fires), Santa Clara Unit, Cal Fire. IMT 1 (Cal Fire Team 6). Five miles southwest of Brentwood, CA. Tall grass and chapparal. Extreme fire behavior with uphill runs, isolated torching and long-range spotting. Numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

CZU Aug Lightning Complex (4 fires), San Mateo-Santa Cruz Unit, Cal Fire. IMT 1 (Cal Fire Team 3). Eight miles east of Pescadero, CA. Timber, brush and closed timber litter. Active fire behavior with flanking, backing and smoldering. Numerous residences, several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

August Complex (5 fires), Mendocino NF, USFS. Fourteen miles northwest of Elk Creek, CA. IMT 2 (CA Team 15). Timber, brush and medium slash. Active fire behavior with running, group torching and short-range spotting. Numerous residences and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

North Complex (2 fires), Plumas NF, USFS. IMT 1 (CA Team 1). IMT is also managing the Sheep fire. One mile southwest of Crescent Mills, CA. Timber, short grass and brush. Active fire behavior with torching, spotting and crowning. Structures threatened. Evacuations, road and trail closures in effect.

BTU/TGU Lightning Complex (9 fires), Butte Unit, Cal Fire. IMT 1 (Cal Fire Team 4). Two miles northwest of Oroville, CA. Timber, brush and tall grass. Active fire behavior with torching and backing. Numerous residences and energy infrastructure threatened. Evacuations, road and trail closures in effect.

Sheep, Plumas NF, USFS. Thirteen miles east of Westwood, CA. Timber, short grass and chaparral. Active fire behavior with group torching, short crown runs and spotting. Numerous structures threatened. Evacuations, road and trail closures in effect.

Woodward, Point Reyes National Seashore, NPS. IMT 1 (NR Team 2). Three miles southwest of Olema, CA. Timber, brush and chaparral. Active fire behavior with short crown runs, group torching and wind-driven runs. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Spring, Shasta-Trinity NF. Eight miles north of Platina, CA. Timber and medium timber slash. Moderate fire behavior with backing, flanking and single tree torching. Structures threatened. Evacuations, area and road closures in effect.

W-5 Cold Springs, Northern California District, BLM. IMT 2 (CA Team 13). Eleven miles east of Madeline, CA. Brush, light slash and timber. Extreme fire behavior with uphill runs, long-range spotting and running. Structures and sage-grouse habitat threatened. Area and road closures in effect.

Red Salmon Complex (2 fires), Six Rivers NF, USFS. IMT 1 (CA Team 4). Fourteen miles northeast of Willow Creek, CA. Timber, chaparral and short grass. Active fire behavior with uphill runs, flanking and torching. Area, road and trail closures in effect.

Hull, Mendocino NF, USFS. Five miles north of Lake Pillsbury, CA. Timber, brush and chaparral. Active fire behavior with torching, running and short-range spotting. Numerous residences and energy infrastructure threatened. Area and road closures in effect.

Loyalton, Tahoe NF, USFS. Transfer of command from IMT 2 (CA Team 10) back to the local unit will occur today. Four miles northeast of Loyalton, CA. Timber and tall grass. Minimal fire behavior with smoldering and creeping. Area and road closures in effect.

Jones, Nevada-Yuba-Placer Unit, Cal Fire. Three miles southeast of Birchville, CA. Timber, dormant brush and hardwood slash. Minimal fire behavior with smoldering. Area and trail closures in effect.

River, San Benito-Monterey Unit, Cal Fire. IMT 1 (Cal Fire Team 1). IMT is also managing the Carmel incident. Five miles southeast of Salinas, CA. Brush, chaparral and short grass. Minimal fire behavior with backing and creeping. Numerous residences and communication infrastructure threatened. Evacuations, area, road, and trail closures in effect.

Carmel, San Benito-Monterey Unit, Cal Fire. Three miles southeast of Carmel Valley, CA. Brush, tall grass and chaparral. Minimal fire behavior with backing and creeping. Numerous residences and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Lake, Angeles NF, USFS. IMT 1 (CA Team 5). Seventeen miles west of Lancaster, CA. Timber, brush and chaparral. Active fire behavior with flanking and backing. Numerous structures, multiple communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Dolan, Los Padres NF, USFS. IMT 1 (CA Team 2). Ten miles south of Big Sur, CA. Timber, brush and chaparral. Active fire behavior with flanking, short crown runs and backing. Numerous residences and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Moc, Tuolumne-Calaveras Unit, Cal Fire. Started on county land two miles southwest of Big Oak Flat, CA. Chaparral and grass. Moderate fire behavior with flanking, backing and smoldering. Multiple communities, numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Ranch 2, Angeles NF, USFS. IMT 2 (CA Team 11). Two miles north of Azusa, CA. Brush and tall grass. Minimal fire behavior with creeping and smoldering. Numerous residences threatened. Area, road and trail closures in effect.

Castle, Sequoia NF, USFS. IMT 2 (CA Team 12) mobilizing. IMT is also managing the Shotgun fire. Six miles northeast of Ponderosa, CA. Timber, brush and short grass. Extreme fire behavior with crowning, short crown runs and group torching. Numerous residences threatened. Area, road and trail closures in effect.

Shotgun, Sequoia NF, USFS. Twenty-one miles southeast of Three Rivers, CA. Timber and chaparral. Moderate fire behavior. Trail closures in effect.

Hills, Fresno-Kings Unit, Cal Fire. Nine miles south of Coalinga, CA. Chaparral and tall grass. Minimal fire behavior.

Dome, Mojave National Preserve, NPS. Seven miles northwest of Cima, CA. Brush and tall grass. Minimal fire behavior with smoldering. Structures threatened.

Apple, Riverside Unit, Cal Fire. One mile northeast of Cherry Valley, CA. Timber, chaparral and tall grass. Minimal fire behavior with smoldering.

Salt, Tuolumne-Calaveras Unit, Cal Fire. Two miles west of Felix, CA. Brush and grass. Minimal fire behavior with smoldering.

Trimmer, Sierra NF, USFS. Ten miles northeast of Piedra, CA. Timber and brush. No new information.

Grizzly Creek, White River NF, USFS. IMT 1 (GB Team 1) and IMT 1 (AK Team 1). Started on county land one mile east of Glenwood Springs, CO. Timber and brush. Active fire behavior with group torching, single tree torching and creeping. Energy and transportation infrastructure and numerous structures threatened. Evacuations, area, road and trail closures in effect.

Williams Fork, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. IMT 1 (GB Team 2). Fifteen miles southwest of Fraser, CO. Timber. Active fire behavior with uphill runs, torching and spotting. Numerous structures threatened. Area, road and trail closures in effect.

Pine Gulch, Grand Junction Field Office, BLM. IMT 1 (RM Team 1). IMT 1 (SA Red Team) mobilizing. Eighteen miles north of Grand Junction, CO. Timber and brush. Moderate fire behavior with crowning, group torching and spotting. Structures, energy infrastructure and sage-grouse habitat threatened. Evacuations, area and road closures in effect.

Cameron Peak, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. IMT 2 (RM Blue Team). NIMO (Day) and IMT 2 (RM Black Team) mobilizing. Fifteen miles southwest of Redfeather Lakes, CO. Timber and closed timber litter. Active fire behavior with short crown runs and long-range spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

High Bull, Pine Ridge Agency, BIA. Seven miles northeast of Pine Ridge, SD. Grass and timber. Minimal fire behavior.

Lionshead, Warm Springs Agency, BIA. Twenty miles west of Warm Springs, OR. Timber and brush. Active fire behavior with flanking, backing and torching. Area, road and trail closures in effect.

Green Ridge, Deschutes NF, USFS. IMT 1 (ODF Team 3). Twelve miles northwest of Sisters, OR. Timber and brush. Active fire behavior with isolated torching and short-range spotting. Community of Camp Sherman and numerous residences threatened. Area, road, and trail closures in effect.

Palmer, Spokane District, BLM. IMT 2 (NW Team 6). Nine miles southwest of Oroville, WA. Timber. Moderate fire behavior with flanking, group torching and short crown runs. Numerous residences threatened. Road closures in effect.

Indian Creek, Vale District, BLM. IMT 2 (NW Team 13). Nine miles east of Juntura, OR. Brush and short grass. Moderate fire behavior with backing, isolated torching and short-range spotting. Numerous structures and sage-grouse habitat threatened.

Meacham Complex, Umatilla NF, USFS. IMT 2 (NR Team 3). Eight miles northeast of Meacham, OR. Timber. Moderate fire behavior with flanking, backing and isolated torching. Numerous structures and transportation infrastructure threatened. Road closures in effect.

Frog, Ochoco NF, USFS. IMT 2 (NW Team 8). Eight miles south of Post, OR. Timber and brush. Active fire behavior with group torching, running and creeping. Structures threatened. Area and road closures in effect.

White River, Mt. Hood NF, USFS. IMT2 (NW Team 9). Timber and closed timber litter. Twenty miles west of Wamic, OR. Moderate fire behavior with short-range spotting, group torching and single tree torching. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Crane, Fremont-Winema NF, USFS. IMT 2 (NW Team 12). Ten miles southeast of Lakeview, OR. Timber and brush. Minimal fire behavior with creeping, smoldering and isolated torching. Structures and energy infrastructure threatened. Area, road and trail closures in effect.

Steet Mountain, John Day Unit, Oregon DOF. IMT 1 (ODF Team 2). IMT is also managing the Laurel fire. Six miles northeast of Monument, OR. Timber. Minimal fire behavior.

Laurel, Prineville District, BLM. Five miles south of Spray, OR. Timber, brush and short grass. Minimal fire behavior.

Beachie Creek, Willamette NF, USFS. NIMO (Quesinberry). Six miles northeast of Detroit, OR. Timber. Active fire behavior with backing. Structures threatened. Road and trail closures in effect.

Putnam Springs, Umatilla NF, USFS. Forty-five miles south of Heppner, OR. Timber. Minimal fire behavior with smoldering and creeping. Structures threatened.

Baldy, Vale District, BLM. Six miles north of Ironside, OR. Brush and grass. Moderate fire behavior with smoldering. Sage-grouse habitat threatened.

Salt, Tonto NF, USFS. IMT 2 (SW Team 5). IMT is also managing the Griffin fire. Twelve miles northwest of Globe, AZ. Tall grass and brush. Minimal fire behavior with flanking, backing and creeping. Numerous structures threatened. Area and road closures in effect. Precipitation occurred over the fire area yesterday.

Griffin, Tonto NF, USFS. Sixteen miles northeast of Globe, AZ. Short grass and brush. Moderate fire behavior with running, flanking and backing. Structures threatened. Area closures in effect.

Medio, Santa Fe NF, USFS. IMT 2 (SW Team 4). Three miles northeast of Chupadero, NM. Timber. Active fire behavior with uphill runs, backing and torching. Structures threatened. Area, road and trail closures in effect.

Ridge, Colorado River District, BLM. IMT 2 (SW Team 3). Six miles south of Pine Lake, AZ. Timber, chapparal, and short grass. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

* **East Well**, Socorro District, New Mexico State Forestry. Twenty miles south of Mountainair, NM. Brush and short grass. Active fire behavior with running, group torching and spotting.

* **Medicine**, Fort Apache Agency, BIA. Twenty-five miles north of Globe, AZ. Brush and tall grass. Active fire behavior with uphill runs, backing and flanking.

Constellation, Northwest District, Arizona DOF. Nine miles northeast of Wickenburg, AZ. Brush and short grass. Moderate fire behavior with wind-driven runs, backing and short-range spotting. Structures threatened. Road closures in effect.

Superstition, Tonto NF. Three miles east of Gold Canyon, AZ. Brush and short grass. Moderate fire behavior.

Verde, Tonto NF. Thirty miles northeast of Cave Creek, AZ. Timber, brush and short grass. Minimal fire behavior.

Spud Rock, Saguaro NP, NPS. Twelve miles southeast of Tanque Verde, AZ. Timber and short grass. Minimal fire behavior with backing and creeping. Area and trail closures in effect.

Buck, Truxton Canyon Agency, BIA. Five miles west of Peach Springs, AZ. Brush and short grass. No new information.

Predictive Services Discussion: Early morning convection across northern California and Nevada should diminish during the morning hours. However, critical fire weather conditions are expected to redevelop by mid-afternoon across California, the Great Basin, southern Oregon, and western Wyoming as embedded disturbances moving northeast around the Four Corners High initiate activity. While there is more than enough high-level moisture to produce a large number of storms, the prevailing thought is that the presence of copious amounts of smoke over the West may hinder some of the convective development. Storms that develop will be a mix of dry and wet, mostly dry. Isolated storms will reach into Montana by late afternoon. Looking elsewhere, Hurricane Marco will make landfall south of New Orleans around mid-day. The main concerns with this storm will be flooding resulting from storm surge and heavy rainfall followed by high winds.

Preparedness Level 5

Operational Engagement Category

PREPAREDNESS LEVEL 5 (PL 5) means that nationally we are experiencing so many major incidents that there is potential to exhaust, or have exhausted, all agency fire resources. There are a number of factors which exist at this preparedness level that have the potential to impact firefighter safety:

- Most or all levels of the fire management organization are operating at maximum capacity or even in crisis mode
- The incident support system is maxed out
- Resources needed to accomplish incident objectives are unavailable
- Fatigue is impacting individuals at all levels of the organization
- There is a sustained high operational tempo

We must be mindful that these conditions reduce our margin for error. The decisions we make have the potential to further reduce that margin, or to increase our capacity to cope with uncertainty.

Read the following scenario and imagine that you are in a similar situation...

It is PL5 and you are on a rapidly growing Type 3 incident. The fire is growing and the resources on the incident can't keep up with the demands of the fire. A type 1 team has been ordered but is not expected to arrive for multiple days. An engine crew has been exceeding their 2:1 work/rest ratio for 3 days straight and is now overly fatigued both mentally and physically. The crew works a full day shift prepping line with chainsaws for the soon to start night shift of burn operations.

The engine is a part of a task force responsible for completing a back burn and holding the line without the ability to bring in extra resources if things don't go as planned. The engine crew consists of an Engine Boss (ENGB), an assistant (very experienced firefighter), a first year crew member, and a fuels tech from the local district that has 4+ years of fire experience but not as a primary fire fighter. The assistant is involved in the burn and is working for the Firing Boss, leaving the ENGB and two engine crew members to help with holding. Unfavorable winds during the night burn cause the firefighters to take smoke all night.

At about six hours into the burn the ENGB is faced with making a decision. The task force needs a Dozer Boss and, since the ENGB is a trainee and the only option, is asked to leave their engine and provide direction to the dozer. At this point the ENGB takes a tactical pause to think about the timeline that got them to this point.

- *Stories like this are not uncommon during PL 5 conditions; we operate at high tempos for long durations often with narrow margins for safety. Take this time to discuss how you could create margin in this situation or share a personal story where you were stretched operationally, and what you did.*
- *Do we adjust our tactics during PL5 knowing that it is unlikely that we will get any additional resources?*
- *Are there other circumstances when conditions like PL5 can occur?*
- *What practices can you use to cope with the increase of expectations and operational tempo during PL 5 conditions?*
