NIMO (Houseman) has been assigned to COVID-19 support at Forest Service headquarters in Washington, D.C.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

Two MAFFS C-130 airtanker and support personnel each from the 153rd Airlift Wing (Wyoming Air National Guard) and the 146th Airlift Wing (California Air National Guard) have been deployed to support wildland fire operations in California.

On August 24th, a pilot with Central Helicopters, Inc. was fatally injured when his helicopter crashed during suppression operations on the White River Fire on the Mt. Hood National Forest. The firefighting community extends condolences to the friends and family of the deceased.

**LNU Lightning Complex** (3 fires), Sonoma-Lake Napa Unit, Cal Fire. IMT 1 (Cal Fire Team 2). Two miles north of Barro, CA. Chaparral, tall grass and timber. Extreme fire behavior with long-range spotting, short-range spotting and uphill runs. Numerous structures, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**SCU Lightning Complex** (2 fires), Santa Clara Unit, Cal Fire. IMT 1 (Cal Fire Team 6). Five miles southwest of Brentwood, CA. Tall grass and chaparral. Active fire behavior with short-range spotting, uphill runs and backing. Numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**CZU Aug Lightning Complex** (4 fires), San Mateo-Santa Cruz Unit, Cal Fire. IMT 1 (Cal Fire Team 3). Eight miles east of Pescadero, CA. Timber, brush and closed timber litter. Active fire behavior with flanking, backing and isolated torching. Numerous residences, several communities and energy infrastructure threatened. Area, road and trail closures in effect.

**Sheep**, Plumas NF, USFS. IMT 1 (CA Team 1). IMT is also managing the North Complex. Thirteen miles east of Westwood, CA. Timber, short grass and chaparral. Active fire behavior with wind-driven runs, single tree torching and flanking. Numerous structures and sage-grouse habitat threatened. Evacuations, road and trail closures in effect.

**North Complex** (2 fires), Plumas NF, USFS. One mile southwest of Crescent Mills, CA. Timber, short grass and brush. Active fire behavior with torching, spotting and wind-driven runs. Structures threatened. Evacuations, road and trail closures in effect.

**August Complex** (6 fires), Mendocino NF, USFS. Fourteen miles northwest of Elk Creek, CA. IMT 1 (SA Blue Team) and IMT 2 (CA Team 15). Includes previously reported Hull fire. Timber, brush and medium slash. Active fire behavior with group torching, uphill runs and short-range spotting. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

**Butte/Tehama/Glenn Complex** (8 fires), Butte Unit, Cal Fire. IMT 1 (Cal Fire Team 4). Previously reported as BTU/TGU Lightning Complex. Two miles northwest of Oroville, CA. Timber, brush and tall grass. Moderate fire behavior with single tree torching and backing. Numerous residences and energy infrastructure threatened. Evacuations, road and trail closures in effect.

**W-5 Cold Springs**, Northern California District, BLM. IMT 2 (CA Team 13). Eleven miles east of Madeline, CA. Timber and brush. Extreme fire behavior with uphill runs, wind-driven runs and long-range spotting. Structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

**Woodward**, Point Reyes National Seashore, NPS. IMT 1 (NR Team 2). Three miles southwest of Olema, CA. Timber, brush and chaparral. Active fire behavior with short crown runs, group torching and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Red Salmon Complex** (2 fires), Six Rivers NF, USFS. Transfer of command from IMT 1 (CA Team 4) to IMT 2 (GB Team 5) will occur today. Fourteen miles northeast of Willow Creek, CA. Timber, chaparral and short grass. Active fire behavior with uphill runs, flanking and torching. Area, road and trail closures in effect.

**Spring**, Shasta-Trinity NF. Eight miles north of Platina, CA. Timber and medium timber slash. Minimal fire behavior with smoldering and creeping. Structures threatened. Area and road closures in effect.

**Loyalton**, Tahoe NF, USFS. Four miles northeast of Loyalton, CA. Timber and tall grass. Minimal fire behavior with smoldering.

**Jones**, Nevada-Yuba-Placer Unit, Cal Fire. Three miles southeast of Birchville, CA. Timber, dormant brush and hardwood slash. Minimal fire behavior with smoldering. Area and trail closures in effect.

**\* R-8 Pinecone**, Northern California District, BLM. Fifteen miles west of Termo, CA. Timber and brush. Active fire behavior with running, flanking and spotting. Sage-grouse habitat threatened.

**Dolan**, Los Padres NF, USFS. IMT 1 (CA Team 2). Ten miles south of Big Sur, CA. Timber, brush and chaparral. Active fire behavior with flanking, backing and isolated torching. Numerous residences and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Lake**, Angeles NF, USFS. Transfer of command from IMT 1 (CA Team 5) to IMT 2 (CA Team 14) will occur tomorrow. Seventeen miles west of Lancaster, CA. Timber, brush and chaparral. Active fire behavior with backing and flanking. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect.

**SQF Complex** (2 fires), Sequoia NF, USFS. IMT 2 (CA Team 12). Thirty-three miles east of Porterville, CA. Timber and short grass. Active fire behavior with running, flanking and short-range spotting. Numerous structures threatened. Area, road and trail closures in effect.

**River**, San Benito-Monterey Unit, Cal Fire. IMT 1 (Cal Fire Team 1). IMT is also managing the Carmel fire. Five miles southeast of Salinas, CA. Brush, chapparral and short grass. Moderate fire behavior with backing, creeping and smoldering. Numerous residences threatened. Area, road, and trail closures in effect.

**Carmel**, San Benito-Monterey Unit, Cal Fire. Three miles southeast of Carmel Valley, CA. Brush, tall grass and chapparral. Minimal fire behavior with creeping and smoldering. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

**Moc**, Tuolumne-Calaveras Unit, Cal Fire. Started on county land two miles southwest of Big Oak Flat, CA. Chaparral and grass. Minimal fire behavior. Area, road and trail closures in effect.

**Ranch 2**, Angeles NF, USFS. Transfer of command from IMT 2 (CA Team 11) back to the local unit will occur today. Two miles north of Azusa, CA. Brush and tall grass. Minimal fire behavior with smoldering. Area, road and trail closures in effect.

**Trimmer**, Sierra NF, USFS. Ten miles northeast of Piedra, CA. Timber and brush. Minimal fire behavior.

**Apple**, Riverside Unit, Cal Fire. One mile northeast of Cherry Valley, CA. Timber, chaparral and tall grass. No new information. Last report unless new information is received.

**Pine Gulch**, Grand Junction Field Office, BLM. IMT 1 (RM Team 1). IMT 1 (SA Red Team) mobilizing. Eighteen miles north of Grand Junction, CO. Timber and brush. Moderate fire behavior with crowning, group torching and spotting. Structures, energy infrastructure and sage-grouse habitat threatened. Evacuations, area and road closures in effect.

**Grizzly Creek**, White River NF, USFS. Transfer of command from IMT 1 (GB Team 1) to IMT 1 (AK Team 1) will occur today. Started on county land one mile east of Glenwood Springs, CO. Timber and brush. Active fire behavior with group torching, single tree torching and creeping. Energy and transportation infrastructure and numerous structures threatened. Area, road and trail closures in effect.

**Williams Fork**, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. IMT 1 (GB Team 2). Fifteen miles southwest of Fraser, CO. Timber. Active fire behavior with uphill runs, isolated torching and spotting. Numerous structures threatened. Area, road and trail closures in effect.

**Cameron Peak**, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. Transfer of command from IMT 2 (RM Blue Team) to NIMO (Day) and IMT 2 (RM Black Team) will occur today. Fifteen miles southwest of Redfeather Lakes, CO. Timber and closed timber litter. Active fire behavior with short crown runs and long-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Thorpe**, Pike and San Isabel NF, USFS. Nine miles northwest of Lake George, CO. Timber. Moderate fire behavior with isolated torching. Energy infrastructure threatened.

**Bent Rim**, Cheyenne River Agency, BIA. Five miles south of Eagle Butte, SD. Tall grass. Moderate fire behavior. Structures threatened. Reduction in acreage due to more accurate mapping.

**Lionshead**, Warm Springs Agency, BIA. Twenty miles west of Warm Springs, OR. Timber and brush. Active fire behavior with flanking, backing and torching. Area, road and trail closures in effect.

**White River**, Mt. Hood NF, USFS. IMT2 (NW Team 9). Timber and closed timber litter. Twenty miles west of Wamic, OR. Moderate fire behavior with short-range spotting, single tree torching and group torching. Residences threatened. Area, road and trail closures in effect.

**Green Ridge**, Deschutes NF, USFS. IMT 1 (ODF Team 3). Twelve miles northwest of Sisters, OR. Timber and brush. Active fire behavior with flanking and isolated torching. Community of Camp Sherman and numerous residences threatened. Area, road, and trail closures in effect.

**Palmer**, Spokane District, BLM. IMT 2 (NW Team 6). Nine miles southwest of Oroville, WA. Timber. Moderate fire behavior with creeping, backing and flanking. Numerous residences threatened. Road closures in effect. Reduction in acreage due to more accurate mapping.

**Indian Creek**, Vale District, BLM. IMT 2 (NW Team 13). Nine miles east of Juntura, OR. Brush and short grass. Moderate fire behavior with creeping, isolated torching and short-range spotting. Numerous structures and sage-grouse habitat threatened.

**Meacham Complex** (2 fires), Umatilla NF, USFS. IMT 2 (NR Team 3). Eight miles northeast of Meacham, OR. Timber. Moderate fire behavior with backing, flanking and uphill runs. Numerous structures and transportation infrastructure threatened. Area, road and trail closures in effect.

**Frog**, Ochoco NF, USFS. IMT 2 (NW Team 8). Eight miles south of Post, OR. Timber and brush. Moderate fire behavior with single tree torching, creeping and smoldering. Structures threatened. Area and road closures in effect. Precipitation occurred over the fire area yesterday.

**Steet Mountain**, John Day Unit, Oregon DOF. IMT 1 (ODF Team 2). IMT is also managing the Laurel fire. Six miles northeast of Monument, OR. Timber. Minimal fire behavior. Reduction in acreage due to more accurate mapping.

**Laurel**, Prineville District, BLM. Five miles south of Spray, OR. Timber, brush and short grass. Minimal fire behavior.

**Crane**, Fremont-Winema NF, USFS. Transfer of command from IMT 2 (NW Team 12) to the local unit will occur tomorrow. Ten miles southeast of Lakeview, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

**Griffin**, Tonto NF, USFS. Sixteen miles northeast of Globe, AZ. Transfer of command from IMT 2 (SW Team 5) to IMT 1 (SW Team 1) will occur today. IMT is also managing the Salt, Meddler and previously reported Champion fires. Short grass and brush. Active fire behavior with uphill runs, wind-driven runs and running. Structures threatened. Area and road closures in effect.

**Salt**, Tonto NF, USFS. Twelve miles northwest of Globe, AZ. Tall grass and brush. Minimal fire behavior with backing and creeping. Numerous structures threatened. Area closures in effect.

**Meddler**, Tonto NF, USFS. Seven miles northeast of Rock House, AZ. Brush, chaparral and tall grass. Active fire behavior with wind-driven runs, flanking and backing. Structures and energy infrastructure threatened. Road closures in effect.

**Medio**, Santa Fe NF, USFS. IMT 2 (SW Team 4). Three miles northeast of Chupadero, NM. Timber. Active fire behavior with uphill runs, backing and torching. Structures threatened. Area, road and trail closures in effect.

**Medicine**, Fort Apache Agency, BIA. Twenty-five miles north of Globe, AZ. Brush and tall grass. Active fire behavior with running, flanking and backing.

**Ridge**, Colorado River District, BLM. IMT 2 (SW Team 3). Six miles south of Pine Lake, AZ. Timber, chaparral, and short grass. Minimal fire behavior with smoldering. Area, road and trail closures in effect.

**Superstition**, Tonto NF. Three miles east of Gold Canyon, AZ. Brush and short grass. Moderate fire behavior.

**Spud Rock**, Saguaro NP, NPS. Twelve miles southeast of Tanque Verde, AZ. Timber and short grass. Moderate fire behavior with backing, flanking and isolated torching. Area and trail closures in effect.

**Predictive Services Discussion:** Critical fire weather conditions are expected again on Wednesday across northern California, eastern Oregon, Idaho, Montana, Wyoming, and northern Nevada as scattered storms redevelop. Most storms will be wet, but they will be good lightning producers. There is some concern that the storms over northern California, northern Nevada, and southern Oregon could be dry. Monsoonal thunderstorms over the Four Corner States will continue with some wetting rain expected. In the East, hurricane Laura will make landfall late Wednesday night near the Louisiana/Texas state line. Breezy and cool conditions are expected across New England. Gusty westerly winds are expected across the Upper Midwest as a frontal boundary pushes east.

## Responding To Vehicle Fires

*Vehicles/Roads Category*

Suppression of vehicle fires is extremely dangerous and poses many health and safety hazards to firefighters. The following procedures are recommended:

- Wear a high visibility reflective vest or other high visibility clothing if available.
- Secure the scene and provide or request assistance for traffic control.
- Park your vehicle to provide a protective barricade for you and your crew. Position it so that an inattentive or drunk driver will hit your vehicle and not your crew. Your vehicle is expendable, you are not.
- Provide for your escape route at the scene.
- Do not use road flares if fuel is leaking from the vehicle.
- DO NOT BREATHE ANY SMOKE. Smoke from vehicle fires contains toxic chemicals that will kill you.
- Vehicle fires are considered a hazardous materials scene. Suppression action should only be taken if the crew is trained, equipped, and authorized in the use of Self-Contained Breathing Apparatus (SCBA).
- If taking suppression action on wildland fuels, firefighters should ensure that they are a safe distance from the burning vehicle (100-feet minimum), and avoid contact with vehicle fire smoke or fumes.
