Bighorn, Coronado NF, USFS. IMT 2 (SW Team 4). Five miles northeast of Tucson, AZ. Chaparral, brush and timber. Moderate fire behavior with backing, creeping and smoldering. Numerous structures threatened. Evacuations, road, trail and area closures in effect.

Mangum, Kaibab NF, USFS. Twenty-four miles southeast of Fredonia, AZ. Timber, brush and short grass. Minimal fire behavior with creeping and smoldering. Residences threatened. Road, trail and area closures in effect.

Cub, Gila NF, USFS. Fifteen miles southeast of Mogollon, NM. Timber, brush and tall grass. Moderate fire behavior with backing, creeping and smoldering.

Bringham, Apache-Sitgreaves NF, USFS. Twenty-two miles north of Morenci, AZ. Timber, brush and short grass. Minimal fire behavior with smoldering. Structures threatened. Road, trail and area closures in effect.

Mahogany, Humboldt-Toiyabe NF, USFS. IMT 2 (GB Team 7). Twenty-eight miles northwest of Las Vegas, NV. Timber and brush. Minimal fire behavior with smoldering. Road, trail and area closures in effect. Reduction in acreage due to more accurate mapping.

Predictive Services Discussion: Borderline critical fire weather conditions due to breezy southwesterly winds and low humidities will continue across northern Nevada and southern Idaho as a low pressure trough off the coast of Washington lingers. Temperatures across the Pacific Northwest will continue to be slightly below average. Scattered wet storms are possible across western portions of the Northern Rockies. A second surge of monsoonal moisture into the Four Corners is expected. So, expect widely scattered storms to develop in the afternoon. In Alaska, high pressure over the western Interior will begin to retreat to Southwest Alaska as another low pressure area moves into northwestern portions of the state and begins to be absorbed into the stronger low pressure area over the northern Yukon Territory. Scattered showers will be possible across the Interior through the day.
