NIMO (Houseman) has been assigned to COVID-19 support at Forest Service headquarters in Washington, D.C.

Two hundred thirty-three soldiers from the 14<sup>th</sup> Brigade Engineer Battalion based out of Joint Base Lewis-McChord, Washington are deployed in support of the August Complex.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

Two MAFFS C-130 airtanker and support personnel each from the 153rd Airlift Wing (Wyoming Air National Guard) and the 146th Airlift Wing (California Air National Guard) have been deployed to support wildland fire operations in California.

Three wildland fire suppression crews and three overhead personnel from Quebec, Canada are supporting fire suppression efforts in the Northern California Area.

Area Command Team (Jalbert) has been mobilized to support wildland fire in northern California.

**Slater**, Klamath NF, USFS. IMT 2 (CA Team 10). Five miles northeast of Happy Camp, CA. Timber and brush. Extreme fire behavior with crowning, long-range spotting and wind-driven runs. Community of Happy Camp threatened. Evacuations, area, road and trail closures in effect.

**Fork**, Eldorado NF, USFS. IMT 2 (SW Team 4) mobilizing. Fifteen miles northeast of Pollock Pines, CA. Timber. Active fire behavior with spotting and running. Structures threatened. Evacuations, area, road and trail closures in effect.

**North Complex**, Plumas NF, USFS. IMT 1 (CA Team 4). One mile southwest of Crescent Mills, CA. Timber and brush. Extreme fire behavior with crowning, wind-driven runs and long-range spotting. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Butte/Tehama/Glenn Complex** (6 fires), Butte Unit, Cal Fire. IMT 1 (Cal Fire Team 4). Two miles northwest of Oroville, CA. Timber, brush and tall grass. Moderate fire behavior with creeping. Residences threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to SHF Elkhorn reporting separately.

**August Complex**, Mendocino NF, USFS. IMT 1 (SA Blue Team) and IMT 1 (GB Team 2). Fourteen miles northwest of Elk Creek, CA. Timber, chaparral and tall grass. Active fire behavior with backing, creeping and

flanking. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to Hopkins and Willow Peak realignment to SHF Elkhorn.

**SHF Elkhorn** (3 fires), Shasta-Trinity NF, USFS. IMT 1 (CA Team 5). Twenty-six miles south of Hayfork, CA. Timber, chaparral and tall grass. Active fire behavior with group torching and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Red Salmon Complex** (2 fires), Six Rivers NF, USFS. NIMO (Quesinberry) and IMT 2 (CA Team 14). Fourteen miles northeast of Willow Creek, CA. Timber and closed timber litter. Active fire behavior with uphill runs, spotting and torching. Community of Hoopa threatened. Area, road and trail closures in effect.

**Oak**, Mendocino Unit, Cal Fire. IMT 1 (Cal Fire Team 5). Six miles north of Willits, CA. Timber and short grass. Active fire behavior with backing, creeping and smoldering. Numerous structures threatened. Evacuations and road closures in effect.

\* **Willow**, Nevada-Yuba-Placer Unit, Cal Fire. Six miles west of Dobbins, CA. Timber, chaparral and tall grass. Active fire behavior with uphill runs, backing and isolated torching. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Woodward**, Point Reyes National Seashore, NPS. Three miles southwest of Olema, CA. Timber, brush and chaparral. Moderate fire behavior with backing, creeping and smoldering. Numerous structures and communication infrastructure threatened. Area, road and trail closures in effect.

**CZU Aug Lightning Complex**, San Mateo-Santa Cruz Unit, Cal Fire. Eight miles east of Pescadero, CA. Timber, chaparral and closed timber litter. Moderate fire behavior with backing, creeping and smoldering. Numerous residences and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**SCU Lightning Complex**, Santa Clara Unit, Cal Fire. IMT 1 (Cal Fire Team 6). Five miles southwest of Brentwood, CA. Timber, chaparral and tall grass. Minimal fire behavior with smoldering. Area and trail closures in effect.

**LNU Lightning Complex** (2 fires), Sonoma-Lake Napa Unit, Cal Fire. Transfer of command from IMT 1 (Cal Fire Team 2) back to the local unit will occur today. Two miles north of Barro, CA. Timber, chaparral and tall grass. Minimal fire behavior with smoldering and creeping. Evacuations have been lifted. Area and trail closures in effect. Reduction in acreage due to more accurate mapping.

**W-5 Cold Springs**, Northern California District, BLM. Eleven miles east of Madeline, CA. Timber and brush. Minimal fire behavior with creeping and smoldering.

Area Command Team (Sexton) has been mobilized to support wildland fire in southern California.

**Creek**, Sierra NF, USFS. Unified command between IMT 1 (Cal Fire Team 1) and IMT 1 (GB Team 1). Thirty-five miles northeast of Clovis, CA. Timber, chaparral and tall grass. Active fire behavior with wind-driven runs, backing and spotting. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**El Dorado**, San Bernardino Unit, Cal Fire. IMT 2 (CA Team 11). Three miles northeast of Yucaipa, CA. Timber, chaparral and tall grass. Active fire behavior with backing, flanking and creeping. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Valley**, Cleveland NF, USFS. IMT 2 (CA Team 15). Nineteen miles northeast of Chula Vista, CA. Chaparral and tall grass. Active fire behavior flanking, backing and uphill runs. Several communities, communication and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Bobcat**, Angeles NF, USFS. IMT 1 (CA Team 1) and IMT 2 (EA Silver Team). Twelve miles northeast of Pasadena, CA. Chaparral and tall grass. Active fire behavior with spotting, uphill and wind-driven runs. Several communities, communications and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**SQF Complex** (2 fires), Sequoia NF, USFS. IMT 1 (NR Team 1). Thirty-three miles east of Porterville, CA. Timber and chaparral. Active fire behavior with short crown runs, group torching and long-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Dolan**, Los Padres NF, USFS. IMT 1 (PNW Team 2). Ten miles south of Big Sur, CA. Timber, brush and chaparral. Active fire behavior with short crown runs, uphill runs and spotting. Numerous residences and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Moraine**, Sequoia & Kings Canyon NP, NPS. Five miles northeast of Kanawyers, CA. Timber and brush. No new information.

Area Command Team (Stutler) has been mobilized to support wildland fire in northwest Oregon.

**Holiday Farm**, Willamette NF, USFS. IMT 1 (ODF Team 3). Thirty-five miles east of Eugene, OR. Timber and brush. Extreme fire behavior with long-range spotting, wind-driven runs and short crown runs. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Beachie Creek**, Willamette NF, USFS. IMT 2 (NW Team 13). Six miles north of Detroit, OR. Timber. Extreme fire behavior with wind-driven runs, group torching and long-range spotting. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Almeda Drive**, Medford Unit, Oregon DOF. IMT 2 (PNW Team 8). One mile north of Ashland, OR. Timber, brush and tall grass. Extreme fire behavior with wind-driven runs, running and long-range spotting. Several communities threatened. Evacuations and road closures in effect.

**Two Four Two**, Fremont-Winema NF, USFS. IMT 1 (ODF Team 2). Six miles northeast of Chiloquin, OR. Timber, brush and tall grass. Extreme fire behavior with group torching and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Lionshead**, Warm Springs Agency, BIA. IMT 1 (PNW Team 3). IMT is also managing the P515 and White River incidents. Twenty miles west of Warm Springs, OR. Timber. Extreme fire behavior with running, group torching and long-range spotting. Several communities and energy infrastructure threatened. Evacuations, road, area and trail closures in effect.

**Inchelium Complex** (3 fires), Colville Agency, BIA. IMT 2 (NW Team 7). One mile north of Inchelium, WA. Timber, brush and short grass. Moderate fire behavior with flanking, backing and group torching. Numerous structures threatened.

**Cold Springs**, Colville Agency, BIA. Four miles southeast of Omak, WA. Brush and grass. Extreme fire behavior with running, isolated torching and flanking. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Apple Acres**, Southeast Region, Washington DNR. Three miles northeast of Chelan, WA. Timber, brush and short grass. Minimal fire behavior with backing, creeping and flanking. Residences threatened. Area and road closures in effect.

**Pearl Hill**, Washington State Fire Marshal's Office. IMT 2 (NW Team 6). Four miles east of Okanogan, WA. Brush and short grass. Moderate fire behavior with backing, flanking and creeping. Numerous structures and communication infrastructure threatened. Evacuations, area and road closures in effect.

**White River**, Mt. Hood NF, USFS. Twenty miles west of Wamic, OR. Timber. Minimal fire behavior with creeping, single tree torching and smoldering. Residences threatened. Area, road and trail closures in effect.

**S. Obenchain**, Medford Unit, Oregon DOF. Five miles east of Eagle Point, OR. Timber and brush. Active fire behavior with wind-driven runs, group torching and spotting. Community of Shady Cove threatened. Evacuations and road closures in effect.

**Brattain**, Fremont-Winema NF, USFS. Eight miles south of Paisley, OR. Timber, brush and short grass. Active fire behavior with creeping, running and torching. Structures threatened. Evacuations, area, road and trail closures in effect.

**Whitney**, Northeast Region, Washington DNR. IMT 2 (NW Team 10) mobilizing. Started on private land six miles northwest of Davenport, WA. Timber, brush and tall grass. Extreme fire behavior with wind-driven runs, running and isolated torching. Numerous structures threatened. Evacuations and road closures in effect. Reduction in acreage due to more accurate mapping.

**Archie Creek**, Umpqua NF, USFS. IMT 2 (NW Team 9) mobilizing. IMT is also managing the French Creek incident. Twenty miles east of Glide, OR. Timber and brush. Active fire behavior with long-range spotting, group torching and wind-driven runs. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**French Creek**, Central Unit, Oregon DOF. One mile northwest of Glide, OR. Short grass. No new information.

**Riverside**, Mt. Hood NF, USFS. IMT 1 (SW Team 1) mobilizing. Eight miles southeast of Estacada, OR. Timber and brush. Extreme fire behavior with crowning, wind-driven runs and long-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Evans Canyon**, Southeast Region, Washington DNR. Started on county land eight miles northwest of Naches, WA. Timber, brush and tall grass. Minimal fire behavior with smoldering or creeping.

**Star Mountain Ln.**, Central Unit, Oregon DOF. Started on BLM land three miles northeast of Glide, OR. Timber. Extreme fire behavior. Numerous structures threatened. Evacuations and road closures in effect.

**Babb**, Northeast Region, Washington DNR. Thirty miles northwest of Colfax, WA. Timber, brush and tall grass. Active fire behavior with torching, smoldering and creeping. Numerous structures threatened. Evacuations in effect.

**Manning Rd**, Washington State Fire Marshal's Office. Five miles northwest of Colfax, WA. Timber, brush and tall grass. Active fire behavior with torching and smoldering. Numerous structures threatened.

\* **Thielsen**, Umpqua NF, USFS. Sixteen miles west of Chemult, OR. Timber and brush. Active fire behavior with wind-driven runs, isolated torching and short-range spotting. Structures threatened. Evacuations, road, area and trail closures in effect.

\* **Customs Road**, Northeast Region, Washington DNR. Started on private land one mile northwest of Curlew, WA. Timber, brush and tall grass. Active fire behavior with group torching, spotting and backing. Numerous structures threatened. Evacuations in effect.

\* **Paterson**, Mid-Columbia NWR Complex, FWS. One mile west of Paterson, WA. Timber, brush and short grass. Minimal fire behavior with smoldering and creeping.

\* **Echo Mtn. Complex**, Toledo Unit, Oregon DOF. Four miles east of Lincoln City, OR. Timber, brush and tall grass. Extreme fire behavior with crowning, uphill runs and long-range spotting. Communities of Otis and Lincoln City threatened. Evacuations and road closures in effect.

\* **Beverly Burke**, Spokane District, BLM. Three miles northeast of Beverly, WA. Brush and grass. Minimal fire behavior with creeping and smoldering. Evacuations in effect.

\* **Sumner Grade**, Washington State Fire Marshal's Office. Four miles west of Sumner, WA. Brush and tall grass. Moderate fire behavior with torching, running and smoldering. Numerous structures threatened. Evacuations in effect.

**Big Hollow**, Gifford Pinchot NF, USFS. IMT 2 (NW Team 12). Twenty miles north of Stevenson, WA. Timber. No new information.

**Grizzly Creek**, Medford Unit, Oregon DOF. Sixteen miles east of Ashland, OR. Timber and brush. No new information. Last report unless new information is received.

**Predictive Services Discussion:** The strong upper low over the Four Corners will begin to slowly move east-northeast today. In its wake, an upper high pressure will build over the West Coast. This will result in relatively weak onshore flow across the West Coast with generally lighter winds and higher relative humidity along coast. As the upper high pressure strengthens, conditions will become increasingly hot and dry, although dense and widespread smoke across portions of the West Coast will impact surface temperatures. Thunderstorms and rain will remain likely across portions of the southern and central Rockies and southern and central Plains and across much of the East Coast ahead of an approaching cold front.

# Suicide Prevention Day

Firefighter Health/First Aid



It is fair to say that since the recognition of COVID-19 in March, our workforce has been in a Planning Level (PL5) level of reaction. We have been forced to adapt rapidly with ever-changing policies. This alone has created a

stressful environment for many, and if you are feeling this way, you are not alone.

Our work as firefighters is not limited to wildfires any longer but has expanded to all risk, which brings even more exposure to stressful situations. Hurricanes, longer assignments, busier seasons, devastating fires...sound familiar? More time away from home and experiencing more stress can take its toll.

Learning to recognize the indicators that you or someone on your crew/unit/team needs additional support can be the difference that saves a life.

The mental health continuum can be used as a tool to help build resiliency, allowing for recovery from stressful events and reducing the chance of suicide.

## ACTION:

**1 – YOU:** Assess where you are currently on the spectrum.

**2 – As a CREW:** Have each person on the crew write down three signs they exhibit when they are stressed as well as several things they enjoy doing to relieve stress.

Talking about stress can bring a crew/unit/team closer together, but it's not always easy to do. Consider discussing these questions to chat about stress and how to manage stress:

- How do you exhibit stress?
- Do co-workers have insights on how you exhibit stress?
- What stress-relief activities and strategies do you share with your co-workers?
