NIMO (Houseman) has been assigned to COVID-19 support at Forest Service headquarters in Washington, D.C.

NIMO (Reinarz) has been assigned to provide wildland fire support to California.

NIMO (Day) has been assigned to provide wildland fire support to federal land management agencies in Oregon and Washington.

Two hundred thirty-three soldiers from the 14th Brigade Engineer Battalion based out of Joint Base Lewis-McChord, Washington are deployed in support of the August Complex.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

Two MAFFS C-130 airtankers and support personnel from the 146th Airlift Wing (California Air National Guard) and one MAFFS C-130 airtanker and support personnel from each the 153rd Airlift Wing (Wyoming Air National Guard) and the 152nd Airlift Wing (Nevada Air National Guard) have been deployed to support wildland fire operations in California.

One fire suppression crew and one overhead personnel from Quebec, Canada are supporting fire suppression efforts in northern California.

North Complex, Plumas NF, USFS. Unified command between IMT 1 (CA Team 4) and IMT 1 (Cal Fire Team 4). One mile southwest of Crescent Mills, CA. Timber and brush. Active fire behavior with running, spotting and isolated torching. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

August Complex West Zone, Mendocino Unit, Cal Fire. IMT 1 (Cal Fire Team 5). Four miles northeast of Covelo, CA. Timber, chaparral and tall grass. Active fire behavior with single tree torching, backing and flanking. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

August Complex (2 fires), Mendocino NF, USFS. Area Command (Jalbert), IMT 1 (CA Team 5), IMT 1 (GB Team 2) and IMT 1 (AK Team 1). Fourteen miles northwest of Elk Creek, CA. Timber, chaparral and tall grass. Active fire behavior with running, flanking and torching. Several communities threatened. Evacuations, area, road and trail closures in effect.

Slater, Klamath NF, USFS. IMT 1 (NR Team 2) and IMT 2 (CA Team 10). IMT is also managing the Devil fire. Five miles northeast of Happy Camp, CA. Timber and brush. Moderate fire behavior with flanking, backing and isolating torching. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Devil, Klamath NF, USFS. Five miles north of Seiad, CA. Timber. Moderate fire behavior with flanking, backing and creeping. Numerous residences threatened. Structures threatened. Area, road and trail closures in effect.

Red Salmon Complex (2 fires), Six Rivers NF, USFS. NIMO (Quesinberry) and IMT 2 (CA Team 14). Fourteen miles northeast of Willow Creek, CA. Timber and closed timber litter. Active fire behavior with single tree torching, backing and creeping. Structures threatened. Evacuations, area, road and trail closures in effect.

Fork, Eldorado NF, USFS. IMT 2 (SW Team 4) Fifteen miles northeast of Pollock Pines, CA. Timber and brush. Moderate fire behavior with flanking and backing. Numerous structures threatened. Area, road and trail closures in effect.

Fox, Klamath NF, USFS. Three miles east of Callahan, CA. Timber and brush. Moderate fire behavior with flanking and backing. Structures threatened. Area, road and trail closures in effect.

Woodward, Point Reyes National Seashore, NPS. Three miles southwest of Olema, CA. Timber, brush and chaparral. Minimal fire behavior with creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

CZU Aug Lightning Complex, San Mateo-Santa Cruz Unit, Cal Fire. Eight miles east of Pescadero, CA. Timber, chaparral and closed timber litter. Minimal fire behavior with smoldering. Numerous residences and energy infrastructure threatened. Area, road and trail closures in effect.

Area Command Team (Stutler) has been mobilized to support wildland fire in northwest Oregon.

Riverside, Mt. Hood NF, USFS. IMT 1 (SW Team 1). Eight miles southeast of Estacada, OR. Timber, brush and short grass. Minimal fire behavior with smoldering. Several communities threatened. Evacuations, area, road and trail closures in effect.

Lionshead, Warm Springs Agency, BIA. IMT 1 (RM Team 1). Twenty miles west of Warm Springs, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Beachie Creek, Willamette NF, USFS. IMT 1 (SW Team 2). Six miles north of Detroit, OR. Timber. Minimal fire behavior with smoldering. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Archie Creek, Umpqua NF, USFS. IMT 1 (SA Red Team). Twenty miles east of Glide, OR. Timber and brush. Moderate fire behavior with backing, flanking and torching. Numerous residences threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

OR-WIF-200430, Willamette NF, USFS. IMT 1 (ODF Team 3). Thirty-five miles east of Eugene, OR. Timber and brush. Moderate fire behavior with creeping, flanking and backing. Numerous structures threatened. Area, road and trail closures in effect.

Brattain, Fremont-Winema NF, USFS. IMT 2 (EA Silver Team). Eight miles south of Paisley, OR. Timber and brush. Active fire behavior with short crown runs, wind-driven runs and long-range spotting. Numerous structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

S. Obenchain, Medford Unit, Oregon DOF. IMT 2 (PNW Team 8). Five miles east of Eagle Point, OR. Timber and brush. Moderate fire behavior with creeping, single tree torching and wind-driven runs. Several communities threatened. Evacuations, area and road closures in effect.

Thielsen, Umpqua NF, USFS. IMT 2 (SA Gold Team). Sixteen miles west of Chemult, OR. Timber and brush. Minimal fire behavior with isolated torching, creeping and smoldering. Numerous structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Big Hollow, Gifford Pinchot NF, USFS. IMT 2 (NW Team 12). Twenty miles north of Stevenson, WA. Timber. Minimal fire behavior with creeping and smoldering. Structures threatened. Evacuations, area, road and trail closures in effect.

Inchelium Complex (3 fires), Colville Agency, BIA. IMT 2 (NW Team 7). One mile north of Inchelium, WA. Timber and brush. Active fire behavior with flanking, backing and single tree torching. Numerous structures threatened.

Two Four Two, Fremont-Winema NF, USFS. IMT 1 (ODF Team 2). Six miles northeast of Chiloquin, OR. Timber, brush and tall grass. Moderate fire behavior with creeping and smoldering. Area, road and trail closures in effect.

Echo Mtn. Complex (2 fires), Toledo Unit, Oregon DOF. IMT 1 (ODF Team 1). Four miles east of Lincoln City, OR. Timber, brush and tall grass. Minimal fire behavior with creeping and smoldering. Communities of Otis and Lincoln City threatened. Evacuations and road closures in effect.

Cold Creek, Okanogan-Wenatchee NF, USFS. IMT 2 (NW Team 10) mobilizing. Thirty-eight miles west of Yakima, WA. Timber. Active fire behavior with creeping, group torching and spotting. Numerous structures threatened. Area, road and trail closures in effect.

North Cascade Complex (3 fires), Molalla Unit, Oregon DOF. One mile south of Molalla, OR. Timber and tall grass. Moderate fire behavior with smoldering and creeping. Numerous structures threatened. Evacuations, area and road closures in effect.

Cold Springs, Colville Agency, BIA. Four miles southeast of Omak, WA. Brush and grass. Minimal fire behavior with smoldering. Numerous structures threatened. Area, road and trail closures in effect.

Area Command Team (Sexton) has been mobilized to support wildland fire in southern California.

Creek, Sierra NF, USFS. Unified command between IMT 1 (Cal Fire Team 1) and IMT 1 (GB Team 1). Thirty-five miles northeast of Clovis, CA. Timber, chaparral and tall grass. Moderate fire behavior with backing, wind-driven runs and single tree torching. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Bobcat, Angeles NF, USFS. IMT 1 (CA Team 1). Twelve miles northeast of Pasadena, CA. Chaparral, brush and tall grass. Active fire behavior with crowning, torching and long-range spotting. Several communities, communications and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

SQF Complex (2 fires), Sequoia NF, USFS. IMT 1 (NR Team 1) and IMT 1 (Cal Fire Team 6). Thirty-three miles east of Porterville, CA. Timber and chaparral. Active fire behavior with running, group torching and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

El Dorado, San Bernardino Unit, Cal Fire. Transfer of command from IMT 2 (CA Team 11) to IMT 2 (CA Team 13) will occur today. Three miles northeast of Yucaipa, CA. Timber, chaparral and tall grass. Active fire behavior with uphill runs, wind-driven runs and spotting. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Dolan, Los Padres NF, USFS. IMT 1 (PNW Team 2). Ten miles south of Big Sur, CA. Timber, brush and chaparral. Active fire behavior with uphill runs, flanking and spotting. Numerous residences and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Bullfrog, Sierra NF, USFS. Forty-three miles northeast of Clovis, CA. Timber, brush and short grass. Moderate fire behavior with creeping, single tree torching and backing. Area, road and trail closures in effect.

Valley, Cleveland NF, USFS. Nineteen miles northeast of Chula Vista, CA. Chaparral and tall grass. Minimal fire behavior creeping and smoldering. Area closures in effect.

Moraine, Sequoia & Kings Canyon NP, NPS. Five miles northeast of Kanawyers, CA. Timber and brush. Minimal fire behavior with creeping and smoldering.

Badger, Sawtooth NF, USFS. IMT 2 (GB Team 5). Twenty miles southwest of Oakley, ID. Timber. Extreme fire behavior with wind-driven runs, crowning and short-range spotting. Structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Woodhead, Payette NF, USFS. IMT 2 (GB Team 4). Started on state land 20 miles west of Council, ID. Timber, brush and short grass. Moderate fire behavior with flanking, group torching and short-range spotting. Numerous structures threatened. Evacuations, area and road closures in effect. Reduction in acreage due to more accurate mapping.

Buck, Boise NF, USFS. Thirty miles northeast of Cascade, ID. Timber. Active fire behavior with flanking, torching and spotting. Structures threatened. Area and road closures in effect.

East Fork, Ashley NF, USFS. IMT 2 (GB Team 7). IMT is also managing the Center Creek Trail fire. Fourteen miles northeast of Hanna, UT. Timber. Active fire behavior with short crown runs, group torching and uphill runs. Structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Center Creek Trail, Ashley NF, USFS. Five miles northeast of Moon Lake, UT. Timber. Minimal fire behavior with smoldering. Area, road and trail closures in effect.

Slink, Humboldt-Toiyabe NF, USFS. Three miles west of Coleville, CA. Timber, brush and short grass. Moderate fire behavior with creeping, single tree torching and smoldering. Structures threatened. Area, road and trail closures in effect.

Trap, Sawtooth NF, USFS. Nine miles northeast of Stanley, ID. Timber. Moderate fire behavior with isolated torching and creeping. Structures threatened. Area and road closures in effect. Reduction in acreage due to more accurate mapping.

Grouse, Boise NF, USFS. Thirty-five miles northeast of Glenns Ferry, ID. Timber and brush. Moderate fire behavior with backing, flanking and torching. Numerous structures threatened. Area and road closures in effect. Last narrative report unless significant activity occurs.

William, Northwest Area, Utah DOF. IMT 2 (GB Team 3). Started on private land two miles south of Santaquin, Utah. Timber short grass. Active fire behavior with smoldering, flanking and uphill runs. Structures threatened. Area, road and trail closures in effect.

Leggit, Sawtooth NF, USFS. Five miles east of Atlanta, ID. Timber. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

* **White Sage**, Dugway Proving Ground, DOD. Twenty-six miles southwest of Terra, UT. Brush and short grass. Minimal fire behavior with baking, creeping and torching. Last narrative report unless significant activity occurs.

Shissler, Nez Perce-Clearwater NF, USFS. Previously reported incident. Thirteen miles east of Elk City, MT. Timber. Active fire behavior with wind-driven runs, group torching and short-range spotting. Structures threatened. Area, road and trail closures in effect. Last narrative report unless significant activity occurs.

Bernard, Idaho Panhandle NF, USFS. Two miles west of Lakeview, ID. Timber and brush. Moderate fire behavior with isolated torching, backing and creeping. Area, road and trail closures in effect.

Bridger Foothills, Custer Gallatin NF, USFS. Transfer of command from IMT 2 (NR Team 5) back to the local unit will occur tomorrow. Three miles northeast of Bozeman, MT. Timber, brush and short grass. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

Predictive Services Discussion: An upper low will move over the Northern Rockies with a cold front pushing south and east through the Great Basin and into the central Rocky Mountains. Elevated to critical fire weather conditions are likely along and ahead of the cold front stretching from southeast California into eastern Wyoming. Rain showers with embedded isolated to widely scattered thunderstorms are expected across the inland Pacific Northwest, northern Great Basin, and central/northern Rocky Mountains. Visibility and air quality will improve across many locations due to the increased winds and shower activity. Rain bands from a tropical disturbance in the western Gulf of Mexico will bring potentially heavy rainfall to portions of the South Texas coast.

Effects of Smoke Exposure

Firefighter Health First Aid

Wildland smoke is a complex mix of chemicals and particles, which varies depending on the fuels, soil, weather, fire intensity, and the burning phase of the fire. Some of the chemicals and particles that are present can pose a health risk particularly with higher exposures or long duration exposures. Wildland fire smoke can cause irritating respiratory symptoms and, over time, could possibly increase the risk of developing long-term illnesses.

While the makeup of smoke varies, here are just a few of the ways smoke could impact your health:

- **Carbon Monoxide (CO)** – Exposure to CO from wildland fire smoke or from other sources (such as exhaust from chainsaws, engines, or pumps) may lead to a variety of symptoms including impaired vision and judgement, headaches, and fatigue. In extreme situations, high levels of exposure can cause asphyxiation, which can lead to death.
- **Fine Particulate Matter (PM)** – Wildland fire smoke contains very small particles or PM which can penetrate deep into your lungs. Long-term exposure can affect the lungs and heart, especially in individuals with underlying health issues (e.g., high blood pressure, high cholesterol), smokers, and those who work in stressful environments.
- **A variety of other chemicals**, such as polycyclic aromatic hydrocarbons (PAHs) and volatile organic compounds (VOCs), are also present in wildland fire smoke. These may further increase your risk of short-term or even long-term health effects.
- **COVID-19** – Susceptibility to COVID-19 resulting from smoke exposure has not yet been specifically studied, but related studies show exposure to wildland smoke can lead to an increased susceptibility to respiratory infections, including pneumonia and bronchitis. Additionally, severity of infections or symptoms may be increased due to the respiratory tract's immune responses to smoke exposure. Thus, it's assumed that risk of COVID-19 infection would be high for firefighters with respiratory issues resulting from wildland smoke exposure.

Smoke is part of the wildland fire environment. Now more than ever, firefighters and incident overhead should be on the lookout for opportunities to reduce exposure. Incident overhead can think strategically about assigning wildland firefighting tasks in certain work environments and ask **does our workforce really need to be in the smoke to meet the operational objectives?** Other considerations include:

- Is camp located where smoke accumulates?
- Is the crew dispersed holding a smoke-choked road when the probability of ignition is near zero?
- Are firefighters mopping-up an area that poses no operational threat?

Discussion: There are certain tasks that have been associated with higher exposures to smoke. Below are some of those tasks. How can you and your crew realistically reduce smoke and PM exposure during these (and other) tasks?

- Mop-up
- Holding

- Line construction
- Firing

Think about and discuss this partial quote from an article in [Two More Chains: Summer 2017](#):

"As CO exposure increases, your ability to think clearly decreases. Being in smoke you don't need to be in is the epitome of not working "smarter." In fact, it is actually working dumber."
