NIMO (Houseman) has been assigned to COVID-19 support at Forest Service headquarters in Washington, D.C.

NIMO (Reinarz) has been assigned to provide wildland fire support to California.

NIMO (Day) has been assigned to provide wildland fire support to federal land management agencies in Oregon and Washington.

Two hundred thirty-three soldiers from the 14th Brigade Engineer Battalion based out of Joint Base Lewis-McChord, Washington are deployed in support of the August Complex.

Two hundred thirty-four Marines from the 7th Engineer Support Battalion, 1st Marine Logistics Group, 1 Marine Expeditionary Force based out of Camp Pendleton, California are deployed in support of the Creek fire.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

Two MAFFS C-130 airtankers and support personnel from the 146th Airlift Wing (California Air National Guard) and one MAFFS C-130 airtanker and support personnel from each the 153rd Airlift Wing (Wyoming Air National Guard) and the 152nd Airlift Wing (Nevada Air National Guard) have been deployed to support wildland fire operations in California.

One fire suppression crew and one overhead personnel from Canada are supporting fire suppression efforts in northern California.

Seven fire suppression crews, 18 fire engines and 55 overhead personnel from Canada are supporting fire suppression efforts in Oregon.

August Complex West Zone, Mendocino Unit, Cal Fire. IMT 1 (Cal Fire Team 5). Four miles northeast of Covelo, CA. Timber, chaparral and tall grass. Moderate fire behavior with group torching, uphill runs and backing. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

North Complex, Plumas NF, USFS. Unified command between IMT 1 (CA Team 4) and IMT 1 (Cal Fire Team 4). IMT 2 (RM Team Black) mobilizing. One mile southwest of Crescent Mills, CA. Timber and brush. Active fire behavior with running, spotting and isolated torching. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

August Complex (2 fires), Mendocino NF, USFS. Area Command Team (Jalbert), IMT 1 (GB Team 2) and IMT 1 (AK Team 1). Fourteen miles northwest of Elk Creek, CA. Timber, chaparral and tall grass. Moderate fire behavior with backing, flanking and running. Several communities threatened. Evacuations, area, road and trail closures in effect.

Slater, Klamath NF, USFS. IMT 1 (NR Team 2). IMT is also managing the Devil fire. Five miles northeast of Happy Camp, CA. Timber and brush. Moderate fire behavior with backing, isolating torching and short-range spotting. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Devil, Klamath NF, USFS. Five miles north of Seiad, CA. Timber. Moderate fire behavior with backing, creeping and isolated torching. Numerous residences threatened. Area and trail closures in effect.

Fork, Eldorado NF, USFS. IMT 2 (SW Team 4) Fifteen miles northeast of Pollock Pines, CA. Timber and brush. Minimal fire behavior with creeping, flanking and backing. Numerous structures threatened. Area, road and trail closures in effect.

Red Salmon Complex (2 fires), Six Rivers NF, USFS. IMT 2 (CA Team 14). Fourteen miles northeast of Willow Creek, CA. Timber and closed timber litter. Active fire behavior with uphill runs, flanking and backing. Structures threatened. Evacuations, area, road and trail closures in effect.

Fox, Klamath NF, USFS. Three miles east of Callahan, CA. Timber and brush. Moderate fire behavior with flanking and backing. Structures threatened. Area, road and trail closures in effect.

Woodward, Point Reyes National Seashore, NPS. Three miles southwest of Olema, CA. Timber, brush and chaparral. Moderate fire behavior with backing, creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

CZU Aug Lightning Complex, San Mateo-Santa Cruz Unit, Cal Fire. Eight miles east of Pescadero, CA. Timber, chaparral and closed timber litter. Minimal fire behavior with smoldering. Numerous residences and energy infrastructure threatened. Area, road and trail closures in effect.

Area Command Team (Stutler) has been mobilized to support wildland fire in northwest Oregon.

Riverside, Mt. Hood NF, USFS. IMT 1 (SW Team 1). One mile southeast of Estacada, OR. Timber, brush and short grass. Minimal fire behavior with creeping and smoldering. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Lionshead, Warm Springs Agency, BIA. IMT 1 (RM Team 1). Twenty miles west of Warm Springs, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Several communities and energy

infrastructure threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Beachie Creek, Willamette NF, USFS. IMT 1 (SW Team 2). Six miles north of Detroit, OR. Timber. Minimal fire behavior with smoldering and creeping. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Archie Creek, Umpqua NF, USFS. IMT 1 (SA Red Team). Twenty miles east of Glide, OR. Timber and brush. Moderate fire behavior. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

OR-WIF-200430, Willamette NF, USFS. IMT 1 (ODF Team 3). Thirty-five miles east of Eugene, OR. Timber and brush. Moderate fire behavior with creeping, flanking and backing. Numerous structures threatened. Area, road and trail closures in effect.

S. Obenchain, Medford Unit, Oregon DOF. IMT 2 (NW Team 8). Five miles east of Eagle Point, OR. Timber and brush. Moderate fire behavior with creeping, wind-driven runs and single tree torching. Numerous structures threatened. Evacuations, area and road closures in effect.

Thielsen, Umpqua NF, USFS. IMT 2 (SA Gold Team). Sixteen miles west of Chemult, OR. Timber and brush. Moderate fire behavior with creeping, smoldering and single tree torching. Numerous structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Brattain, Fremont-Winema NF, USFS. IMT 2 (EA Silver Team). Eight miles south of Paisley, OR. Timber and brush. Active fire behavior with backing, creeping and smoldering. Numerous structures and sage-grouse habitat threatened. Area, road and trail closures in effect.

Inchelium Complex (3 fires), Colville Agency, BIA. Transfer of command from IMT 2 (NW Team 7) back to the local unit will occur tomorrow. One mile north of Inchelium, WA. Timber and brush. Moderate fire behavior with backing and creeping. Numerous structures threatened.

Two Four Two, Fremont-Winema NF, USFS. Transfer of command from IMT 1 (ODF Team 2) back to the local unit will occur tomorrow. Six miles northeast of Chiloquin, OR. Timber, brush and tall grass. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

North Cascade Complex (3 fires), Molalla Unit, Oregon DOF. One mile south of Molalla, OR. Timber and tall grass. Minimal fire behavior with smoldering. Numerous structures threatened. Evacuations and road closures in effect.

Big Hollow, Gifford Pinchot NF, USFS. Transfer of command from IMT 2 (NW Team 12) back to the local unit occurred yesterday. Twenty miles north of Stevenson, WA. Timber. Minimal fire behavior with backing, creeping and smoldering. Structures threatened. Evacuations, area, road and trail closures in effect.

Cold Creek, Okanogan-Wenatchee NF, USFS. Thirty-eight miles west of Yakima, WA. Timber and hardwood litter. Moderate fire behavior with creeping and smoldering. Numerous structures threatened. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

* **Ritter**, John Day Unit, ODF. Seven miles north of Long Creek, OR. Brush and tall grass. Active fire behavior with running. Structures threatened.

Echo Mtn. Complex (2 fires), Toledo Unit, Oregon DOF. Four miles east of Lincoln City, OR. Timber, brush and tall grass. No new information.

Area Command Team (Sexton) has been mobilized to support wildland fire in southern California.

Creek, Sierra NF, USFS. Unified command between IMT 1 (Cal Fire Team 1) and IMT 1 (GB Team 1). Thirty-five miles northeast of Clovis, CA. Timber, chaparral and tall grass. Active fire behavior with uphill runs, flanking and single tree torching. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

SQF Complex (2 fires), Sequoia NF, USFS. IMT 1 (NR Team 1), IMT 1 (Cal Fire Team 6) and IMT 1 (CA Team 2). Thirty-three miles east of Porterville, CA. Timber and chaparral. Active fire behavior with flanking, backing and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Bobcat, Angeles NF, USFS. IMT 1 (CA Team 1). Twelve miles northeast of Pasadena, CA. Chaparral, brush and tall grass. Active fire behavior with flanking, backing and torching. Several communities, communications and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

El Dorado, San Bernardino Unit, Cal Fire. IMT 2 (CA Team 13). Three miles northeast of Yucaipa, CA. Timber, chaparral and tall grass. Active fire behavior with flanking, backing and single tree torching. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Dolan, Los Padres NF, USFS. IMT 1 (PNW Team 2), NIMO (Quesinberry) and IMT 2 (CA Team 15). Ten miles south of Big Sur, CA. Timber, brush and chaparral. Moderate fire behavior with uphill runs, flanking and smoldering. Numerous structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Snow, Riverside Unit, Cal Fire. Eight miles northwest of Palm Springs, CA Timber, brush and tall grass. Minimal fire behavior with creeping, smoldering and isolated torching. Energy infrastructure threatened.

Bullfrog, Sierra NF, USFS. Forty-three miles northeast of Clovis, CA. Timber, brush and short grass. Moderate fire behavior with torching, creeping and backing. Area, road and trail closures in effect.

Moraine, Sequoia & Kings Canyon NP, NPS. Five miles northeast of Kanawyers, CA. Timber and brush. Minimal fire behavior with creeping and smoldering.

Valley, Cleveland NF, USFS. Nineteen miles northeast of Chula Vista, CA. Chaparral and tall grass. Minimal fire behavior creeping and smoldering. Area closures in effect.

Predictive Services Discussion: An upper-level shortwave trough will move over the Northern Rockies as a stronger upper-level trough approaches the Pacific Northwest with widely scattered showers across western Washington and portions of the Northern Rockies. Gusty winds and low RH are expected along the Sierra Front and portions of the Great Basin and Wyoming. Isolated thunderstorms are possible across the broader Four Corners region into Wyoming. Tropical Storm Beta will continue to produce heavy rainfall and storm surge flooding to portions of the east Texas and Louisiana coasts with heavy rain also expected farther inland across east/central Texas and the Lower Mississippi Valley. A cold front will continue moving east into the Great Lakes with outer rain bands from Hurricane Teddy reaching eastern Maine.

Communications (LCES)

Fire Communications Category

Effective communication is a critical backbone of safe and successful operations.

- Discuss the factors that can affect radio communication at the incident.
 - Knowledge of the radio issued to the individuals.
 - Net control, frequencies.
 - Line-of-sight restrictions.
 - Antenna polarization effect (direction of the antenna).
 - Minimizing noise interference.
 - Wide band vs. narrow band.
 - Potentially unfamiliar local jargon (e.g. Coulee, Candle stick, fence post, etc.)
- How can you mitigate potential problems?
 - Implement effective communication procedures--be brief, use clear text, and to-the-point.
 - Give a good comprehensive briefing. (Refer to the Briefing Checklist inside the back cover of the Incident Response Pocket Guide.)
 - Confirm that relayed information is received and understood.
 - Keep a continuous information flow (e.g., updates on weather, fire behavior, work progress; changes in strategy/tactics; arrival of additional resources; solicit feedback).
 - Establish emergency check-in procedures.
 - Provide a minimum of 4 radios per 20-person firefighter crew.
- The Five Communication Responsibilities for All Firefighters:
 - Brief others.
 - Debrief your actions.
 - Communicate hazards to others.
 - Acknowledge messages.
 - Ask if you don't know.
