NIMO (Houseman) has been assigned to COVID-19 support at Forest Service headquarters in Washington, D.C.

NIMO (Reinarz) has been assigned to provide wildland fire support to California.

NIMO (Day) has been assigned to provide wildland fire support to federal land management agencies in Oregon and Washington.

Two hundred thirty-four Marines from the 7<sup>th</sup> Engineer Support Battalion, 1<sup>st</sup> Marine Logistics Group, 1 Marine Expeditionary Force based out of Camp Pendleton, California are deployed in support of the Creek fire.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

Two MAFFS C-130 airtankers and support personnel from the 146th Airlift Wing (California Air National Guard) and one MAFFS C-130 airtanker and support personnel from each the 153rd Airlift Wing (Wyoming Air National Guard) and the 152<sup>nd</sup> Airlift Wing (Nevada Air National Guard) have been deployed to support wildland fire operations in California.

Eight fire suppression crews and four overhead personnel from Canada are supporting fire suppression efforts in northern California.

Seven fire suppression crews, 18 fire engines and 54 overhead personnel from Canada are supporting fire suppression efforts in Oregon.

Five fire suppression crews and four overhead personnel from Mexico are supporting fire suppression efforts in southern California.

**North Complex**, Plumas NF, USFS. IMT 1 (Cal Fire Team 4) and IMT 2 (RM Team Black). One mile southwest of Crescent Mills, CA. Timber. Active fire behavior with creeping, isolated torching and spotting. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

**August Complex** (2 fires), Mendocino NF, USFS. Area Command Team (Jalbert), NIMO (Quesinberry) and IMT 1 (AK Team 1). IMT 1 (PNW Team 2) mobilizing. Fourteen miles northwest of Elk Creek, CA. Timber, chaparral and tall grass. Extreme fire behavior with crowning, running and long-range spotting. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Slater**, Klamath NF, USFS. IMT 1 (NR Team 2). IMT is also managing the Devil fire. Five miles northeast of Happy Camp, CA. Timber and brush. Moderate fire behavior with backing, creeping and flanking. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Devil**, Klamath NF, USFS. Five miles north of Seiad, CA. Timber. Moderate fire behavior with backing, flanking and creeping. Area and trail closures in effect.

**Red Salmon Complex** (2 fires), Six Rivers NF, USFS. IMT 2 (NW Team 10). Fourteen miles northeast of Willow Creek, CA. Timber and closed timber litter. Active fire behavior short crown runs, uphill runs and short-range spotting. Communities of Hoopa and Willow Creek threatened. Evacuations, area, road and trail closures in effect.

**Fox**, Klamath NF, USFS. Three miles east of Callahan, CA. Timber and brush. Minimal fire behavior with creeping and smoldering. Community of Callahan and communication infrastructure threatened. Area, road and trail closures in effect.

**August Complex West Zone**, Mendocino Unit, Cal Fire. IMT 1 (Cal Fire Team 5). Four miles northeast of Covelo, CA. Timber, chaparral and tall grass. Active fire behavior with wind-driven runs, long-range spotting and torching. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Fork**, Eldorado NF, USFS. Fifteen miles northeast of Pollock Pines, CA. Timber and brush. Minimal fire behavior with creeping, backing and smoldering. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect.

**Woodward**, Point Reyes National Seashore, NPS. Three miles southwest of Olema, CA. Timber, brush and chaparral. Moderate fire behavior with backing, creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

\* **Zogg**, Shasta-Trinity Unit, Cal Fire. IMT 1 (Cal Fire Team 2) mobilizing. Nine miles southwest of Redding, CA. Chaparral, brush and short grass. Extreme fire behavior with running, wind-driven runs and long-range spotting. Communities of Igo and Ono threatened. Evacuations, area, road and trail closures in effect.

\* **Glass**, Sonoma-Lake Napa Unit, Cal Fire. IMT 1 (Cal Fire Team 3) mobilizing. Thirteen miles northwest of Napa, CA. Tall grass, brush and timber. Extreme fire behavior with wind-driven runs, short-range spotting and running. Several communities threatened. Evacuations in effect.

Area Command Team (Sexton) has been mobilized to support wildland fire in southern California.

**Bobcat**, Angeles NF, USFS. IMT 1 (CA Team 1). IMT 2 (CA Team 11) mobilizing. Twelve miles northeast of Pasadena, CA. Chaparral, brush and tall grass. Moderate fire behavior with backing, creeping and smoldering. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

**SQF Complex** (2 fires), Sequoia NF, USFS. IMT 1 (CA Team 2) and IMT 1 (Cal Fire Team 6). Thirty-three miles east of Porterville, CA. Timber and chaparral. Active fire behavior with short-range spotting, creeping and group torching. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Creek**, Sierra NF, USFS. Unified command. IMT 1 (CA Team 5). Transfer of command from IMT 1 (GB Team 1) to IMT 2 (NR Team 4) will occur today. Thirty-five miles northeast of Clovis, CA. Timber, chaparral and tall grass. Active fire behavior with torching, creeping and smoldering. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Dolan**, Los Padres NF, USFS. IMT 2 (CA Team 15). Ten miles south of Big Sur, CA. Brush, chaparral and short grass. Moderate fire behavior with backing, smoldering and creeping. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**El Dorado**, San Bernardino Unit, Cal Fire. IMT 2 (CA Team 13). Three miles northeast of Yucaipa, CA. Timber, chaparral and brush. Moderate fire behavior with uphill runs, smoldering and backing. Numerous structures threatened. Area, road and trail closures in effect.

**Snow**, Riverside Unit, Cal Fire. Eight miles northwest of Palm Springs, CA. Timber, brush and tall grass. Minimal fire behavior with smoldering. Trail closures in effect.

**Moraine**, Sequoia & Kings Canyon NP, NPS. Five miles northeast of Kanawyers, CA. Timber, brush and tall grass. Minimal fire behavior with creeping and smoldering.

**Beachie Creek**, Willamette NF, USFS. Transfer of command from IMT 1 (SW Team 2) to IMT 1 (PNW Team 3) will occur tomorrow. IMT is also managing the Riverside fire. Six miles north of Detroit, OR. Timber and brush. Minimal fire behavior with smoldering. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Riverside**, Mt. Hood NF, USFS. One mile southeast of Estacada, OR. Closed timber litter. Minimal fire behavior. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Lionshead**, Warm Springs Agency, BIA. IMT 2 (NW Team 13). Twenty miles west of Warm Springs, OR. Timber and brush. Minimal fire behavior with backing, creeping and smoldering. Several communities threatened. Evacuations, area, road and trail closures in effect.

**Archie Creek**, Umpqua NF, USFS. IMT 1 (SA Red Team). IMT is also managing the Thielsen fire. Twenty miles east of Glide, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Numerous residences threatened. Evacuations have been lifted. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Thielsen**, Umpqua NF, USFS. Sixteen miles west of Chemult, OR. Timber and brush. Minimal fire behavior with smoldering. Numerous structures threatened. Evacuations have been lifted. Area, road and trail closures in effect.

**S. Obenchain**, Medford Unit, Oregon DOF. Five miles east of Eagle Point, OR. Timber and brush. Minimal fire behavior with smoldering and creeping. Structures threatened. Area and road closures in effect.

**North Cascade Complex** (3 fires), Molalla Unit, Oregon DOF. One mile south of Molalla, OR. Timber and tall grass. Minimal fire behavior.

**Brattain**, Fremont-Winema NF, USFS. Eight miles south of Paisley, OR. Timber and brush. Moderate fire behavior with creeping and smoldering. Sage-grouse habitat threatened. Area, road and trail closures in effect.

**Two Four Two**, Fremont-Winema NF, USFS. Six miles northeast of Chiloquin, OR. Timber, brush and tall grass. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

**Cameron Peak**, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. Transfer of command from IMT 2 (SW Team 3) to IMT 2 (NW Team 6) will occur on 9/29. Fifteen miles southwest of Redfeather Lakes, CO. Timber. Active fire behavior with short crown runs, single tree torching and smoldering. Numerous residences threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Mullen**, Medicine Bow-Routt NF and Thunder Basin National Grassland, USFS. IMT 2 (RM Team Blue). Thirty-eight miles west of Laramie, WY. Timber. Active fire behavior with short crown runs, uphills runs and torching. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Middle Fork**, Medicine Bow-Routt NF and Thunder Basin National Grassland, USFS. Ten miles north of Steamboat Springs, CO. Timber. Minimal fire behavior with isolated torching, flanking and backing. Structures threatened. Area and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Williams Fork**, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. Fifteen miles southwest of Fraser, CO. Timber. Active fire behavior with backing, single tree torching and spotting. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Predictive Services Discussion:** Critical fire weather will continue for Northern California and portions of Southern California due to breezy offshore winds and very hot/dry conditions. Offshore winds are likely west of the Cascade Crest in Oregon as well, although humidities generally stay above critical values. Gusty winds are expected for much of the Great Plains and low humidities will result in elevated fire weather concerns for eastern Wyoming and Colorado as well as the Texas and Oklahoma Panhandles. Very dry conditions continue for the Southwest and Great Basin. Little to no measurable precipitation is expected across the West.

## Developing a Learning Organization

*Leadership Category*



Leaders evaluate performance at all levels to understand the causal factors of successes and failures. All those involved learn incrementally, applying today's lessons to the next assignment. This focus on continuous improvement brings with it a responsibility to share lessons learned throughout the organization. In a learning organization, leaders treat honest mistakes as opportunities to learn and do better next time. Understanding that failure is a part of learning, they establish command climates in which followers are motivated by a desire to succeed rather than fear of failure. At the crew level, conducting regular After Action Reviews is one of the most powerful tools a leader has for building effective and cohesive teams.

### **Discussion Points:**

- Discuss the relationship between developing a learning organization and safety.
- What happens when honest mistakes are punished rather than used as a learning opportunity?
- How are mistakes and failure dealt with within your crew / organization?
- What was your crew's/organization's most recent learning moment?
