**Backbone**, Coconino NF, USFS. IMT 1 (SW Team 1). Eleven miles west of Pine, AZ. Short grass and brush. Active fire behavior with short crown runs, wind-driven runs and long-range spotting. Numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Wyrick**, Apache-Sitgreaves NF, USFS. IMT 2 (SW Team 5). IMT is also managing the West Chev fire. Two miles northwest of Heber, AZ. Timber and short grass. Active fire behavior with uphill runs, group torching and spotting. Community of Heber-Overgaard and energy infrastructure threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**West Chev**, Apache-Sitgreaves NF, USFS. Thirteen miles northwest of Heber, AZ. Timber and short grass. Active fire behavior with uphill runs, group torching and spotting. Area, road and trail closures in effect.

**Rafael**, Prescott NF, USFS. IMT 1 (SW Team 2) mobilizing. Three miles northeast of Perkinsville, AZ. Brush, short grass and timber. Extreme fire behavior with wind-driven runs, uphill runs and crowning. Numerous structures threatened. Area, road and trail closures in effect.

**Walnut**, Southeast District, Arizona DOF. Fourteen miles northeast of Benson, AZ. Short grass, brush and chaparral. Active fire behavior with wind-driven runs, running and flanking. Structures and infrastructure threatened. Evacuations in effect. Last narrative report unless significant activity occurs.

**Horton**, Apache-Sitgreaves NF, USFS. Five miles north of Hannigan, AZ. Timber and heavy slash. Active fire behavior with uphill runs, flanking and backing. Residences threatened. Area closures in effect.

**Pinnacle**, Coronado NF, USFS. IMT 2 (SW Team 3). Thirteen miles south of Bylas, AZ. Short grass, brush and timber. Moderate fire behavior with flanking, backing and smoldering. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Telegraph**, Tonto NF, USFS. IMT 2 (NW Team 6). Two miles southeast of Superior, AZ. Short grass and brush. Moderate fire behavior with flanking, backing and creeping. Numerous residences and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Rock Butte**, Prescott NF, USFS. Three miles northwest of Drake, AZ. Short grass and brush. Moderate fire behavior with group torching, creeping and smoldering. Area closures in effect.

**Johnson**, Gila NF, USFS. Previously reported incident. Twenty miles north of Silver City, NM. Timber and brush. Moderate fire behavior with backing and creeping. Structures threatened. Area, road and trail closures in effect. Last narrative report unless significant activity occurs.

**Alamo**, Coronado NF, USFS. Ten miles west of Nogales, AZ. Short grass and brush. Moderate fire behavior with uphill runs, flanking and backing. Structures threatened.

**Slate**, Coconino NF, USFS. Twenty-three miles northwest of Flagstaff, AZ. Chaparral and timber. Minimal fire behavior with smoldering.

**Rincon**, Sante Fe NF, USFS. Twenty-five miles northwest of Las Vegas, NM. Timber and brush. No new information.

**Sylvan**, White River NF, USFS. IMT 1 (RM Team 1) mobilizing. Fifteen miles south of Eagle, CO. Timber and slash. Active fire behavior with wind-driven runs, spotting and backing. Structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

\* **Muddy Slide**, Medicine Bow-Routt NF, Thunder Basin National Grassland, USFS. IMT 2 (RM Team Blue) mobilizing. Eighteen miles west of Kremmling, CO. Timber. Extreme fire behavior with crowning, wind-driven runs and long-range spotting. Structures threatened. Evacuations in effect.

**Oil Springs**, White River Field Office, BLM. IMT 2 (GB Team 3). Forty-two miles north of Grand Junction, CO. Timber and brush. Active fire behavior with uphill runs, short crown runs and short-range spotting. Structures and energy infrastructure threatened. Evacuations and road closures in effect.

**West**, Little Snake Field Office, BLM. IMT 2 (RM Team Black). Thirty-five miles southeast of Rock Springs, WY. Timber and brush. Active fire behavior with wind-driven runs, group torching and short crown runs. Structures, Sage-grouse habitat and energy infrastructure threatened. Road closures in effect. Reduction in acreage due to more accurate mapping.

**Trail Canyon**, Ute Mountain Agency, BIA. Ten miles northwest of Red Mesa, CO. Brush. Minimal fire behavior with isolated torching, creeping and smoldering.

**Collom**, Moffat County. Twelve miles northwest of Meeker, CO. Chaparral and timber. No new information.

**Morgan Canyon**, Uinta-Wasatch-Cache NF, USFS. Twelve miles west of Stockton, UT. Timber, brush and short grass. Active fire behavior with backing and group torching. Numerous structures threatened.

**Pack Creek**, Manti-La Sal NF, USFS. IMT 2 (GB Team 4). Fourteen miles southeast of Moab, UT. Timber and brush. Moderate fire behavior with backing, single tree torching and smoldering. Structures threatened. Evacuations, area and road closures in effect.

**Andrus Canyon**, Lake Mead National Recreation Area, NPS. Sixty miles south of St. George, UT. Brush and short grass. Extreme fire behavior with torching and wind-driven runs.

**Flatt**, Cedar City Field Office, BLM. Five miles northwest of Enterprise, UT. Brush. Moderate fire behavior with smoldering, backing and creeping. Area and road closures in effect.

**Bennion Creek**, Manti-La Sal NF, USFS. Twenty-three miles northwest of Helper, UT. Brush, chaparral and timber. Minimal fire behavior with creeping and smoldering. Trail closures in effect.

**Predictive Services Discussion:** An upper low will remain off the California coast with high pressure aloft over the Intermountain West. Moisture will move north with cooler and more moist conditions for Arizona and the southern Great Basin, but it will remain above normal for the Northwest and Northern Rockies. The moisture will also fuel a mix of wet and dry thunderstorms across much of the West, with the greatest threat for dry thunderstorms over Arizona, the Great Basin, eastern Oregon, northern California, and western Montana. Dry and breezy conditions are likely in portions of Wyoming. Alaska will see above normal temperatures and gusty winds for the eastern interior, with isolated thunderstorms near the Brooks Range.

## Safety Zones 2 (LCES)

*Operational Engagement Category*

Safety Zones are locations where a threatened firefighter can find adequate refuge from an approaching fire. Unfortunately, some shelter deployment sites have been incorrectly called safety zones. Safety zones are locations where no fire shelter is needed.

This isn't meant to deter a firefighter from deploying their shelter if needed but to clarify that the location is not a true safety zone if a shelter deployment is necessary.

Fireline intensity and topographic location determine a safety zone's effectiveness.

- How have you distinguished between a safety zone and a deployment zone?
- Is refuge in a vehicle or house an acceptable tactic?

Consider access to the incident. You are often confronted with considerable distances of unburned fuel to cross. How do you manage Lookouts, Communications, Escape Routes, and Safety Zones (LCES)?
