Interceptor, Seminole Tribe, BIA. Twenty-one miles southeast of Immokalee, FL. Southern rough and tall grass. Minimal fire behavior with creeping and smoldering. Structures threatened.

Washita River, Oklahoma DOF. Two miles southeast of Durham, OK. Timber, brush and grass. Active fire behavior with creeping, torching and spotting. Numerous structures threatened.

Indigo Lane, Tennessee DOF. Seven miles west of Gatlinburg, TX. Dormant brush, hardwood slash. Minimal fire behavior.

* **Seymour**, Tennessee DOF. Started on private land six miles southeast of Seymour, TN. Dormant brush, hardwood slash. Moderate fire behavior.

Cedar Creek, North Carolina Forest Service. Ten miles southeast of Fayetteville, NC. Southern Rough. Moderate fire behavior with smoldering. Reduction in acreage due to more accurate mapping.

Beech, Daniel Boone NF, USFS. Four miles northeast of Manchester, KY. Timber. Minimal fire behavior with backing, flanking and creeping.

Rocky Point, National Forests in Florida. Four miles east of Salt Springs, FL. Southern rough. Minimal fire behavior.

Hurricane, Daniel Boone NF, USFS. Five miles southwest of Oneida, KY. Timber. Minimal fire behavior with backing, creeping and smoldering.

Valley View Ranch, Georgia Forestry Commission. Seven miles northwest of Trion, GA. Timber. Minimal fire behavior.

Blue Devil, Wewoka Agency, BIA. Five miles southeast of Bowlegs, OK. Hardwood litter and tall grass. Minimal fire behavior with smoldering.

* **Plan X**, Virginia DOF. Four miles east of Blackwater, VA. Timber and tall grass. Minimal fire behavior with smoldering. Structures threatened.

Homestead Estates, Kentucky DOF. Three miles west of Tutor Key, KY. Timber. Moderate fire behavior. Structures threatened.

* **Red Mud**, Texas A&M Forest Service. Started on private land 11 miles west of Spur, TX. Short grass. Minimal fire behavior with smoldering. Structures threatened.

* **Dubbs Creek**, Texas A&M Forest Service. Started on private land five miles northeast of Wheeler, TX. Tall grass. Minimal fire behavior with smoldering. Structures threatened.

137 Ave, Florida Forest Service. One mile west of Tamiami, FL. Chaparral and timber. Active fire behavior with creeping.

* **Adrian**, Texas A&M Forest Service. Started on private land 11 miles southeast of Sweetwater, TX. Tall grass and brush. Minimal fire behavior with smoldering.

L 30, Florida Forest Service. Twelve miles southwest of Miramar, FL. Tall grass. Active fire behavior with creeping.

Borrega, Texas A&M Forest Service. Started on private land 10 miles west of Kingsville, TX. Brush and tall grass. Minimal fire behavior with smoldering. Residences threatened.

Crittenburg Complex, Texas A&M Forest Service. Started on private land 12 miles southeast of Gatesville, TX. Tall grass and brush. Minimal fire behavior with smoldering. Numerous structures threatened.

Chimney Rock, Cherokee NF, USFS. Six miles northeast of Del Rio, TN. Hardwood litter. No new information. Last report unless new information is received.

Salt, Okmulgee Field Office, BIA. Eight miles northwest of Henryetta, OK. Tall grass. No new information. Last report unless new information is received.

Kingdom, Kentucky DOF. Three miles east of Buckhorn, KY. Timber, grass and hardwood litter. No new information. Last report unless new information is received.

Predictive Services Discussion: Elevated to critical fire weather conditions will develop across much of the central to northern High Plains today, with elevated conditions likely across southern New Mexico into southwest Texas. Thunderstorms, including severe, are expected across the southern Plains into the Lower Mississippi Valley and central Gulf Coast today as well. Precipitation, including potentially heavy mountain snow, will fall across the Pacific Northwest, northern Rockies, northern Great Basin, into the Colorado Rockies, and onto the northern Plains. Rain and snow showers are likely across Michigan into the eastern Great Lakes. A Gulf of Alaska low will likely bring precipitation to the Alaska Coast.



Responding To Vehicle Fires

Vehicles/Roads Category

Suppression of vehicle fires is extremely dangerous and poses many health and safety hazards to firefighters. The following procedures are recommended:

- Wear a high-visibility reflective vest or other high-visibility clothing.
- Secure the scene and provide or request assistance for traffic control.
- Park your vehicle to provide a protective barricade for you and your crew. Position it so that an inattentive or drunk driver will hit your vehicle and not your crew. Your vehicle is expendable; you are not.
- Provide for your escape route at the scene.
- Do not use road flares if fuel is leaking from the vehicle.
- Do not breathe any smoke. Smoke from vehicle fires contains toxic chemicals that will kill you.
- Vehicle fires are considered a hazardous materials scene. Suppression action should only be taken if the crew is trained, equipped, and authorized in the use of Self-Contained Breathing Apparatus (SCBA).
- If taking suppression action on wildland fuels, firefighters should ensure that they are a safe distance from the burning vehicle (100 feet minimum), and avoid contact with vehicle fire smoke or fumes.
