**Double Creek**, Wallowa-Whitman NF, USFS. IMT 1 (PNW Team 2). IMT is also managing the Sturgill, Nebo, and Goat Mountain Two fires. Ten miles southeast of Imnaha, OR. Timber and short grass. Active fire behavior with uphill runs, group torching and spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

**Sturgill**, Wallowa-Whitman NF, USFS. Fifteen miles southwest of Enterprise, OR. Timber and closed timber litter. Active fire behavior with short crown runs, flanking and backing. Structures threatened. Evacuations, area and trail closures in effect.

**Nebo**, Wallowa-Whitman NF, USFS. Twenty-one miles southeast of Enterprise, OR. Timber. Active fire behavior with short crown runs, flanking and spotting. Area, road and trail closures in effect. Reduction in acres due to more accurate mapping.

**Goat Mountain Two**, Wallowa-Whitman NF, USFS. Previously reported incident. Nine miles south of Lostine, OR. Timber. Moderate fire behavior with backing.

**Rum Creek**, Medford District, BLM. IMT 1 (ODF Team 1). Transfer of command from IMT 2 (NW Team 13) to IMT 2 (NR Team 6) will occur tomorrow. Twelve miles northwest of Hugo, OR. Timber and closed timber litter. Active fire behavior with uphill runs and backing. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**White River**, Okanogan-Wenatchee NF, USFS. IMT 2 (NW Team 8). IMT is also managing the Irving Peak fire. Twenty-three miles northwest of Leavenworth, WA. Timber. Active fire behavior with flanking, backing and torching. Numerous structures threatened. Area, road and trail closures in effect.

**Irving Peak**, Okanogan-Wenatchee NF, USFS. Twenty-six miles northwest of Leavenworth, WA. Timber. Active fire behavior with flanking, backing and isolated torching. Structures threatened. Area, road and trail closures in effect.

**Cedar Creek**, Willamette NF, USFS. IMT 2 (NW Team 6). Fifteen miles east of Oakridge, OR. Timber and closed timber litter. Moderate fire behavior with flanking, backing and torching. Structures threatened. Area, road and trail closures in effect.

**Crockets Knob**, Malheur NF, USFS. IMT 2 (NW Team 12). Nineteen miles north of Prairie City, OR. Brush, closed timber litter and timber. Active fire behavior with flanking, torching and short-range spotting. Structures threatened. Area, road and trail closures in effect.

**Boulder Mountain**, Northeast Region, DNR. IMT 2 (GB Team 7). Started on private land nine miles northwest of Cusick, WA. Timber. Active fire behavior with flanking, backing and isolated torching. Structures threatened. Evacuations, area, road and trail closures in effect.

**Potter**, Willamette NF, USFS. IMT 2 (NW Team 9). Forty-six miles southwest of La Pine, OR. Closed timber litter, timber and medium slash. Minimal fire behavior with creeping and isolated torching. Area, road and trail closures in effect.

Active fire behavior with uphill runs, short crown runs and spotting. Communities of Gazelle and Scott Valley threatened. Evacuations and road closures in effect.

**Mill**, Siskiyou Unit, Cal Fire. One mile northeast of Weed, CA. Short grass, brush and timber. Minimal fire behavior with creeping and smoldering. Several communities, numerous structures and infrastructure threatened. Evacuations and road closures in effect.

**2022 SRF Lightning Complex** (2 fires), Six Rivers NF, USFS. IMT 2 (CA Team 15). One mile northeast of Willow Creek, CA. Timber and slash. Minimal fire behavior with backing, flanking and uphill runs. Several communities, numerous structures and infrastructure threatened. Area, road and trail closures in effect.

**McKinney**, Klamath NF, USFS. Fifteen miles northwest of Yreka, CA. Timber and brush. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

**Williams Creek**, Nez Perce-Clearwater NF, USFS. IMT 2 (NR Team 5). Fourteen miles southwest of Elk City, ID. Closed timber litter, timber and heavy slash. Extreme fire behavior with crowning, torching and short-range spotting. Structures threatened. Area, road and trail closures in effect.

**Lemonade**, Flathead NF, USFS. IMT 2 (NR Team 3). Twenty-one miles west of Kalispell, MT. Timber and medium slash. Active fire behavior with uphill runs, torching and group torching.

**Bull Gin Complex** (4 fires), Kootenai NF, USFS. IMT 2 (NR Team 7). Two miles northeast of Heron, MT. Timber and brush. Active fire behavior with uphill runs, group torching and backing. Area, road and trail closures in effect.

\* **Mill Lake**, Bitterroot NF, USFS. Seven miles west of Pinesdale, MT. Timber and brush. Active fire behavior with short crown runs, spotting and uphill runs. Area road and trail closures in effect. Last narrative report unless significant activity occurs.

Several communities, numerous structures and communications infrastructure threatened. Area, road and trail closures in effect.

**Moose**, Salmon-Challis NF, USFS. IMT 2 (GB Team 5). Seventeen miles north of Salmon, ID. Short grass, brush and timber. Active fire behavior with backing, group torching and single tree torching. Area, road and trail closures in effect.

**Ross Fork**, Sawtooth NF, USFS. IMT 2 (GB Team 3) mobilizing. Six miles east of Atlanta, ID. Closed timber litter, timber and short grass. Extreme fire behavior with running, flanking and wind-driven runs. Structures threatened. Area and trail closures in effect.

**Predictive Services Discussion:** Another weak Pacific cold front will move through the Inland Pacific Northwest into the northern Great Basin and northern Rockies today. Ahead of the front, temperatures will remain well above normal across the West, mostly in the 90s to 110°F, and minimum relative humidity generally below 15%. Elevated to critical fire weather conditions are expected across northern Montana and in portions of southeast Idaho into Wyoming as west-northwest sustained winds of 15-20 mph gusting 25-40 mph amid minimum relative humidity of 7-15% develop. Hot and dry conditions are likely on much of the northern Plains and the central High Plains as well. Isolated mixed wet and dry thunderstorms are possible in the Transverse Ranges and southern Sierra of southern California and in portions of southern Colorado, northern New Mexico, and northeast Arizona. Scattered thunderstorms and showers are expected from south Texas through much of the eastern US except in New England. Heavy rain is possible from the Ohio Valley into the southern and central Appalachians.

## Ash Pit Hazards

*Miscellaneous Fireline Hazards Category*

Ash pits are an inherent and hidden risk to wildland firefighters that can cause severe burns and injuries. Ash pits are created when a ground fire consumes underground fuels creating an empty space that is imperceptible from the surface.

### **Environmental factors that increase the risk of ash pit formation after a wildfire:**

- Extensive root systems of trees and shrubs.
- Deep duff or peat, which is the organic layer covering mineral soil.
- Landscapes that have once been cultivated or manipulated by heavy equipment, old dozer piles, sawmills, timber sale yards, or decking areas.
- Animal dwellings that have become filled with decadent combustible debris.
  - Small rodent holes,
  - Beaver holes near dams and stream beds, or
  - Badger and coyote dens.
- White ash is sometimes an indicator of ash pits, as are swarms of hovering insects.
- With the sun behind the suspected ash pit, look for small nearly translucent smokes that dissipate quickly above the ground.
- Ash pits often give off the smell of incomplete combustion or of creosote burning.

### **Mitigation measures to consider:**

- Identification of high-risk landscape.
- Identify and flag all hazardous discovered ash pits.
