**Cedar Creek**, Willamette NF, USFS. IMT 1 (AK Team 1) and IMT 2 (NW Team 6). Fifteen miles east of Oakridge, OR. Timber and closed timber litter. Extreme fire behavior with crowning, wind-driven runs and long-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Double Creek**, Wallowa-Whitman NF, USFS. IMT 1 (PNW Team 2). IMT is also managing the Sturgill, Nebo, and Goat Mountain Two fires. Ten miles southeast of Imnaha, OR. Timber and short grass. Active fire behavior with wind-driven runs, flanking and backing. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Sturgill**, Wallowa-Whitman NF, USFS. Fifteen miles southwest of Enterprise, OR. Timber and closed timber litter. Active fire behavior with group torching, flanking and backing. Residences threatened. Evacuations, area, road and trail closures in effect.

**Nebo**, Wallowa-Whitman NF, USFS. Twenty-one miles southeast of Enterprise, OR. Timber. Active fire behavior with group torching, flanking and backing. Area, road and trail closures in effect.

**Goat Mountain Two**, Wallowa-Whitman NF, USFS. Nine miles south of Lostine, OR. Timber. Moderate fire behavior with backing.

**Van Meter**, Lakeview District, BLM. IMT 1 (ODF Team 3). Thirteen miles southeast of Klamath Falls, OR. Timber, brush and short grass. Active fire behavior with torching and short-range spotting. Numerous structures threatened. Evacuations in effect. Reduction in acreage due to more accurate mapping.

**Boulder Mountain**, Northeast Region, DNR. IMT 2 (GB Team 7). Nine miles northwest of Cusick, WA. Timber and medium slash. Active fire behavior with group torching, single tree torching and flanking. Structures threatened. Evacuations have been lifted. Area, road and trail closures in effect.

**Rum Creek**, Medford District, BLM. IMT 2 (NR Team 6). Twelve miles northwest of Hugo, OR. Timber and closed timber litter. Active fire behavior with backing and flanking. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Crocks Knob**, Malheur NF, USFS. Transfer of command from IMT 2 (NW Team 12) back to the local unit will occur today. Nineteen miles north of Prairie City, OR. Brush, closed timber litter and timber. Minimal fire behavior with flanking, backing and creeping. Structures threatened. Area, road and trail closures in effect.

**Chilliwack Complex** (4 fires), North Cascades NP, NPS. NIMO (Team 2). IMT is also managing the NW Pasayten Complex. Thirty miles east of Maple Falls, WA. Timber. Active fire behavior. Structures threatened. Trail closures in effect. Reduction in acreage due to more accurate mapping.

**NW Pasayten Complex** (6 fires), Okanogan-Wenatchee NF, USFS. Twenty miles northeast of Diablo, WA. Timber. Active fire behavior. Structures and communication infrastructure threatened. Trail closures in effect.

**Potter**, Willamette NF, USFS. Transfer of command from IMT 2 (NW Team 9) back to the local unit will occur tomorrow. Forty-six miles southwest of La Pine, OR. Closed timber litter, timber and medium slash. Minimal fire behavior with backing, creeping and isolated torching. Area, road and trail closures in effect.

\* **Goat Rocks**, Gifford Pinchot NF, USFS. IMT 2 (NW Team 10) mobilizing. Eight miles east of Packwood, WA. Timber. Active fire behavior with wind-driven runs, flanking and short-range spotting. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

**Jones Creek**, Wallowa-Whitman NF, USFS. IMT 2 (NW Team 7). Seventeen miles northeast of Imnaha, OR. Short grass and timber. Minimal fire behavior with creeping and smoldering. Structures threatened. Area and road closures in effect.

**White River**, Okanogan-Wenatchee NF, USFS. Twenty-three miles northwest of Leavenworth, WA. Timber. Active fire behavior with flanking. Numerous structures threatened. Area, road and trail closures in effect.

**Irving Peak**, Okanogan-Wenatchee NF, USFS. Twenty-six miles northwest of Leavenworth, WA. Timber. Moderate fire behavior with flanking. Structures threatened. Area, road and trail closures in effect.

**Seven Bays**, Northeast Region, DNR. Fifteen miles northwest of Davenport, WA. Timber and hardwood litter. Minimal fire behavior with creeping and smoldering.

**Amelia Road**, Vale District, BLM. Twelve miles northwest of Brogan, OR. Brush and short grass. Minimal fire behavior with smoldering. Structures threatened.

**Moose**, Salmon-Challis NF, USFS. Transfer of command from IMT 2 (GB Team 5) to IMT 1 (GB Team 1) will occur today. Seventeen miles north of Salmon, ID. Short grass, brush and timber. Active fire behavior with group torching, single tree torching and short-range spotting. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

**Ross Fork**, Sawtooth NF, USFS. IMT 2 (GB Team 3). Six miles east of Atlanta, ID. Short grass, timber and brush. Extreme fire behavior with uphill runs, spotting and short crown runs. Structures threatened. Area, road and trail closures in effect.

**Tenmile**, Payette NF, USFS. IMT 2 (GB Team 4). Nine miles west of Warren, ID. Timber. Active fire behavior with group torching and spotting. Structures threatened. Reduction in acreage due to more accurate mapping.

**Four Corners**, Payette NF, USFS. IMT 1 (GB Team 2). Six miles west of Cascade, ID. Timber and closed timber litter. Moderate fire behavior with creeping, torching and smoldering. Several communities, numerous structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Two and a Half**, Idaho Falls District, BLM. Five miles north of Pocatello, ID. Short grass and brush. Active fire behavior with short crown runs and short-range spotting. Residences threatened. Area and road closures in effect.

**Wildhorse**, Boise NF, USFS. Started on county land twenty-four miles northeast of Mountain Home, ID. Brush, tall grass and timber. Minimal fire behavior with smoldering. Structures and sage-grouse habitat threatened.

**Woodtick**, Salmon-Challis NF, USFS. Previously reported incident. Twenty-seven miles northwest of Challis, ID. Timber, short grass and brush. Moderate fire behavior with creeping, smoldering and isolated torching. Structures threatened. Area, road and trail closures in effect. Last narrative report unless significant activity occurs.

**Barnes**, Modoc NF, USFS. IMT 1 (CA Team 1) mobilizing. Two miles east of Willow Ranch, CA. Timber, brush and tall grass. Extreme fire behavior with crowning, group torching and spotting. Communities of Fort Bidwell and Willow Ranch threatened. Numerous structures threatened. Evacuations, area and road closures in effect.

**Mountain**, Siskiyou Unit, Cal Fire. IMT 1 (Cal Fire Team 5). IMT is also managing the Mill fire. Thirteen miles southeast of Etna, CA. Short grass, brush and timber. Minimal fire behavior with smoldering and creeping. Evacuations have been lifted. Reduction in acreage due to more accurate mapping.

**Mill**, Siskiyou Unit, Cal Fire. One mile northeast of Weed, CA. Short grass, brush and timber. Minimal fire behavior with smoldering. Several communities, numerous structures and infrastructure threatened. Evacuations and road closures in effect.

**2022 SRF Lightning Complex**, Six Rivers NF, USFS. IMT 2 (CA Team 15). One mile northeast of Willow Creek, CA. Timber and light slash. Minimal fire behavior with backing, smoldering and creeping. Several communities, numerous structures and infrastructure threatened. Area, road and trail closures in effect.

**Fairview**, Riverside Unit, Cal fire. IMT 1 (Cal Fire Team 6). Seven miles southeast of Hemet, CA. Chaparral, brush and short grass. Minimal fire behavior with creeping, smoldering and backing. Community of Hemet, numerous structures, communication and energy infrastructure threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Radford**, San Bernardino NF, USFS. IMT 2 (CA Team 11). Seven miles southwest of Big Bear, CA. Timber, chaparral and brush. Minimal fire behavior with backing, creeping and smoldering. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Kootenai River Complex** (4 fires), Idaho Panhandle NF, USFS. IMT 2 (NR Team 4). Seven miles northwest of Bonners Ferry, ID. Timber and brush. Moderate fire behavior with uphill runs, backing and short-range spotting. Residences threatened. Road and trail closures in effect.

**Williams Creek**, Nez Perce-Clearwater NF, USFS. IMT 2 (NR Team 5). IMT is also managing the Twin Lakes fire. Fourteen miles southwest of Elk City, ID. Closed timber litter, timber and heavy slash. Moderate fire behavior with uphill runs, flanking and single tree torching. Community of Orogrande and structures threatened. Evacuations, area, road and trail closures in effect.

**Twin Lakes**, Nez Perce-Clearwater NF, USFS. Twenty-five miles southeast of White Bird, ID. Closed timber litter, timber and heavy slash. Moderate fire behavior with flanking, creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

**Predictive Services Discussion:** Offshore east winds will continue over the Northwest and northern California but are forecast to gradually decrease during the day. Very warm temperatures will continue west of the Cascades and Sierra with highs into the 80s and 90s and afternoon relative humidity falling to 7-20%. Very dry conditions will continue for the northern Intermountain West as well. Thermal troughing and low-level instability are forecast to continue for northern California into the Cascades, likely keeping fires active into the evening even as the winds subside. Isolated mixed wet and dry thunderstorms may be ongoing in the morning from the central Sierra to the central California coast but are likely to become wetter as moisture increases in the afternoon. Showers and thunderstorms along with potential flooding will continue from the southern Sierra to Point Conception southward for California and stretch into portions of southern Nevada and northwest Arizona. Isolated to scattered showers and thunderstorms are expected across the greater Four Corners region, while showers and thunderstorms are likely near a cold front across the central Plains into the Great Lakes. Scattered to numerous showers and thunderstorms are forecast from the Ohio Valley to the Gulf Coast and Southeast as well, with the heaviest rain and possible flooding in the western Carolinas.

## Creating hope through action



### U.S.'s first three-digit mental health crisis line

In July 2022, the U.S. adopted 988, an easy to remember number for anyone experiencing mental health distress or a suicidal crisis.

#### What is 988?

The 988 Suicide and Crisis Lifeline (formerly known as the National Suicide Prevention Lifeline) offers free, 24/7 access to a counselor who is trained to support people experiencing mental health distress, suicidal, or substance use crises. Services are available in English, Spanish, or translation in over 250 languages.

#### What happens when you contact 988?

A trained crisis counselor will respond to your call or text. The counselor will listen, ask questions to understand how problems are affecting you, provide support, and share resources that might be helpful.

#### Help is a touch away
