The Federal Emergency Management Agency (FEMA) has activated Emergency Support Function 4 (ESF4) to assist with the wildfires burning in Hawaii.

Two incident management teams and two overhead personnel are assigned to large fire support in Canada.

One MAFFS C-130 airtanker and support personnel from the 153rd Airlift Wing (Wyoming Air National Guard) and one MAFFS unit from the 302nd Airlift Wing (Colorado Air Force Reserve) have been deployed to Klamath Falls, OR to support wildland fire operations nationally.

IMT 1 (Cal Fire Team 1) is mobilizing to Hawaii to assist with wildfire suppression efforts.

Head, Klamath NF, USFS. IMT 1 (CA Team 5). Twenty-one miles northwest of Yreka, CA. Timber and chaparral. Extreme fire behavior with short crown runs, long-range spotting and running. Several communities threatened. Evacuations, area and road closures in effect. Reduction in acreage due to more accurate mapping.

* **Smith River Complex**, (2 fires), Six Rivers NF, USFS. IMT 2 (CA Team 15). Seven miles northeast of Gasquet, CA. Timber and brush. Active fire behavior with torching, crowning and long-range spotting. Numerous structures, communication and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

* **Slide 1**, Mendocino NF, USFS. Twenty-four miles northwest of Flournoy, CA. Chaparral, grass and timber. Active fire behavior with backing, torching and group torching. Area, road and trail closures in effect.

* **Lone Pine**, Six Rivers NF, USFS. Four miles northeast of Willow Creek, CA. Timber and brush. Moderate fire behavior with backing, short-range spotting and isolated torching.

Lookout, Willamette NF, USFS. IMT 2 (NW Team 6). Four miles north of McKenzie Bridge, OR. Timber. Moderate fire behavior with group torching, uphill runs and short-range spotting. Community of McKenzie Bridge and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Bedrock, Willamette NF, USFS. IMT 2 (NW Team 12). IMT 1 (NW Team 2) mobilizing. IMT is also managing the Salmon fire. Twelve miles south of Vida, OR. Timber and brush. Active fire behavior with creeping, uphill runs and short crown runs. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Salmon, Willamette NF, USFS. Four miles northeast of Oakridge, OR. Timber and brush. Minimal fire behavior with smoldering. Several communities and infrastructure threatened. Area, road and trail closures in effect.

Sourdough, North Cascades NP, NPS. IMT 2 (NW Team 10). IMT 2 (NW Team 8) mobilizing. Six miles northeast of Newhalem, WA. Timber and brush. Extreme fire behavior with short crown runs and torching. Structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Predictive Services Discussion:

Hot, dry, and unstable conditions will continue across the Pacific Northwest, Northern Rockies, and much of the Great Basin, with little change from prior days. Minimum relative humidity will again fall to 10-25% over a wide area, with poor recoveries for many mid-slope and higher locations, and temperatures of 95 to 110°F will be common. A notable increase in winds is also anticipated in the Northern Rockies and through the Cascade Gaps. Hot weather will extend into northern California where another round of isolated mixed wet and dry thunderstorms is expected and could lead to a few new ignitions. Isolated mixed wet and dry thunderstorms are also likely in portions of Oregon and southern Idaho. An active monsoon will lead to continued wet thunderstorms across southern California and much of the Four Corners states. Hotter and drier weather is expected over Texas, Oklahoma, and Louisiana, while the remainder of the Plains states and the Midwest will see a cooling trend. Scattered showers and thunderstorms are likely for a good portion of the Great Lakes and the East Coast. It will be mainly dry and breezy over Interior Alaska, but temperatures will be generally near to below normal.
