Chris Mountain, San Juan NF, USFS. CIMT (RM Team 3). Six miles northwest of Pagosa Springs, CO. Timber and brush. Moderate fire behavior with running, flanking and isolated torching. Structures threatened. Area, road and trail closures in effect.

Titan, Las Animas County. CIMT (RM Team 1). Eleven miles northwest of Trinidad, CO. Timber. Minimal fire behavior with creeping and smoldering.

Coal Mine, Archuleta County. Eighteen miles south of Pagosa Springs, CO. Timber and brush. Minimal fire behavior with smoldering and creeping. Residences threatened.

Arkansas Loop, Southern Ute Agency, BIA. Twelve miles west of Tiffany, CO. Timber and brush. Minimal fire behavior with creeping and smoldering. Structures threatened.

Predictive Services Discussion:

Hot and dry conditions are forecast across much of California, the Southwest, and Great Basin today, with temperatures exceeding 110°F across portions of California and Arizona. Relative humidity will also fall below 15% with poor overnight recovery for mid-slopes and ridges. Above normal temperatures are also forecast across the rest of the West into the Plains and Southeast. Breezy conditions are forecast across portions of the northern Great Basin and Arizona, with elevated conditions most likely across southern Arizona. Isolated mixed wet and dry thunderstorms may form over the mountains of northern Utah and the West Slope while wetter scattered thunderstorms are forecast across the High Plains. Scattered showers and thunderstorms are also forecast for much of the eastern US east of the Mississippi River with severe thunderstorms likely from the Tennessee Valley to the Mid-Atlantic. The Alaska Interior will be warm and dry today, with a few showers possible in southwest Alaska.
