## Predictive Services Discussion:

Hot and dry conditions will continue across the Mid-Atlantic and Carolinas today ahead of a cold front. The front may limit the duration of the hot and dry conditions, with scattered thunderstorms likely to develop in the afternoon. Isolated to scattered thunderstorms are also likely in the Southeast ahead of the front, with more widespread thunderstorms and wetting rain across the Northeast. Well above normal temperatures will continue across much of New Mexico into the southern Plains as well. Winds overall are forecast to be light in Texas and Oklahoma, but moderate westerly winds of 10-20 mph are forecast in the Four Corners states, with locally stronger downslope gusts of $30-40 \mathrm{mph}$ possible along the New Mexico central mountain chain. Isolated mixed wet and dry thunderstorms are possible over southeast Arizona into west-central New Mexico as well. Near normal temperatures are forecast for northern California, Northwest, northern Great Basin, and northern Rockies amid minimum RH of $15-35 \%$. Isolated thunderstorms are likely to develop across much of southern Montana into the northern Plains with isolated mixed wet and dry thunderstorms possible tonight for northeast Oregon, eastern Washington, and central Idaho.
