On July 26, a single engine air tanker on contract with the Bureau of Land Management crashed while working in the vicinity of the Falls fire on the Malheur National Forest. The pilot was fatally injured. The firefighting community expresses its condolences to the family and friends of the deceased.

One MAFFS C-130 airtanker and support personnel from the 302nd Airlift Wing (Air Force Reserve), one MAFFS C-130 airtanker and support personnel from the 152nd Airlift Wing (Nevada Air National Guard), one MAFFS C-130 airtanker from the 146th Airlift Wing (California Air National Guard), and one MAFFS C-130 airtanker from the 153rd Airlift Wing (Wyoming Air National Guard) have been deployed to Port Hueneme, CA to support wildland fire operations nationally.

Swawilla I, Colville Agency, BIA. CIMT (NR Team 6). IMT is also managing the Bridge Creek fire. Ten miles southwest of Keller, WA. Grass, brush and timber. Active fire behavior with running, single tree torching and short-range spotting. Numerous residences threatened. Area, road and trail closures in effect.

Bridge Creek, Northeast Region, Washington DNR. Ten miles north of Keller, WA. Grass, brush and timber. Moderate fire behavior with creeping and smoldering. Residences threatened. Area and road closures in effect.

Durkee, Vale District, BLM. Transfer of command from CIMT (NW Team 6) to CIMT (SA Team 3) will occur today. IMT is also managing the Cow Valley fire. Started on private land one mile west of Durkee, OR. Brush, grass and timber. Active fire behavior with wind-driven runs, flanking and short-range spotting. Numerous structures, energy and communication infrastructure threatened. Evacuations and road closures in effect.

Cow Valley, Vale District, BLM. Started on private land nine miles east of Ironside, OR. Brush and grass. Minimal fire behavior. Energy and communication infrastructure threatened. Sage-grouse habitat threatened.

Falls, Malheur NF, USFS. CIMT (AK Team 1). IMT is also managing the Telephone fire. Twenty-six miles northwest of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Telephone, Malheur NF, USFS. Sixteen miles northeast of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Retreat, Southeast Region, Washington DNR. CIMT (NR Team 1). Started on private land 14 miles southeast of Naches, WA. Timber, brush and closed timber litter. Active fire behavior with uphill runs and single tree torching. Numerous structures, communication and energy infrastructure threatened. Area and road closures in effect.

Battle Mountain Complex (5 fires), Pendleton Unit, Oregon DOF. IMT 1 (ODF Team 3) and IMT 1 (ODF Team 1). IMT is also managing the Courtrock fire. Eight miles north of Ukiah, OR. Timber, grass and brush. Active fire behavior with running, group torching and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Courtrock, Fossil Unit, Oregon DOF. Seven miles south of Monument, OR. Grass and brush. Extreme fire behavior with running, spotting and wind-driven runs. Numerous structures threatened. Evacuations, area and road closures in effect.

Badland Complex (3 fires), Vale District, BLM. CIMT (RM Team 2). Three miles northeast of Durkee, OR. Grass, brush and timber. Active fire behavior with wind-driven runs, torching and spotting. Structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Pyramid, Willamette NF, USFS. CIMT (CA Team 5). Seventeen miles northeast of Cascadia, OR. Timber and medium slash. Active fire behavior with backing, creeping and short-range spotting. Area, road and trail closures in effect.

Lone Rock, Prineville District, BLM. CIMT (NW Team 2). Started on county land 10 miles southeast of Condon, OR. Timber and grass. Minimal fire behavior with flanking, backing and creeping. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Microwave Tower, The Dalles Unit, Oregon DOF. CIMT (GB Team 6). IMT is also managing the Whisky Creek fire. Five miles southwest of Mosier, OR. Timber and grass. Moderate fire behavior with backing, creeping and smoldering. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Whisky Creek, Mt. Hood NF, USFS. Six miles southeast of Cascade Locks, OR. Timber and brush. Active fire behavior with flanking, backing and creeping. Area, road and trail closures in effect.

Diamond Complex (7 fires), Umpqua NF, USFS. CIMT (NW Team 7). IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber. Active fire behavior with flanking, isolated torching and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Middle Fork, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber and brush. Moderate fire behavior with backing, creeping and isolated torching. Trail closures in effect.

Red, Deschutes NF, USFS. CIMT (EA Team 1). IMT is also managing the Wickiup fire. Eighteen miles west of Crescent, OR. Timber and closed timber litter. Moderate fire behavior with creeping, isolated torching and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Wickiup, Deschutes NF, USFS. Eight miles west of La Pine, OR. Timber. Minimal fire behavior with smoldering. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Pioneer, Southeast Region, Washington DNR. CIMT (NW Team 3). IMT is also managing the Easy fire. Started on private land 10 miles southeast of Stehekin, WA. Timber, brush and grass. Active fire behavior with backing, flanking and single tree torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Easy, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber. Active fire behavior with backing, creeping and single tree torching. Structures threatened. Trail closures in effect. Reduction in acreage due to more accurate mapping.

Chalk, Willamette NF, USFS. CIMT (RM Team 1). IMT is also managing the Moss Mountain, Coffeepot and 208 fires. Nine miles northeast of Oakridge, OR. Timber. Active fire behavior with uphill runs, group torching and spotting. Area, road and trail closures in effect.

Moss Mountain, Willamette NF, USFS. Fourteen miles southeast of Oakridge, OR. Timber. Active fire behavior with uphill runs, group torching and spotting. Area, road and trail closures in effect. Transportation infrastructure threatened.

Coffeepot, Willamette NF, USFS. Ten miles southeast of Oakridge, OR. Timber. Active fire behavior with uphill runs, single tree torching and spotting. Transportation infrastructure threatened. Area, road and trail closures in effect.

208, Willamette NF, USFS. Twenty miles southeast of Oakridge, OR. Timber. Moderate fire behavior with creeping and smoldering. Area and trail closures in effect.

Cougar Creek, Southeast Region, Washington DNR. CIMT (NW Team 13). Twenty-three miles southwest of Asotin, WA. Timber, grass and brush. Moderate fire behavior with backing, creeping and isolated torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Homestead Complex (5 Fires), Umpqua NF, USFS. CIMT (GB Team 5). Thirty miles northeast of Glide, OR. Timber and brush. Moderate fire behavior with backing, flanking and isolated torching. Area, road and trail closures in effect.

Lane 1, East Lane Unit, Oregon DOF. CIMT (NC State Team 1). IMT is also managing the Clark 900, Adam Mountain, Jack Saddle, Mineral, Quartz and Puddin fires. Fifteen miles southeast of Springfield, OR. Timber. Active fire behavior with flanking, backing and torching. Structures threatened. Area and road closures in effect.

Clark 900, Northwest District, BLM. Nineteen miles southwest of Oakridge, OR. Timber. Active fire behavior with flanking, backing and torching.

Adam Mountain, Umpqua NF, USFS. Six miles southeast of Dorena, OR. Timber and closed timber litter. Active fire behavior with flanking, backing and torching.

Jack Saddle, Umpqua NF, USFS. Ten miles southeast of Dorena, OR. Timber and closed timber litter. Active fire behavior with flanking, backing and torching.

Mineral, Umpqua NF, USFS. Seven miles southeast of Dorena, OR. Timber and closed timber litter. Active fire behavior with flanking, backing and torching. Structures threatened.

Quartz, Umpqua NF, USFS. Ten miles southeast of Dorena, OR. Timber and closed timber litter. Active fire behavior with flanking, backing and torching. Area and road closures in effect.

Puddin, Umpqua NF, USFS. Thirteen miles southeast of Dorena, OR. Timber, closed timber litter and light slash. Active fire behavior with flanking, backing and torching. Structures threatened.

Ore, Willamette NF, USFS. CIMT (NW Team 10). Seven miles northeast of Blue River, OR. Timber. Active fire behavior with creeping, torching and group torching. Structures threatened. Area, road and trail closures in effect.

Crazy Creek, Ochoco NF, USFS. CIMT (SW Team 5). Sixteen miles northeast of Paulina, OR. Timber and grass. No new information.

Hole-In-The-Ground, Vale District, BLM. Twenty-four miles west of Jordan Valley, OR. Brush and grass. Extreme fire behavior with running, wind-driven and flanking. Structures threatened.

Camp Creek, Prineville District, BLM. Ten miles southwest of Paulina, OR. Grass, timber and brush. Moderate fire behavior with isolated torching and creeping.

Ritter, Burns District, BLM. Thirteen miles northeast of Crane, OR. Timber, brush and grass. Active fire behavior with torching, spotting and running. Residences threatened.

Big Horn, Washington State Fire Marshall's Office. Seven miles southeast of Bickleton, WA. Grass and brush. Moderate fire behavior with backing and creeping. Numerous structures threatened. Evacuations, area and road closures in effect.

Black Canyon, Southeast Region, Washington DNR. Ten miles northwest of Naches, WA. Timber, brush and grass. Minimal fire behavior with backing and smoldering. Numerous structures threatened. Area, road and trail closures in effect.

Cedar Creek, Vale District, BLM. Twenty-three miles southwest of Juntura, OR. Brush and grass. Minimal fire behavior. Sage-grouse habitat threatened. Reduction in acreage due to more accurate mapping.

Cliff Mountain, Wallowa-Whitman NF, USFS. Twenty-five miles east of Joseph, OR. Brush and grass. No new information.

Deer Creek, Vale District, BLM. Eighteen miles southwest of Adrian, OR. Brush and grass. Minimal fire behavior. Sage-grouse habitat threatened.

Predictive Services Discussion:

An upper-level low along the California coast will move north and east into the northern Great Basin today, with isolated mixed wet and dry thunderstorms ongoing this morning across northern Utah into southeast Idaho. Isolated to scattered mixed wet and dry thunderstorms will develop this afternoon across northeast Nevada into northern Utah, southeast Idaho, southwest Montana, and Wyoming. Isolated dry thunderstorms will be possible on the western fringe in northwest Nevada, southeast Oregon, and southwest Idaho. Generally wet thunderstorms will continue across southeastern Arizona and portions of Colorado and New Mexico where deeper moisture will be in place.

However, hot, dry, and breezy conditions will impact much of southern California into southern Nevada, northwest Arizona, and Utah ahead of a cold front, with relative humidity expected to fall near or below 10%. Southwesterly winds in these areas will likely gust to 30-50 mph, highest in downslope areas. Dense smoke may continue to limit visibility and result in very poor air quality across northeastern California, areas east of the Cascades and into portions of the northern Great Basin and northern Rockies. Wet weather will continue across the Southeast and Gulf Coast, while high pressure will bring some relief from recent flooding to the Carolinas and southern Appalachians. Alaska is forecast to remain cool and wet today, while dry trade winds diminish slightly in Hawai'i.
