**Swawilla I**, Colville Agency, BIA. CIMT (NR Team 6). IMT is also managing the Bridge Creek fire. Ten miles southwest of Keller, WA. Grass, brush and timber. Active fire behavior with group torching, uphill runs and short-range spotting. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

**Bridge Creek**, Northeast Region, Washington DNR. Ten miles north of Keller, WA. Grass, brush and timber. Moderate fire behavior with creeping and smoldering. Residences threatened. Area and road closures in effect.

**Falls**, Malheur NF, USFS. CIMT (AK Team 1). IMT is also managing the Telephone and Ritter fires. Twenty-six miles northwest of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Telephone**, Malheur NF, USFS. Sixteen miles northeast of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Ritter**, Burns District, BLM. Thirteen miles northeast of Crane, OR. Timber, brush and grass. Active fire behavior with flanking, backing and creeping. Residences threatened. Reduction in acreage due to more accurate mapping.

**Retreat**, Southeast Region, Washington DNR. CIMT (NR Team 1). Started on private land 14 miles southeast of Naches, WA. Timber and brush. Active fire behavior with uphill runs and single tree torching. Numerous structures, communication and energy infrastructure threatened. Area, road and trail closures in effect.

**Battle Mountain Complex (2 fires)**, Pendleton Unit, Oregon DOF. IMT 1 (ODF Team 3) and IMT 1 (ODF Team 1). IMT is also managing the Courtrock fire. Eight miles north of Ukiah, OR. Timber, grass and brush. Active fire behavior with running, group torching and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Courtrock**, Fossil Unit, ODF. Seven miles south of Monument, OR. Timber, grass and brush. Active fire behavior with wind-driven runs, isolated torching and short-range spotting. Numerous structures threatened. Evacuations, area and road closures in effect.

**Badland Complex (2 fires)**, Vale District, BLM. CIMT (RM Team 2). Three miles northeast of Durkee, OR. Brush and timber. Moderate fire behavior with wind-driven runs, torching and spotting. Structures, energy, communication infrastructure and Sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

**Durkee**, Vale District, BLM. CIMT (SA Team 3). IMT is also managing the Cow Valley fire. Started on private land one mile west of Durkee, OR. Grass and timber. Active fire behavior with flanking, backing and smoldering. Numerous structures, energy and communication infrastructure threatened. Evacuations, area and road closures in effect.

**Cow Valley**, Vale District, BLM. Started on private land nine miles east of Ironside, OR. Brush and grass. Minimal fire behavior.

**Pioneer**, Southeast Region, Washington DNR. CIMT (NW Team 3). IMT is also managing the Easy fire. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Active fire behavior with

backing, flanking and single tree torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Easy**, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber and brush. Active fire behavior with creeping, backing and single tree torching. Structures threatened. Trail and area closures in effect.

**Diamond Complex (8 fires)**, Umpqua NF, USFS. CIMT (NW Team 7). IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber and brush. Moderate fire behavior with flanking, backing and isolated torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Middle Fork**, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber and brush. Moderate fire behavior with flanking, backing and isolated torching. Trail closures in effect.

**Microwave Tower**, The Dalles Unit, Oregon DOF. Transfer of command from CIMT (GB Team 6) back to the local unit will occur today. IMT is also managing the Whisky Creek fire. Five miles southwest of Mosier, OR. Timber and grass. Active fire behavior with backing, flanking and uphill runs. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Whisky Creek**, Mt. Hood NF, USFS. Six miles southeast of Cascade Locks, OR. Timber and slash. Active fire behavior with flanking, backing and creeping. Area, road and trail closures in effect.

**Lone Rock**, Prineville District, BLM. CIMT (NW Team 2). CIMT (SW Team 2) mobilizing. Started on county land 10 miles southeast of Condon, OR. Timber and grass. Minimal fire behavior with backing, isolated torching and smoldering. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Crazy Creek**, Ochoco NF, USFS. CIMT (SW Team 5). Sixteen miles northeast of Paulina, OR. Timber, brush and grass. Active fire behavior with running, torching and spotting. Residences threatened. Evacuations, area, road and trail closures in effect.

**Chalk**, Willamette NF, USFS. CIMT (RM Team 1). IMT is also managing the Moss Mountain, Coffeepot and 208 fires. Nine miles northeast of Oakridge, OR. Timber. Active fire behavior with uphill runs, group torching and spotting. Area, road and trail closures in effect.

**Moss Mountain**, Willamette NF, USFS. Fourteen miles southeast of Oakridge, OR. Timber. Active fire behavior with uphill runs, group torching and spotting. Area, road and trail closures in effect.

**Coffeepot**, Willamette NF, USFS. Ten miles southeast of Oakridge, OR. Timber. Active fire behavior with uphill runs, group torching and spotting. Area, road and trail closures in effect.

**208**, Willamette NF, USFS. Twenty miles southeast of Oakridge, OR. Timber. Minimal fire behavior with creeping and smoldering. Area and trail closures in effect.

**Cougar Creek**, Southeast Region, Washington DNR. CIMT (NW Team 13). Twenty-three miles southwest of Asotin, WA. Timber, grass and brush. Active fire behavior with uphill runs, flanking and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Homestead Complex (5 Fires)**, Umpqua NF, USFS. CIMT (GB Team 5). Thirty miles northeast of Glide, OR. Timber and brush. Moderate fire behavior with backing, flanking and isolated torching. Area, road and trail closures in effect.

**Red**, Deschutes NF, USFS. CIMT (EA Team 1). IMT is also managing the Wickiup fire. Eighteen miles west of Crescent, OR. Timber. Moderate fire behavior with smoldering, single tree torching and short-range spotting. Numerous structures threatened. Area, road and trail closures in effect.

**Wickiup**, Deschutes NF, USFS. Eight miles west of La Pine, OR. Timber. Moderate fire behavior with smoldering. Area, road and trail closures in effect.

**Lane 1**, East Lane Unit, ODF. CIMT (NC State Team 1). IMT is also managing the Adam Mountain fire. Mineral and Puddin fires. Fifteen miles southeast of Springfield, OR. Timber. Active fire behavior with uphill runs, flanking and backing. Structures threatened. Area and road closures in effect.

**Adam Mountain**, Umpqua NF, USFS. Includes the acreage from the previously reported Clark 900, Mineral and Puddin fires. Six miles southeast of Dorena, OR. Timber. Active fire behavior with uphill runs, flanking and backing. Structures, communication and energy infrastructure threatened. Area, road and trail closures in effect.

**Ore**, Willamette NF, USFS. CIMT (NW Team 10). Seven miles northeast of Blue River, OR. Timber. Active fire behavior with creeping, torching and group torching. Structures threatened. Area, road and trail closures in effect.

**Pyramid**, Willamette NF, USFS. CIMT (CA Team 5). Seventeen miles northeast of Cascadia, OR. Timber. Active fire behavior with backing, creeping and short-range spotting. Area, road and trail closures in effect.

**Big Horn**, Washington State Fire Marshall's Office. Seven miles southeast of Bickleton, WA. Grass and brush. Minimal fire behavior with creeping. Numerous structures threatened. Evacuations and area closures in effect.

**Grasshopper**, Vale District, BLM. Six miles northeast of Juntura, OR. Grass and brush. Moderate fire behavior. Structures and energy infrastructure threatened.

**Hole-In-The-Ground**, Vale District, BLM. Twenty-four miles west of Jordan Valley, OR. Brush and grass. Minimal fire behavior with smoldering.

**Winding Waters Complex**, Wallowa Unit, ODF. IMT 1 (ODF Team 2) mobilizing. Twenty-three miles east of Union, OR. Timber and brush. Active fire behavior with flanking, backing and short-range spotting. Area, road and trail closures in effect.

\* **Umtanum**, Spokane District, BLM. Eight miles south of Ellensburg, WA. Grass and brush. Minimal fire behavior with smoldering and creeping.

**Black Canyon**, Southeast Region, Washington DNR. Ten miles northwest of Naches, WA. Timber, brush and grass. Minimal fire behavior. Last report unless significant activity occurs.

**Cedar Creek**, Vale District, BLM. Twenty-three miles southwest of Juntura, OR. Brush and grass. Minimal fire behavior. Sage-grouse habitat threatened. Last report unless significant activity occurs.

**Deer Creek**, Vale District, BLM. Eighteen miles southwest of Adrian, OR. Brush and grass. Minimal fire behavior. Sage-grouse habitat threatened. Last report unless significant activity occurs.

**Camp Creek**, Prineville District, BLM. Ten miles southwest of Paulina, OR. Grass, timber and brush. No new information.

**Cliff Mountain**, Wallowa-Whitman NF, USFS. Twenty-five miles east of Joseph, OR. Brush and grass. No new information.

## **Predictive Services Discussion:**

Another cold front will shift into the Pacific Northwest today, bringing wetting rain to portions of western Washington, while a few thunderstorms may develop near and east of the Cascades in Oregon. Unfortunately, this system will enhance winds in much of the northern Intermountain West as compared to the weekend. Existing incidents in these areas will see a wind shift with the front, with gusts of 40-50 mph or higher likely in the Cascade gaps and Columbia River Gorge. Higher humidity will surge in just behind the front. Meanwhile, southeastern Oregon into Idaho, western Montana and portions of Wyoming will see dry, windy and warmer conditions. Gusts upwards of 35-55 mph can be expected through mountain gaps and in downslope areas, while minimum humidity values will range from 5-20%, lowest in southern Idaho. For the southern Great Basin into northern Arizona, West Slope and southern Sierra, single-digit relative humidity will be widespread again after poor morning recoveries, while breezy winds will continue to impact any ongoing or new incidents. Moderate- to locally high-risk significant fire potential is likely.

A few dry thunderstorms could occur in northern Wyoming and southern Montana, while scattered wet thunderstorms will pop up over far southern Colorado into parts of New Mexico and southeast Arizona. Triple-digit heat will become more widespread in the central and southern Plains, where breezy and dry conditions are expected. An increase in initial attack is possible in the parts of Oklahoma and northwestern Texas that have not observed rain in several weeks. Wet weather will extend from the Great Lakes into much of the Southeast, with locally heavy rain likely in New England, as well.
