**Hurricane Helene Support - NC**, National Forests in North Carolina, USFS. CIMT (SA Team 2). Primary mission is to coordinate emergency road clearing efforts and protect critical infrastructure on the Pisgah and Nantahala National Forests near Asheville, NC.

**Hurricane Helene Support – TN & VA**, National Forests in Tennessee and Virginia, USFS. CIMT (SA Team 3). Primary mission is to assess damage, coordinate emergency road clearing efforts and assist with critical infrastructure restoration on the Cherokee National Forest and the George Washington and Jefferson National Forest.

**Hurricane Milton Support - FL**, Florida Forest Service. CIMT (FL State Team 4). Primary mission is to stage resources to deploy after landfall and perform urban search and rescue as conditions permit in central Florida and along Florida's west coast.

**Yellow Lake**, Uinta-Wasatch-Cache NF, USFS. CIMT (CA Team 2). Ten miles southeast of Francis, UT. Timber, medium slash and grass. Extreme fire behavior with group torching, short crown runs and short-range

spotting. Several communities, numerous structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

**Pack Trail**, Bridger-Teton NF, USFS. CIMT (CA Team 10). Twenty-five miles southeast of Moran, WY. Timber, medium slash and brush. Moderate fire behavior with torching, wind driven runs and backing. Several communities and numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Red Rock**, Salmon-Challis NF, USFS. CIMT (SW Team 3). Fifteen miles west of Salmon, ID. Chaparral, hardwood litter and timber. Active fire behavior with uphill runs, wind driven runs and torching. Numerous structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

**Logan**, Payette NF, USFS. CIMT (GB Team 3). One mile west of Edwardsburg, ID. Timber, brush and closed timber litter. Active fire behavior with uphill runs, backing and group torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Castle Ridge**, Elko District, BLM. Three miles north of Midas. NV. Grass and brush. Moderate fire behavior with creeping, backing and smoldering. Structures and sage-grouse habitat threatened. Reduction in acreage due to more accurate mapping.

**Valley**, Southwest Supervisory Area Office, Idaho Department of Lands. One mile east of Boise, ID. Timber and grass. Moderate fire behavior with creeping, isolated torching and smoldering. Numerous residences threatened. Area and trail closures in effect.

**Goat**, Boise NF, USFS. CIMT (GB Team 6). IMT is also managing the Snag fire and the Middle Fork Complex. Eleven miles southeast of Cascade, ID. Timber, brush and grass. Moderate fire behavior with flanking, backing and single tree torching. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect.

**Snag**, Boise NF, USFS. Ten miles east of Cascade, ID. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Energy infrastructure threatened. Area, road and trail closures in effect.

**Middle Fork Complex (2 fires)**, Boise NF, USFS. Nine miles east of Garden Valley, ID. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Area, road and trail closures in effect.

**Rosie**, Southwest Supervisory Area Office, Idaho Department of Lands. Twenty-five miles southeast of Jordan Valley, OR. Medium slash and grass. Moderate fire behavior with flanking, backing and isolated torching. Structures and sage-grouse habitat threatened.

**Lava**, Boise NF, USFS. Twelve miles southwest of Cascade, ID. Timber and closed timber litter. Minimal fire behavior with creeping and smoldering. Numerous residences threatened. Area, road and trail closures in effect.

## **Predictive Services Discussion:**

Well above normal, record-setting temperatures will continue in the Southwest, but temperatures will be a few degrees cooler in the northern half of the West, with the modestly cooler temperatures continuing in California. Above normal temperatures will also continue in the Plains into the Appalachians. The airmass will remain quite dry for much of the Great Basin, central/southern Rockies, Southwest, and High Plains as minimum relative humidity falls to 5-20%, with minima of 12-30% for the Plains into Appalachians and Deep South. Higher relative humidity generally near or above 20% is expected in California, the Northwest, and northern Rockies. Breezy and dry southwesterly winds will spread across much of the Great Basin into Wyoming creating areas of elevated conditions. Breezy northwesterly winds will develop in North Dakota into western Minnesota, while locally breezy southerly winds develop on the central and southern Plains.

Much of the US will be dry today, with little to no precipitation forecast. However, heavy rain will fall across portions of central and northern as Hurricane Milton moves off the coast. Strong winds are also likely to continue through the day in Florida and portions of the Southeast abating overnight, with elevated fire weather conditions possible in Georgia due to the stronger winds and dry conditions on the northwest side of the storm.
