**Bachelor Complex**, Deschutes NF, USFS. CIMT (NW Team 3). IMT is also managing the Firestone and Flat Top fires. Twenty miles southwest of Bend, OR. Timber and closed timber litter. Moderate fire behavior with flanking, backing and creeping. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Firestone**, Deschutes NF, USFS. Twenty-one miles north of Fort Rock, OR. Grass, brush and timber. Moderate fire behavior with flanking, backing and creeping. Residences, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping. Precipitation occurred over the fire area yesterday.

**Flat Top**, Deschutes NF, USFS. Ten miles north of Fort Rock, OR. Grass, brush and timber. Moderate fire behavior with flanking, backing and creeping. Structures, sage-grouse habitat and energy infrastructure threatened. Precipitation occurred over the fire area yesterday.

**Rail Ridge**, Prineville, District, BLM. CIMT (CA Team 10). Fifty-one miles northwest of Burns, OR. Grass, brush and timber. Moderate fire behavior with backing, creeping and isolated torching. Numerous structures, communication infrastructure and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Fossil Complex (3 fires)**, Fossil Unit, ODF. IMT 1 (ODF Team 2). Two miles northwest of Spray, OR. Timber. Moderate fire behavior with backing, creeping and isolated torching. Structures and communication infrastructure threatened. Evacuations and road closures in effect. Precipitation occurred over the fire area yesterday.

**Devils Knob**, Umpqua NF, USFS. CIMT (NW Team 13). IMT is also managing the Milepost 98 fire. Five miles southeast of Tiller, OR. Timber. Minimal fire behavior with smoldering, creeping and backing. Structures threatened. Precipitation occurred over the fire area yesterday.

**Milepost 98**, South Unit, ODF. One mile north of Canyonville, OR. Light slash and timber. Minimal fire behavior with smoldering and creeping. Structures threatened. Precipitation occurred over the fire area yesterday.

**Willamette Complex (4 fires)**, Willamette NF, USFS. CIMT (CA Team 13) and CIMT (NW Team 2). IMTs are also managing the Ore fire. Eight miles southeast of Oakridge, OR. Timber, brush and grass. Minimal fire behavior with creeping, smoldering and single tree torching. Communication and transportation infrastructure threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Ore**, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Closed timber litter and timber. Moderate fire behavior with flanking and backing. Structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Wiley Flat**, Ochoco NF, USFS. CIMT (CA Team 1). Thirty-one miles southeast of Prineville, OR. Timber, brush and grass. Moderate fire behavior with flanking, backing and creeping. Structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Buck Creek**, Fremont-Winema NF, USFS. CIMT (NW Team 10). IMT is also managing Bowman Well fire. Thirty miles southwest of Silver Lake, OR. Timber and medium slash. Extreme fire behavior with running, torching and crowning. Precipitation occurred over the fire area yesterday.

**Bowman Well**, Lakeview District. BLM. Twenty miles northeast of Silver Lake, OR. Brush and grass. Moderate fire behavior with creeping and smoldering. Area closures in effect. Precipitation occurred over the fire area yesterday.

**Shoe Fly**, Prineville Unit, ODF. IMT 1 (ODF Team 1). Forty-five miles northeast of Prineville, OR. Brush, grass and timber. Minimal fire behavior with creeping, smoldering and backing. Road closures in effect. Precipitation occurred over the fire area yesterday.

**Homestead Complex (4 fires)**, Umpqua NF, USFS. CIMT (NW Team 8). CIMT (NW Team 7) mobilizing. IMT is also managing the Lane 1 fire. Thirty miles northeast of Glide, OR. Timber, closed timber litter and brush. Minimal fire behavior with smoldering, flanking and creeping. Structures and communication infrastructure threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Huckleberry Ridge**, Pacific Cascade Region, DNR. Twenty miles south of Pe Ell, WA. Heavy slash and timber. Minimal fire behavior with smoldering and backing. Area and road closures in effect.

## **Predictive Services Discussion:**

An upper-level low will continue moving through the northern Rockies today, with wetting precipitation continuing across northern Idaho and western/central Montana. Above 6,500 feet, several inches of snow are expected in east-central Idaho and west-central Montana. Behind the cold front from Wednesday conditions will be significantly moderated across much of the northern Intermountain West. Relative humidity minima will generally be 25 to 40%, with below normal temperatures expected. Winds will also be lighter from the west to northwest with peak gusts of 15 to 20 mph. However, from the central Rockies through the Four Corners and into southern California, warmer, drier conditions will persist. Southern California and Arizona will see the heat wave weakening, but highs will still be 95 to 105°F as relative humidity remains low at 5 to 20%. Ahead of the cold front, from the Four Corners into the central and northern Plains, strong south to southwest winds gusting 35-to 50 mph are expected along with low relative humidity and widespread elevated to critical conditions.

The remnants of Francine will continue to move inland up the Mississippi Valley, continuing to weaken as it moves north. Significant precipitation is expected, with widespread rain amounts of 2 to 4 inches. However, the Great Lakes will remain hot and dry as upper-level high pressure strengthens.
