**Wiley Flat**, Ochoco NF, USFS. CIMT (AK Team 3). IMT is also managing the Rail Ridge fire. Thirty-one miles southeast of Prineville, OR. Timber, brush and grass. Minimal fire behavior with smoldering. Structures threatened. Area, road and trail closures in effect.

**Rail Ridge**, Prineville, District, BLM. Fifty-one miles northwest of Burns, OR. Grass, brush and timber. Active fire behavior with flanking, isolated torching and spotting. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

**Willamette Complex (4 fires)**, Willamette NF, USFS. CIMT (EA Team 1). IMT is also managing the Red fire. Eight miles southeast of Oakridge, OR. Timber, brush and grass. No fire behavior received. Area, road and trail closures in effect.

**Red**, Deschutes NF, USFS. Transfer of command from CIMT (EA Team 1) back to the local unit will occur today. Eighteen miles west of Crescent, OR. Timber and closed timber litter. Minimal fire behavior with creeping, single tree torching and smoldering. Numerous structures threatened. Area, road and trail closures in effect.

**Homestead Complex (4 fires)**, Umpqua NF, USFS. CIMT (NW Team 12). IMT is also managing the Diamond Complex. Thirty miles northeast of Glide, OR. Timber, closed timber litter and brush. Minimal fire behavior with smoldering and creeping. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

**Diamond Complex (2 fires)**, Umpqua NF, USFS. Eighteen miles southwest of Chemult, OR. Timber. Minimal fire behavior with smoldering and creeping. Area, road and trail closures in effect.

**Goosmus**, Northeast Region, Washington DNR. Started on private land five miles north of Curlew, WA. Grass, timber and brush. Active fire behavior with isolated torching, flanking and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Bachelor Complex**, Deschutes NF, USFS. Twenty miles southwest of Bend, OR. Timber and closed timber litter. Moderate fire behavior with backing, creeping and smoldering. Area, road and trail closures in effect.

**Bottom Creek**, Coos Forest Protective Association, ODF. Twenty-one miles east of Coos Bay, OR. Heavy slash and timber. Moderate fire behavior with smoldering, backing and creeping. Road closures in effect.

**Buck Creek**, Fremont-Winema NF, USFS. Thirty miles southwest of Silver Lake, OR. Timber and medium slash. Moderate fire behavior with creeping and smoldering. Area and road closures in effect.

**Frog**, Sawtooth NF, USFS. Nineteen miles southeast of Stanley, ID. Grass, brush and timber litter. Minimal fire behavior with creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

**Red Rock**, Salmon-Challis NF, USFS. Fifteen miles west of Salmon, ID. Timber and light slash. Active fire behavior with backing, single tree torching and short-range spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

**Goat**, Boise NF, USFS. CIMT (GB Team 2). CIMT (GB Team 6) mobilizing. IMT is also managing the Snag fire and the Middle Fork Complex. Eleven miles southeast of Cascade, ID. Timber and brush. Moderate fire behavior with creeping, backing and flanking. Energy infrastructure threatened. Area, road and trail closures in effect.

**Snag**, Boise NF, USFS. Ten miles east of Cascade, ID. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Energy infrastructure threatened. Area, road and trail closures in effect.

**Middle Fork Complex (2 fires)**, Boise NF, USFS. Nine miles east of Garden Valley, ID. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Area, road and trail closures in effect.

**Pack Trail**, Bridger-Teton NF, USFS. Twenty-five miles southeast of Moran, WY. Timber. Active fire behavior with short crown runs, running, and short-range spotting. Structures threatened. Area and trail closures in effect. Last narrative report unless significant activity occurs.

## **Predictive Services Discussion:**

Critical conditions develop/expand across much of the Inland Northwest, portions of the northern Great Basin as well as parts of Montana, Wyoming and the northern Plains through the day as a fast-moving, strong and dry cold front sweeps eastward and emerges east of the Northern Rockies this evening. Of particular concern will be much of Wyoming, the Nebraska Panhandle and western Dakotas where fuels are driest. Strong/dry westerly winds gusting to 40 mph amid RH 12-20% expected early in the day for the Columbia Basin and Inland Northwest. Breezy/windy conditions and lowering RH expand eastward across portions of the northern Great Basin, Northern Rockies and northern Plains during the afternoon. Gusts to 50+ mph are likely along/east of the Divide in Montana and northern Wyoming. A few brief showers may cross the North Cascades, northern Idaho Panhandle, and northwest Montana. Lightning if any will be very isolated and confined to the north-central Washington/Canadian border region.

Strong high pressure aloft will bring dry and unseasonably warm/hot conditions to the Great Lakes, central/southern Plains, Colorado, and the Southwest. Weaker upper-level high pressure over California along with a weak closed low aloft that drifts inland will take the edge off the heat; however, gusty northerly winds to 30+ mph in wind prone areas of northern California will bring elevated conditions and moderate potential through tonight. In the east, weakening low pressure system over the central Appalachians with areas of mainly light to moderate rain slowly expanding into the Upper Ohio and Shenandoah Valleys, as well as the Mid-Atlantic. Scattered wetting rainfall anticipated for much of West Virginia and southeast Ohio. Elsewhere, scattered showers and thunderstorms will develop over Florida to the coastal areas of the Carolinas while a few showers and thunderstorms develop from the eastern Great Lakes to the Northeast.
