#### **Predictive Services Discussion:**

Isolated mixed wet/dry thunderstorms are possible across the inland Pacific Northwest at first, with storms remaining isolated but extending into northern California, the northern Great Basin, and Montana during the afternoon. Scattered mixed wet/dry thunderstorms are expected across the Rockies extending south to southeast Arizona.

Very dry conditions with minimum relative humidity of 4-15% and poor overnight recovery will continue across much of Utah, Nevada, Arizona, as well as inland California and southern Idaho. Elevated conditions will persist across southeast Nevada to southern/western Utah, northern Arizona, western Colorado, and southeast Wyoming with southwesterly winds of 15-25 mph and gusts of 25-35 mph.

Monsoon moisture lies over much of eastern and southern New Mexico, extending east of the Divide where isolated to scattered wet thunderstorms are forecast. Isolated dry thunderstorms will remain possible on the western fringe of the moisture from southeastern Arizona to the West Slope. Scattered showers and thunderstorms are expected across the Great Plains. Scattered showers and thunderstorms will continue across the south and east.
