**Monroe Canyon**, Fishlake NF, USFS. CIMT (GB Team 5). Three miles east of Monroe, UT. Brush, timber and heavy slash. Active fire behavior with wind-driven runs, flanking and torching. Several communities, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect. Sage-grouse habitat threatened.

- \* **Jakes**, Elko District, BLM. Two miles southwest of Midas, NV. Grass and brush. Active fire behavior with running, flanking and backing. Structures, communication infrastructure and sage-grouse habitat threatened.
- \* **MP 22**, Elko District, BLM. Six miles southwest of Midas, NV. Grass and brush. Active fire behavior with running, flanking and backing. Residences and sage-grouse habitat threatened.
- \* **Snowstorm**, Elko District, BLM. Eleven miles north of Midas, NV. Grass and brush. Extreme fire behavior with running, uphill runs and wind-driven runs. Sage-grouse habitat threatened.

\* **Victory**, Boise District, BLM. Fifteen miles southwest of Boise, ID. Grass and brush. Active fire behavior with running, flanking and backing. Structures and energy infrastructure threatened.

**Mill**, Idaho Falls District, BLM. Four miles south of Patterson, ID. Brush, grass and timber. Minimal fire behavior with creeping and smoldering.

#### **Predictive Services Discussion:**

Breezy west to southwesterly sustained winds of 15-20 mph with gusts 25-35 mph will develop across much of Nevada amid relative humidity of 5-14% creating widespread elevated to locally critical conditions. Very dry air will also spread across much of the Mojave Desert, Utah, and Arizona, as well as Colorado and New Mexico west of the Continental Divide as minimum humidity falls to 4-12% with very poor overnight recovery of 10-30%. Locally elevated conditions due to westerly winds are possible, as well. Scattered mainly wet thunderstorms will develop across central and northeast Oregon into central Idaho, with isolated mixed wet and dry thunderstorms to the south from northeast California into southeast Oregon, southwest Idaho, and far northern Nevada.

With the very dry air across the monsoon will take a break, with scattered showers and thunderstorms farther east across much of the Plains. Scattered showers and thunderstorms will develop along the Gulf Coast into much of the Southeast, but much of the Northeast will remain dry with locally low relative humidity of 25-35%. Warm and dry weather will continue across Interior Alaska, while the strong trade winds in Hawai'i will ease slightly but locally critical conditions are possible as minimum humidity falls to 35-45%.
