Monroe Canyon, Fishlake NF, USFS. CIMT (GB Team 5). Three miles east of Monroe, UT. Brush, timber and heavy slash. Active fire behavior with wind-driven runs, flanking and torching. Several communities, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect. Sage-grouse habitat threatened.

Jakes, Elko District, BLM. Two miles southwest of Midas, NV. Grass and brush. Extreme fire behavior with running, uphill runs and wind-driven runs. Community of Midas, communication infrastructure and sage-grouse habitat threatened.

Snowstorm, Elko District, BLM. Eleven miles north of Midas, NV. Grass and brush. Extreme fire behavior with running, wind-driven runs and uphill runs. Residences and sage-grouse habitat threatened.

MP 22, Elko District, BLM. Six miles southwest of Midas, NV. Grass and brush. Moderate fire behavior with backing, flanking and creeping. Residences and sage-grouse habitat threatened.

Adobe Mountain, Elko District, BLM. Thirty-eight miles north of Elko, NV. Extreme fire behavior with running, flanking and wind-driven runs. Structures and sage-grouse habitat threatened. Reduction in acreage due to more accurate mapping.

Deer Creek, Southeast Area, Utah DOF. One mile north of Old La Sal, UT. Chaparral, timber and brush. Minimal fire behavior with smoldering, creeping and isolated torching. Area, road and trail closures in effect.

Mill, Idaho Falls District, BLM. Four miles south of Patterson, ID. Brush, grass and timber. Minimal fire behavior with creeping and smoldering.

Pole, West Desert District, BLM. Thirty miles west of Yost, UT. Brush and slash. Minimal fire behavior. Last report unless significant activity occurs.

Dragon Bravo, Grand Canyon NP, NPS. CIMT (SW Team 2). Two miles west of North Rim, AZ. Brush, closed timber litter and timber. Active fire behavior with short crown runs, flanking and long-range spotting. Numerous structures, communication and energy infrastructure threatened. Area, road and trail closures in effect.

Middle Mesa, Carson NF, USFS. Twenty-two miles west of Dulce, NM. Timber, brush and medium slash. Active fire behavior with wind-driven runs, group torching and flanking. Structures and energy infrastructure threatened.

Predictive Services Discussion:

Hot, dry, and breezy southwesterlies develop across inland California east of the Sierra and extend across the Great Basin to the West Slope, including areas of northern Arizona, northeast New Mexico, southern Idaho, and southwest Wyoming. Southwest winds of 15-25 mph with gusts 25-40 mph, minimum relative humidity of 3-15%, and poor overnight recovery, and elevated fire weather conditions are expected across the much of those parts, with critical conditions across Utah, northwest Colorado, and southeast Wyoming. Extreme heat continues to build over parts of the southwest.

Isolated mixed wet/dry, thunderstorms are possible across parts of northeast California and the inland Pacific Northwest, across to western Wyoming and Montana, and possibly across northern Nevada and Utah. Note that any storms that develop over northern Utah, northern Nevada, or southern Idaho would be mostly dry and coincident with elevated fire weather conditions.

Monsoon moisture lies mostly east of The Divide, where isolated to scattered wet thunderstorms are forecast. Isolated dry thunderstorms will remain possible on the western fringe of the moisture, including western parts of New Mexico, Colorado, and Wyoming. Scattered showers and thunderstorms are expected across the Great Plains. Scattered showers and thunderstorms will continue across the south and southeast.

Warm and dry weather will continue across Interior Alaska, while the strong trade winds in Hawai'i will ease slightly but locally critical conditions are possible as minimum humidity falls to 35-45%.
