### **Predictive Services Discussion:**

A cold front in the West will push into the central Great Basin and central Rockies, with strong, dry west to southwest winds creating critical conditions ahead of the front from southeast Nevada and northern Arizona into much of Utah and the central Rockies. Low relative humidity of 3-15% and poor overnight recovery will persist across the southern Intermountain West, as well. As the front moves through northern Utah, southwest Wyoming, and northwest Colorado in the late afternoon and evening, a wind shift to the north is expected. Isolated dry thunderstorms will develop from the Mogollon Rim to southwest Colorado and northern New Mexico. Isolated mixed wet/dry thunderstorms will develop across southeast Arizona into southwest New Mexico.

Above normal temperatures and very dry conditions will persist in southern California and begin to spread northward into northern California. In the northern half of the West, below normal temperatures with moderate relative humidity. Hot, dry, and breezy conditions are expected to increase across North Texas and central and western Oklahoma. Scattered showers and thunderstorms are expected in the Midwest and much of Florida, with more isolated thunderstorms into the Southeast. Dry conditions will persist in the Northeast overall in the Northeast, but isolated thunderstorms are possible in northern New England. Cooler conditions are expected across most of Alaska today, with showers for the western half of the state.
