#### **Predictive Services Discussion:**

Showers are expected in the Northwest west of the Cascades, with isolated to scattered showers and thunderstorms developing from northern California into northeast Oregon and west-central Idaho. Wetting rain is most likely west of the Cascades, with more localized wetting rain east of the Cascades into central and northern Idaho. Farther south and east, breezy southwesterly winds will continue across the central and Great Basin into southwest Montana amid relative humidity of 10-20%. The strongest winds gusting to 40 mph are likely along the Sierra Front creating elevated to critical conditions, with more localized elevated conditions from eastern Nevada to southwest Montana. Isolated to scattered mixed wet and dry thunderstorms will also develop across east-central/southeast Idaho into southwest Montana and western Wyoming. Monsoon moisture will begin to wane across Arizona into Utah and the West Slope where isolated to scattered mainly wet thunderstorms are expected. Moisture will remain deep in New Mexico where scattered showers and thunderstorms are likely, while cooler onshore flow will persist in central and southern California.

Elsewhere, breezy and dry southerly winds will persist on the southern Plains amid above normal temperatures and relative humidity as low as 15%. Scattered showers and thunderstorms are expected across the northern Plains and Midwest along a cold front, with more isolated thunderstorms from the Lower Mississippi Valley to the Southeast. Dry conditions will persist in the Northeast.
