**Red Canyon**, Wind River/Bighorn Basin District, BLM. CIMT (RM Team 2). Eleven miles east of Thermopolis, WY. Grass and brush. Extreme fire behavior with wind-driven runs, uphill runs and short-range spotting. Numerous structures threatened. Evacuations, area and road closures in effect.

**Crosho**, Medicine Bow-Routt NF, USFS. Eight miles northwest of Yampa, CO. Timber and brush. Moderate fire behavior with isolated torching, backing and short-range spotting. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

**Lee**, White River Field Office, BLM. Transfer of command from CIMT (RM Team 3) to CIMT (NR Team 1) will occur tomorrow. Eleven miles southwest of Meeker, CO. Grass and brush. Extreme fire behavior with crowning, wind-driven runs and short-range spotting. Community of Meeker and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

#### **Predictive Services Discussion:**

Locally breezy south to southwest winds 12-20 mph with gusts to 30 mph will persist across central/eastern Nevada into the Snake River Plain amid relative of 7-20%, lowest in Nevada. Cooler temperatures and higher RH above 25% is expected farther north and west across northern California into the Northwest and northern Rockies with isolated to scattered showers and thunderstorms. Monsoon moisture is expected to shift farther east into New Mexico and east of the Divide in Colorado as minimum RH falls to 7-15% in Arizona and Utah with poor overnight recovery expected. Isolated to scattered showers and thunderstorms will persist in New Mexico and east of the Divide in Colorado, but isolated mixed wet and dry thunderstorms are possible in eastern Arizona and the West Slope.

For the southern Plains, southerly winds weaken with higher relative humidity and isolated thunderstorms expected over the High Plains. A cold front will push from the Midwest into the Northeast with scattered showers and thunderstorms bringing some relief to New England, but not all areas will receive rain. Isolated showers and thunderstorms are also expected along the Gulf Coast.
