Crosho, Medicine Bow-Routt NF, USFS. Eight miles northwest of Yampa, CO. Timber and brush. Moderate fire behavior with isolated torching, backing and creeping. Residences threatened. Evacuations, area, road and trail closures in effect.

Rock, Boise NF, USFS. CIMT (GB Team 6). Five miles southwest of Donnelly, ID. Timber and brush. Active fire behavior with group torching, short-range spotting and short crown runs. Numerous structures and communication infrastructure threatened. Area, road and trail closures in effect.

Cottonwood Peak, Elko District, BLM. CIMT (EA Team 1). Three miles north of Tuscarora, NV. Brush and grass. Extreme fire behavior with wind-driven runs, running and spotting. Community of Tuscarora, structures, energy infrastructure and sage-grouse habitat threatened. Road closures in effect.

* **Buckley Draw**, Uinta-Wasatch-Cache NF, USFS. Three miles southeast of Provo, UT. Grass, chaparral and timber. Active fire behavior with uphill runs, single tree torching and backing. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect.

Monroe Canyon, Fishlake NF, USFS. CIMT (GB Team 2). Three miles east of Monroe City, UT. Brush, timber and heavy slash. Minimal fire behavior with backing, creeping and smoldering. Several communities and structures threatened. Evacuations, area, road and trail closures in effect.

Beulah, Uinta-Wasatch-Cache NF, USFS. CIMT (GB Team 4). Thirty-two miles northeast of Kamas, UT. Timber and brush. Active fire behavior with group torching, backing and uphill runs. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Box, Boise District, BLM. Fifty-six miles southwest of Grandview, ID. Timber and grass. Moderate fire behavior with creeping, isolated torching and smoldering. Residences threatened.

Chin Creek, Ely District, BLM. Fifty miles northeast of Ely, NV. Timber. Minimal fire behavior with smoldering. Sage-grouse habitat threatened.

Rancho, Truckee Meadows Fire Protection District. Ten miles north of Reno, NV. Grass and brush. Minimal fire behavior with smoldering.

Willard Peak, Bear River Area, Utah DOF. One mile northeast of North Ogden, UT. Chaparral and grass. Minimal fire behavior. Trail closures in effect.

Predictive Services Discussion:

Locally breezy south to southwest winds 10-20 mph with gusts of 30 mph continue across the northern Great Basin, with a slight increase in winds across Nevada and into southern Idaho, bringing gusts of 40 mph and elevated conditions to those parts. Low RH of 7 to 20% and poor overnight recovery is expected across the Great Basin and parts of inland California, with higher RH above 25% farther north and northwest across the Pacific Northwest and northern Rockies. Cooler than normal temperatures are expected across northern California and the Pacific Northwest. Temperatures across the eastern Great Basin and throughout the Rockies continue to rise to 5 to 10 degrees above average, however average to below average temperatures maintain across much of the West Coast and western Basin. Isolated mixed wet/dry thunderstorms are possible from northeast Oregon, across central/northern Idaho and into western Montana.

Monsoonal moisture builds over southern Arizona and across New Mexico to east of the Divide, as minimum RH falls to 7 to 15% in northern Arizona. Isolated to scattered showers and thunderstorms will persist in New Mexico and east of the Divide in Colorado, but isolated mixed/wet dry thunderstorms will remain possible from southern/eastern Arizona to the West Slope.

For the Southern Plains, RH lowers to 20 to 30%. Isolated showers and thunderstorms are expected across much of the remaining parts of the US, however dry conditions continue across the Northeast with RH lowering to 25 to 35%.
