Two MAFFS C-130 airtankers and support personnel have been deployed to Colorado Springs, CO and two MAFFS C-130 airtankers and support personnel have been deployed to Mesa, AZ to support wildland fire operations nationally. Their respective units are as follows: 302nd (Peterson SFB, CO) and 152nd AW (Reno, NV) to Colorado Springs, CO and 146th AW (Channel Islands, CA) and 153rd AW (Cheyenne, WY) to Mesa, AZ.

Six US Army HH-60 MEDEVAC Helicopters from the1st Air Cavalry Brigade (Fort Hood, TX) have been deployed to California to support wildland fire operations nationally.

**Windy Rock**, Southwestern Land Office, Montana DNR. Fifteen miles northeast of Drummond, MT. Timber. Extreme fire behavior with crowning, wind-driven runs and long-range spotting. Structures threatened. Area and road closures in effect.

\* **Corral Creek**, Lolo NF, USFS. Eighteen miles northwest of Missoula, MT. Timber. Active fire behavior with uphill runs, flanking and backing. Energy infrastructure threatened. Area, road and trail closures in effect.

#### **Predictive Services Discussion:**

Hot, dry, and unstable conditions are likely along much of the West Coast near and west of the Cascades and Sierra as near record-setting temperatures 10-25°F above normal are expected. Very low RH of 5-15% is expected in much of California, the Inland Northwest, and central/western Great Basin with poor overnight recovery. Minimum RH of 15-25% is expected in the Willamette Valley, as well, and isolated mixed wet/dry thunderstorms are likely in the Transverse/Peninsular Ranges of California and the southern Sierra providing a potential ignition source.

Monsoon moisture deepens over the Southwest with scattered showers and thunderstorms. Farther north, moisture will continue to move in for the central/southern Great Basin and West Slope. Isolated to scattered mixed wet/dry thunderstorms and potential new ignitions are expected, focused from central Nevada to the West Slope and Wyoming, with the wettest storms likely across far southern Nevada and Utah. Strong outflow winds near or exceeding 50 mph are possible with any thunderstorms. Across Montana, temperatures will be closer to normal with moderate RH near or above 20% and light northeast winds are likely.

Elsewhere, isolated showers and thunderstorms will develop along the Gulf Coast into Georgia and South Carolina, but storms will be more isolated in South Florida. Dry and breezy north to northeasterly winds of 10-20 mph amid RH of 20-35% are expected in eastern New England in the wake of Hurricane Erin. Scattered showers and thunderstorms will develop across the central Plains into the Upper Great Lakes.
