Their respective units are as follows: 302nd (Peterson SFB, CO) and 152nd AW (Reno, NV) to Colorado Springs, CO and 146th AW (Channel Islands, CA) and 153rd AW (Cheyenne, WY) to Mesa, AZ.

Six US Army HH-60 MEDEVAC Helicopters from the 1st Air Cavalry Brigade (Fort Hood, TX) have been deployed to California to support wildland fire operations nationally.

**Sunset**, Pend Oreille Area Office, Idaho Department of Lands. CIMT (NR Team 5). Twenty-six miles north of Coeur d'Alene, ID. Brush and timber. Moderate fire behavior with flanking, single tree torching and short-range spotting. Numerous structures and infrastructures threatened. Evacuations, area, road and trail closures in effect.

**Bivens Creek**, Beaverhead-Deerlodge NF, USFS. CIMT (NR Team 6). CIMT is also managing the Cloudrest incident. Fifteen miles north of Virginia City, MT. Timber. Active fire behavior with group torching, short-range spotting and flanking. Numerous structures threatened. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Cloudrest**, Beaverhead-Deerlodge NF, USFS. Fifteen miles northwest of Virginia City, MT. Timber. Active fire behavior with group torching, short-range spotting and flanking. Structures threatened. Area, road and trail closures in effect.

**Windy Rock**, Southwestern Land Office, Montana DNR. CIMT (NW Team 2) mobilizing. Fifteen miles northeast of Drummond, MT. Timber. Active fire behavior with short crown runs, group torching and long-range spotting. Structures threatened. Area and road closures in effect.

**Corral Creek**, Lolo NF, USFS. Eighteen miles northwest of Missoula, MT. Timber. Active fire behavior with uphill runs, flanking and backing. Energy infrastructure threatened. Area, road and trail closures in effect.

**Knowles**, Northwestern Land Office, Montana DNR. Started on private land 11 miles southeast of Plains, MT. Timber and grass. Active fire behavior with short crown runs, short-range spotting and flanking. Numerous structures threatened. Evacuations and area closures in effect.

**Sandbar 2**, Helena-Lewis and Clark NF, USFS. CIMT (NW Team 8). Thirteen miles northeast of Lincoln, MT. Closed timber litter and medium slash. Minimal fire behavior. Numerous residences threatened. Area, road and trail closures in effect.

**West Fork**, Custer Gallatin NF, USFS. Twenty-three miles northwest of West Yellowstone, MT. Timber and brush. Active fire behavior with wind-driven runs, short-range spotting and flanking. Residences threatened. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Lightning Creek**, Idaho Panhandle NF, USFS. Nine miles north of Clark Fork, ID. Heavy slash and timber. Minimal fire behavior with creeping and smoldering. Road and trail closures in effect.

**Mile Marker 91**, Flathead Agency, BIA. Sixteen miles south of Hot Springs, MT. Grass, brush and timber. Minimal fire behavior with creeping, backing and smoldering.

**Cottonwood Peak**, Elko District, BLM. CIMT (EA Team 1). Three miles north of Tuscarora, NV. Brush, grass and timber. Active fire behavior with wind-driven runs, running and flanking. Community of Tuscarora and energy infrastructure threatened. Area, road and trail closures in effect. Sage-grouse habitat threatened.

**Rock**, Boise NF, USFS. CIMT (GB Team 6). Five miles southwest of Donnelly, ID. Timber, closed timber litter and brush. Active fire behavior with group torching, isolated torching and short-range spotting. Numerous structures and infrastructures threatened. Area, road and trail closures in effect.

**Buckley Draw**, Uinta-Wasatch-Cache NF, USFS. Three miles southeast of Provo, UT. Grass, chaparral and timber. Active fire behavior with single tree torching, flanking and backing. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect.

\* **Dollar Lake**, Bridger-Teton NF, USFS. Thirty-two miles north of Pinedale, WY. Timber, brush and closed timber litter. Extreme fire behavior with crowning, running and spotting. Evacuations and road closures in effect.

**Beulah**, Uinta-Wasatch-Cache NF, USFS. Transfer of command from CIMT (GB Team 4) back to the local unit will occur tomorrow. Thirty-two miles northeast of Kamas, UT. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Monroe Canyon**, Fishlake NF, USFS. Transfer of command from CIMT (GB Team 2) to CIMT (GB Team 3) will occur tomorrow. Three miles east of Monroe City, UT. Brush, timber and heavy slash. Minimal fire behavior with backing, creeping and smoldering. Several communities threatened. Evacuations, area, road and trail closures in effect.

**Box**, Boise District, BLM. Fifty-six miles southwest of Grandview, ID. Timber and grass. Active fire behavior with flanking, uphill runs and single tree torching. Residences threatened.

**Willard Peak**, Bear River Area, Utah DOF. One mile northeast of North Ogden, UT. Chaparral and grass. Minimal fire behavior. Trail closures in effect.

## **Predictive Services Discussion:**

Hot, dry, and unstable conditions continue along much of the West Coast near and west of the Cascades and Sierra as near record-setting temperatures 10-25°F above normal remain likely. Very low RH of 8-15% is expected in much of California, the Inland Northwest, and central/western Great Basin with poor overnight recovery. The thunderstorm risk increases and monsoonal moisture moves in from the south, with isolated mixed wet/dry thunderstorms likely around and near the Sierra as well as the Cascade ranges in Oregon, providing a potential ignition source – gusty thunderstorm outflows are possible.

Monsoon moisture continues to deepen over the Southwest with scattered showers and thunderstorms. Monsoonal moisture begins to push into the northern Great Basin and parts of the Pacific Northwest. Isolated to scattered mixed wet/dry thunderstorms expected across much of the central/southern Great Basin into the West Slope and Wyoming, with the wettest storms likely across southern Nevada and Utah. However, dry and gusty thunderstorms remain a risk across the western and northern fringes of the moisture plume from northwest Nevada into northeast California and possibly southern parts of Oregon and Idaho. Across central and eastern Montana, temperatures will be closer to normal with moderate RH near or above 20%.

Elsewhere, isolated showers and thunderstorms will develop along the Gulf Coast and southeast, extending to the Great Lakes area and into the central Great Plains. Across New England, RH of 25-35% is expected amid southwest winds near 10-15 mph.
