Their respective units are as follows: 302nd (Peterson SFB, CO) and 152nd AW (Reno, NV) to Colorado Springs, CO and 146th AW (Channel Islands, CA) and 153rd AW (Cheyenne, WY) to Mesa, AZ.

Six US Army HH-60 MEDEVAC Helicopters from the 1st Air Cavalry Brigade (Fort Hood, TX) have been deployed to California to support wildland fire operations nationally.

#### **Predictive Services Discussion:**

Hot, dry, and unstable conditions continue along much of the West Coast near and west of the Cascades and Sierra as near record-setting temperatures 10-25°F above normal remain likely. Low RH of 10-20% is expected in much of California, the Inland Northwest. Scattered mixed wet/dry thunderstorms are expected across the Sierra and Cascades, extending to the northern part of the monsoonal moisture across parts of inland Oregon, southern Idaho, and western Wyoming.

Monsoon moisture continues to deepen over the Southwest with scattered showers and thunderstorms. Monsoonal moisture begins to push into the northern Great Basin, bringing higher RH, cooler conditions, and cloud cover. Isolated to scattered mixed wet/dry thunderstorms expected across much of the Great Basin into the West Slope

Elsewhere, isolated showers and thunderstorms are possible across the southeast and the central Great Plains, as well as parts of New England.
