Their respective units are as follows: 302nd (Peterson SFB, CO) and 152nd AW (Reno, NV) to Klamath Falls, OR and 146th AW (Channel Islands, CA) and 153rd AW (Cheyenne, WY) to Channel Islands, CA.

Six US Army HH-60 MEDEVAC Helicopters from the 1st Air Cavalry Brigade (Fort Hood, TX) have been deployed to California to support wildland fire operations nationally.

## **Predictive Services Discussion:**

Friday is a transition day as the ridge begins to build into the Intermountain West and Monsoon moisture diminishes quite a bit with only residual storms developing along a band from northwest Montana down to southeast Wyoming. Isolated storms are also possible over eastern Utah and along the west slope in Colorado. Sunny skies and dry air will continue to spread throughout much of the western U.S. with gradually warming temperatures and RHs dropping into the teens over northern California and east of the Cascades in Oregon.

In the eastern US, a cold front will move through New England with scattered showers and thunderstorms with areas of wetting rain. However, not all areas will receive rainfall, and the Mid-Atlantic will remain dry with RH as low as 30% that will extend south and west into the Tennessee Valley and southern Appalachians. Widespread wet thunderstorms will bring heavy rain to the Lower Mississippi Valley, providing relief from the recent dry conditions. However, thunderstorms in Texas will be more isolated outside the panhandle, with South Texas continuing to remain dry.
