Predictive Services Discussion:

Widespread critical conditions are expected across much of the Great Basin, central Rockies, and Four Corners due to hot and dry west to southwest winds 15-30 mph gusting to 30-50 mph, minimum relative humidity of 3-12%, and poor overnight recovery. Breezy and cooler but still dry westerly winds are expected across eastern Oregon into southern Idaho. Extreme heat will persist over the Southwest with temperatures near or exceeding 115°F in the Sonoran Desert, with above normal temperatures extending into southern California. Isolated dry thunderstorms with strong, gusty, erratic winds will be focused from the Mogollon Rim into northwest New Mexico and southwest Colorado, with wetter thunderstorms likely in southeast Arizona to southwest New Mexico.

Showers and wet thunderstorms are expected in the northern Rockies, with snow in the highest elevations above 8,000 feet. Scattered thunderstorms will develop in the northern Plains to Great Lakes, while isolated showers and thunderstorms continue along the Gulf Coast and into the Southeast. Hot, dry, and breezy conditions are expected on the southern Plains continuing the drying trend, while drier conditions return to the Northeast.
