Predictive Services Discussion:

The heat dome over the northern Rockies will move eastward into the northern Plains on Thursday. Meanwhile, the western US will remain in a pattern of 20-25 mph afternoon wind gusts with additional chances for isolated showers and thunderstorms which could produce outflow winds up to 50 mph. Slightly stronger winds and low RH will lead to elevated fire weather conditions along the Sierra Front as a cold front approaches the area. Monsoonal moisture will bring scattered wet thunderstorms to southern Arizona and New Mexico once again. Isolated dry storms will be possible over the eastern Great Basin, western Rocky Mountain regions, and portions of northern California once again. Otherwise, expect continued low to moderate significant fire potential in portions of the western US where fuels are available.
