Minimal fire behavior with backing, torching and smoldering. Structures threatened. Area and trail closures in effect.

Saint George Creek, Fairbanks Area, Alaska, DOF. Started on Alaska DNR land 30 miles southwest of Salcha, AK. Timber. Moderate fire behavior with flanking, creeping and isolated torching. Residences threatened. Evacuations in effect.

Himalaya Road, Fairbanks Area, Alaska DOF. CIMT (SW Team 3). CIMT is also managing the Aggie Creek incident. Started on Alaska DNR land 12 miles northwest of Fox, AK. Chaparral and timber. Active fire behavior with short crown runs, backing and spotting. Numerous residences and energy infrastructure threatened. Road closures in effect.

Aggie Creek, Fairbanks Area, Alaska DOF. Started on Alaska DNR land 23 miles northwest of Fairbanks, AK. Chaparral and timber. Active fire behavior with short crown runs, backing and spotting. Residences and energy infrastructure threatened. Road closures in effect.

Nenana Ridge Complex (2 fires), Fairbanks Area, Alaska DOF. CIMT (AK Team 2) mobilizing. Started on Alaska DNR land 20 miles southwest of Fairbanks, AK. Timber, hardwood litter and brush. Active fire behavior with flanking, group torching and spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

Predictive Services Discussion:

Scattered mixed wet and dry thunderstorms will be ongoing this morning across eastern Oregon and the northern Great Basin and become wetter as they move into central and western Montana this afternoon. Isolated mixed wet and dry thunderstorms will redevelop this afternoon in southeast Oregon and southwest Idaho. Breezy and dry southwest sustained winds 15-25 mph with gusts to 40 mph amid minimum relative humidity of 5-15% will develop across much of Nevada into western Utah and northwest Arizona creating widespread elevated to critical conditions. and portions of northern California once again. A more stable airmass will move into the Southwest, eastern Utah, and Colorado curtailing thunderstorm development, but relative humidity will remain elevated. Widespread showers and thunderstorms are expected across the Upper Mississippi Valley today, with scattered thunderstorms into the central Plains. In Alaska, another day of hot, dry, and breezy conditions are expected across the Interior with maximum temperatures of 80-95°F, minimum relative humidity as low as 15%, and east winds of 10-18 mph.
