#### **Predictive Services Discussion:**

A warming trend is expected to begin across the West today, with temperatures rising to a few degrees above normal. The dry conditions will continue, with minimum relative humidity falling to 5-10% across much of the Intermountain West and California, although the Northern Rockies will likely remain near or above 20% for one more day. Winds will continue to be generally light, with most consistent westerly winds of 10-15 mph in the southern Great Basin, Arizona, West Slope, and southwest Wyoming. Isolated mixed wet and dry thunderstorms will develop in far southeast Arizona and near the Continental Divide in New Mexico, with wetter storms farther north and east on the central and southern High Plains. Scattered showers and thunderstorms will also develop from central Texas north and east into the Great Lakes. Tropical Storm Chantal will continue to move inland across the Carolinas, with gusty winds and widespread rain. The pattern will begin to change in Alaska, with cooler conditions for the North Slope and south-central Alaska to the southern Interior, but the northern Interior will have one more day of hot temperatures and low relative humidity.
