**Nenana Ridge Complex** (2 fires), Fairbanks Area, Alaska DOF. CIMT (AK Team 2). Started on Alaska DNR land 20 miles southwest of Fairbanks, AK. Timber, hardwood litter and brush. Active fire behavior with flanking and creeping. Structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Himalaya Road**, Fairbanks Area, Alaska DOF. CIMT (SW Team 3). CIMT is also managing the Aggie Creek incident. Started on Alaska DNR land 12 miles northwest of Fox, AK. Chaparral and timber. Minimal fire behavior with smoldering. Numerous residences and energy infrastructure threatened. Road closures in effect.

**Aggie Creek**, Fairbanks Area, Alaska DOF. Started on Alaska DNR land 23 miles northwest of Fairbanks, AK. Chaparral and timber. Minimal fire behavior with smoldering. Residences and energy infrastructure threatened. Road closures in effect.

**Bear Creek**, Fairbanks Area, Alaska DOF. Started on Alaska Native Corporation land 14 miles northwest of Healy, AK. Timber. Minimal fire behavior with creeping and smoldering. Area and trail closures in effect.

**Seven Mile Lookout**, Tok Area, Alaska DOF. Started on Alaska DNR land seven miles southwest of Tok, AK. Timber. Minimal fire behavior with smoldering. Residences threatened.

**Runt**, Upper Yukon Zone, BLM. Eighty-seven miles southwest of Circle, AK. Brush and timber. Minimal fire behavior with smoldering. Structures threatened. Precipitation occurred over the fire area yesterday.

**Tok River**, Tok Area, Alaska DOF. Started on Alaska DNR land 10 miles southwest of Tok, AK. Timber. Minimal fire behavior with smoldering.

\* **Tsukon**, Upper Yukon Zone, BLM. Started on Alaska Native Corporation land 17 miles northwest of Venetie, AK. Closed timber litter and brush. Minimal fire behavior with smoldering and creeping.

\* **Sikik**, Galena Zone, BLM. Started on NPS land 60 miles north of Ambler, AK. Brush. Active fire behavior with running and group torching. Last narrative report unless significant activity occurs.

\* **Doc**, Upper Yukon Zone, BLM. Started on FWS land 13 miles southwest of Birch Creek, AK. Timber and brush. Minimal fire behavior. Precipitation occurred over the fire area yesterday. Last narrative report unless significant activity occurs.

\* **Helmet**, Upper Yukon Zone, BLM. Started on FWS land 50 miles southeast of Arctic Village, AK. Timber and hardwood litter. Minimal fire behavior. Precipitation occurred over the fire area yesterday. Last narrative report unless significant activity occurs.

**Ptarmigan Complex** (5 fires), Upper Yukon Zone, BLM. Two miles south of Central, AK. Brush, timber and hardwood litter. Moderate fire behavior with isolated torching, flanking and creeping. Numerous residences threatened. Area closures in effect. Precipitation occurred over the fire area yesterday. Last narrative report unless significant activity occurs.

**Lush**, Tanana Zone, BLM. Previously reported incident. Started on Alaska Native Corporation land one mile northwest of Rampart, AK. Timber and brush. Moderate fire behavior with creeping, smoldering and backing. Structures threatened. Precipitation occurred over the fire area yesterday. Last narrative report unless significant activity occurs.

**Roundabout Complex** (3 fires), Galena Zone, BLM. Started on FWS land eight miles southwest of Huslia, AK. Timber and brush. Active fire behavior with running, torching and short-range spotting. Residences threatened. Last narrative report unless significant activity occurs.

## **Predictive Services Discussion:**

A weak upper low in conjunction with a stronger upper low in western Canada will break down the ridge over the West. Isolated to scattered mixed wet and dry thunderstorms are likely from south-central Oregon into portions of the northern Rockies and northern Great Basin, with some of these storms capable of severe wind gusts. Thunderstorms may continue overnight in portions of northern Utah, eastern Idaho, and western Wyoming. Elevated to locally critical fire weather conditions are expected across much of the Great Basin, with sustained southwest winds of 12-20 mph gusting 25-40 mph amid minimum relative humidity of 5-15%. Dry and breezy conditions may extend from eastern Idaho into north-central Montana and southwest Wyoming as well. Elevated fire weather conditions are likely again from the Cascade gaps through portions of eastern Washington, northern Oregon, and into north Idaho due to gusty westerly winds of 20-35 mph and minimum relative humidity of 15-30%.

Isolated thunderstorms are forecast over the higher terrain in the greater Four Corners region, with the best chances and coverage likely over eastern Arizona and southwest New Mexico. Isolated to scattered thunderstorms are likely on the northern Plains, and scattered to widespread thunderstorms are expected again across much of the eastern US and Gulf Coast into the Ozarks and Lower/Mid Mississippi Valley, and central and east Texas. In Alaska, scattered to widespread showers and thunderstorms are likely from portions of southwest Alaska through the central and eastern Interior into the northeast portions of the Brooks Range and south-central Alaska. Northwest portions of the Interior are likely to remain dry but with cooler temperatures.
